

ORDINANCE NO 127

AN ORDINANCE AMENDING SECTION TWO OF ORDINANCE NO 28 1/2 OF THE CITY OF POLSON, ESTABLISHING A SYSTEM OF STREET GRADES, TO INCLUDE THE ESTABLISHMENT OF CERTAIN GRADES WITHIN THE CITY OF POLSON, MONTANA.

WHEREAS, The City of Polson, by its City Commissioners, has caused levels to be taken and elevations determined, and a system of grades established upon the streets and avenues within said city and in order to clearly define and perpetuate the grades so established by this ordinance;

Be it ordained by the City Commissioners of the City of Polson, Montana: -

That Section Two of Ordinance No 28 1/2 be amended, and it is hereby amended, to include the grades of the streets and avenues at the points designated and they are hereby established as the official grades of said streets and avenues. Said points being the corners respectively at streets and avenues herein named.

All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

This ordinance shall take effect and be in force from and after its passage and approval.
