

ORDINANCE No. 28.

An ordinance to amend Ordinance No.14. Being an ordinance entitled " An ordinance to provide for the licensing of certain persons, trades, business, and occupation, vocation and professions and to provide rules, regulations and a penalty for the violation of the same, also to amend Ordinance No.21 being an amendment to Ordinance No.14 of the City of Polson, Montana.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF POLSON, MONTANA.

Section I- That section 23 of ordinance 14 be amended to read as follows; Every keeper of a livery or feed stable, or garage, shall pay a license of \$2.50 per quarter.

Section 2: That section 3 of ordinance 21 be amended to read as follows: That a Contractor be considered one who advertises, solicits, or puts up a sign board for contracts, or any one who figures or estimates with intent to construct or build, when contract price amounts to \$100.00 or more.

Section 3: That section 49 of ordinance 14 be amended to read as follows; Every person engaged in the business of draying, or transferring shall pay a license of \$5.00 per quarter, and any person who engages in the business of teaming or hauling for hire or profit, shall pay a license of \$3.00 per quarter.

Section 4. That when a license is not paid by the 10th of the month beginning with the quarter that they are due and payable, a penalty of 10% additional is hereby added to the amount of the license and the same to be collected as provided in Ordinance 14.

All ordinances and parts of ordinances so far as they may conflict herewith are hereby repealed.

This ordinance shall be in full force and effect from and after its passage, approval and publication as provided by law.
