

RESOLUTION NO. 151

A RESOLUTION PROVIDING FOR PERMISSION TO TAP CITY WATER MAIN AND LATERALS, AND PROVIDING THE TIME WITHIN WHICH CONNECTION SHALL BE MADE.

WHEREAS, permission has been heretofore granted by the City Council granting property owners the right to make three-quarter inch taps to the city main or laterals for the use of water for domestic purposes, and

WHEREAS, many of these permits have not been used or installation has been delayed for long periods of time,

NOW, THEREFORE, BE IT RESOLVED, That from and after passage of this resolution, any permits hereafter granted by the City Council must be used and the tap to the city main or laterals must be made within ninety (90) days of the granting of the permit, or such permit shall be automatically cancelled and the permittee must then make a new application for such permit.

BE IT FURTHER RESOLVED, That any and all permits heretofore granted shall become cancelled and void from and after ninety (90) days from the date hereof.

RESOLUTION NO. 152

A RESOLUTION CREATING A SUB-DISTRICT WITHIN OIL SPRINKLING DISTRICT NO. 14, TO BE DESIGNATED AS SUB-DISTRICT NO. 14S, DEFINING THE BOUNDARIES THEREOF, DESIGNATING THE IMPROVEMENTS TO BE MADE, AND THE ESTIMATED COST THEREOF. *Copy*

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Section 1. That a sub-district within Oil Sprinkling District No. 14, to be known and designated as Sub-district No. 14S, is hereby created.

Section 2. That the boundaries of said Sub-district No. 14S are hereby designated as the outside boundary lines of the hereinafter described lots and shall include all of the area of that portion of Oil Sprinkling District No. 14, including the streets upon which the following described lots and blocks abut;

— (Lots 5 to 8 inclusive in Block 7 and Lots 1 to 4 inclusive in Block 12 of Lake shore Addition to the City of Polson.

Lots 1 to 6 inclusive in Block 3 of Riverside Addition to the City of Polson.

Lots 5 to 8 inclusive in Block 1 and all of Block 2 of Pollman Addition to the City of Polson.

Lots 7 to 12 inclusive in Block 1, Lots 7 to 12 inclusive of Block 2, Lots 7 to 12 inclusive in Block 3, Lots 5 to 8 inclusive of Block 4, and all of Blocks 5, 6, 7, 8, 9, 10, 11, 12, 13, 14, 15, and 16 in Lewis Addition
