RESOLUTION No. 167 OF INTENTION TO EXTEND THE BOUNDARIES OF THE CITY OF POSLON, MONTANA, AND TO INCLUDE A CONTIGUOUS TRACT OF LAND WITHIN THE CORPORATE LIMITS THEREOF.

WHEREAS, William F. Curran and Mary E. Curran, Husband Wife, the owners of the hereinafter described tract of land contiguous to the City of Polson, Lake County, Montana, have requested that the City of Polson extend its boundaries so as to include said tract of land within the corporate limits of the City of Polson, Lake County, Montana;

AND WHEREAS, The City Council of the City of Polson, Lake County, Montana, at a regular meeting held Monday, July 6, 1959, at the City Hall in the City of Polson, duly considered the question of extending the boundaries of the City of Polson to include a contiguous tract of land hereinafter described;

AND WHEREAS, It appearing to the City Council of the City of Polson that the following described tract of land is contiguous to the City of Polson, to-wit:

HILLVIEW HEIGHTS ADDITION, An addition to the City of Polson, Lake County, Montana, all as further appears from the map or plat thereof on file and of record in the office of the Clerk and Recorder of Lake County, Montana,

and in the judgment of the City Council of the City of Polson, it will be to the vest interest of said city and the inhabitants thereof and of the inhabitants of the hereinbefore described contiguous tract, that the boundaries of the City of Polson shall be extended so as to include the hereinbefore described contiguous tract of land within the corporate limits thereof;

NOW, THEREFORE, BE IT RESOLVED By the City Council of the City of Polson, Lake County, Montana:

That it is their intention to extend the boundaries of the City of Polson so as to include the above described contiguous tract of land within the corporate limits thereof;

AND BE IT FURTHER RESOLVED, That in the judgment of the City Council of the City of Polson, it will be to the best interest of said city and the inhabitants thereof, and in the best interest of the inhabitants of the hereinbefore described contiguous tract, that the boundaries of the City of Polson, be extended so as to include the same within the corporate limits of the City of Polson.

BE IT FURTHER RESOLVED, That the City Clerk of the City of Polson forthwith notify, in writing, all property holders within the boundaries of the hereinbefore described tract of land, and cause to be published in the Flathead Courier, a newspaper published in the City of Polson, Montana, once a week for two (2) successive weeks, a notice of the passage of this Resolution, which notice shall further state that for a period of twenty (20) days after the first publication thereof, that the City Clerk will receive expressions of approval or disapproval, in writing, of the proposed extension of the boundaries of the City of Polson as in this Resolution provided, from freeholders of the territory herein proposed to be embraced in the corporate limits of the City of Polson.

The foregoing Resolution was duly and regularly passed by the City Council of Polson, Montana, and adopted and approved by the Mayor of the City of Polson this 6th day of July, 1959.


