

## RESOLUTION No. 38

A resolution declaring it to be the intention of the City Council of the city of Polson, Flathead County, Montana to create a Special Sewer Improvement District No. 5 in the city of Polson, Flathead County, Montana, for the purpose of constructing sewers as herein provided and described.

BE IT RESOLVED, by the city council of the city of Polson, Montana.

## Section 1.

That it is the intention of the city council to create and establish in the city of Polson, Montana a special improvement district for the purpose of making and constructing sewers along all that portion of the city of Polson, Montana, including all streets, alleys and intersections within the boundaries hereinafter described.

## Section 2.

That said special improvement district shall be known and designated as Special Sewer Improvement District No. 5 of the city of Polson, Montana.

## Section 3.

The boundaries of said Special Sewer Improvement District No. 5 of the city of Polson, Montana are hereby designated and described as follows, to wit:-

Beginning at the intersection of center lines of "G" street and Hawthorne Ave; thence west along the center lines of "G" street 360 feet to the intersection of the center line of "G" street and Maple Ave; thence north along the center line of Maple Ave . 368.5 feet to the intersection of center lines of Maple Ave and "F" street; thence west along the center line of "F" street 631 feet to the intersection of center lines of "F" street and Birch Ave.; thence south along the center line of Birch Ave., 368.5 feet to the intersection of center lines of Birch Ave. and "G" street; thence east along the center line of "G" street 271 feet to the intersection of center lines of "G" street and Cedar Ave.; thence south along the center line of Cedar Ave. 354.5 feet to the intersection of center lines of Cedar Ave and "H" street; thence along the center line of "H" street 720 feet to the intersection of center lines of "H" street and Hawthorne Ave.; thence north along the center line of Hawthorne Ave., 354.5 feet to the intersection of center lines of Hawthorne Ave., and "G" street which is the point of beginning.

## Section 4.

That the District included within said boundaries is hereby declared to be the district benefited by the making of said improvements and that the property included within the boundaries of said district is hereby declared to be the property to be assessed for the cost and expenses of making said improvements.

## Section 5.

Said lots being benefited by and assessed for the construction of said sewers are as follows, to wit:-

Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and 12 of Block Four (4) and Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and 12 of Block Five (5) in the Riverside Addition to the city of Polson, Montana; also, Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and 12 in Block Two (2) and Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and 12 in Block Three (3) in the Lewis Addition to the city of Polson, Montana.

## Section 6.

That the character of said improvements which are to be made in said Special Sewer Improvement District No. 5 are as follows, to wit:- the said improvement shall consist of a Combination Domestic and Storm Gravity Sewer; said untreated sewage to be discharged into Pend d'Oreille River; in the construction of said system an eight inch circular vitrified pipe inside measure shall be used.

## Section 7.

The location of said sewer is as follows:-

Beginning at the intersection of center line of alley (running E. and W. through block 2, Lewis Add.) with the east property line of lots 1 and 12 block 2; thence west along the center line of said alley 510 feet to the center of block 3, Lewis Add.; thence north between lots 3 and 4 block 3 and along the center line of alley (running N. and S. through block 5 Riverside Add.) 545 feet to the center line of "F" street; thence west along the center line of "F" street 315.5 feet to the intersection of center line of

"F" street and alley (running N. and S. through block 4 Riverside Add.); thence in a northerly direction along the projection of center line of alley (running N. and S. through block 4) 220 feet; thence in open trench N. 20 Deg. 00 Minutes W. approximately 200 feet to the Pend d'Oreille River; also, beginning at the intersection of center line of alley (running N. and S. through block 4 Riverside Add.) and the south property line of lots 6 and 7 block 4; thence north along center line of alley aforesaid 340 feet to the intersection of center line of aforesaid alley and "F" street to join above described sewer; also, beginning at the intersection of center line of alley (running E. and W. through block 3, Lewis Add.) and the property line of lots 6 and 7 block 3; thence east along center line of alley 150 feet to the center of block 3 to join above described sewer.

Said proposed system to be provided with flush tanks, catchment basins, man holes, lamp holes and any further necessary appliances, fittings or structures that may be required to insure proper operation and maintenance.

The approximate quantities are as follows:-

2100 feet of 8 inch vitrified pipe,  
2 flush tanks (possibly 3)  
5 man holes,  
3 lamp holes,  
200 feet of open trench.

#### Section 8.

That the entire cost and expense of said improvement shall be assessed against all of said Special Sewer Improvement District No. 5 and each lot or parcel of land within said district shall be assessed for that part of the whole cost which its area bears to the area of the entire district, exclusive of streets, alleys, avenues and public places.

#### Section 9.

That the estimated cost and expense of making said improvement is the sum of \$70.00 per lot and that the total estimated cost of making said improvement is \$3,300.00

#### Section 10.

That the cost and expense of making said improvement shall be assessed and paid in the following manner to wit:

That the assessment levied to defray the cost of said improvement shall be extended over a period of eight years and paid in eight annual installments or payments, the first of which shall be paid in the year 1923. Deferred payments or installments shall bear interest at the rate of six per cent per annum, payable annually.

#### Section 11.

That warrants issued against Special Sewer Improvement District No. 5 Fund to be created for said Special Sewer Improvement District No. 5 shall be issued in the payment of the cost and expense of making said improvements in said Special Sewer Improvement District No. 5 and that such warrants shall be issued in denominations of \$100.00 or fraction or multiple thereof.

#### Section 12.

That the special assessment to be levied upon and assessed against the property within said Special Sewer Improvement District No 5 to pay the cost and expense of making said improvement, may be paid in installments extending over a period of eight years.

#### Section 13.

That at any time within fifteen days after the date of the first publication of notice of the passage of this Resolution any owner of property within said district which will be assessed for the cost and expense of making said improvements, may make and file in the office of the city clerk of the city of Polson, Montana, a written protest against the proposed work or against the extent or creation or said district, or both, and that the city council will proceed to hear and pass upon all such protests at a special meeting of said city council to be held on Friday the 22nd day of ~~April~~ September, 1922 at 8 o'clock P. M. of said day in the City Hall of the city of Polson, Montana.

Passed, adopted and approved this 1st day of September, 1922.

## RESOLUTION No. 39

A Resolution establishing and creating Special Sewer Improvement District No. 5 in the City of Polson, County of Flathead and State of Montana for the purpose of constructing sewers in said district, describing the boundaries thereof and the property to be assessed.

BE IT RESOLVED by the city council of the city of Polson, Montana.

WHEREAS, the city council of the city of Polson on the 1st day of September 1922 duly and regularly passed and adopted Resolution No. 38 of the said city of Polson declaring its intention to create Special Sewer Improvement District No. 5 of the city of Polson, and

WHEREAS, pursuant to the said Resolution the said city council caused notice of the passage and adoption of said resolution to be published in the Flathead Courier, a weekly newspaper published in the city of Polson in the issues of said paper of Sept. 7th and 14th, 1922 and for a period of more than 15 days immediately preceding the 22nd day of September, 1922, and

WHEREAS, the said city council caused notice of the passage and adoption of said resolution, together with copy of said resolution to be posted by the city clerk throughout the city on the 6th day of Sept. 1922 in three of the most public places in the city, to wit:- one in the post office, one in the office of the city treasurer and one in the office of the city clerk, and

WHEREAS, pursuant to said Resolution No. 38 the city clerk of the city of Polson did on the 7th day of Sept, 1922, the same being the same day said notice was first published in the Flathead Courier mail to each and every person, firm or corporation agent of such firm, person or corporation having property within the said proposed district and directed to the, last known address of said person, firm or corporation or agent a notice of the passage and adoption of said resolution of intention to create Special Sewer Improvement District No. 5 of said city, and

WHEREAS, said notice was published, posted and mailed as aforesaid, describing the general character of the improvement proposed to be made in said district, the estimated cost thereof and designating the time and the place where said council of the city of Polson would hear and pass upon all protests made against the making of said improvements or the creating of said district and which said notice refers to said Resolution No. 38 on file in the office of the City Clerk for a description of the boundaries of said Special Sewer Improvement District No. 5, and

WHEREAS, the city council of the city of Polson has met in special session at the time and place fixed and set by said Resolution and the aforesaid notice for the hearing of the protests against the making of said proposed improvements and the creation of said proposed district and have heard and fully considered all such protests.
