

RESOLUTION OF INTENTION TO EXTEND THE BOUNDARIES OF THE CITY OF POLSON, MONTANA, AND TO INCLUDE THOSE CERTAIN TRACTS OR PARCELS OF LAND HEREINAFTER DESCRIBED WHICH ARE CONTIGUOUS TO THE CITY OF POLSON, MONTANA

WHEREAS, Dwight Swarthout, Mary Swarthout and Glesner DeGolier, owners of a tract of land contiguous to the City of Polson, Lake County, Montana, have requested that the City of Polson extend its boundaries so as to include the following described tracts of land within the corporate limits of the City of Polson, Lake County, Montana; and

WHEREAS, the City Council of the City of Polson at a regular meeting held on April 17, 1978, at the City Hall in the City of Polson, Montana, duly considered the question of extending the boundaries of the City of Polson to include the contiguous tracts of land hereinafter described; and

WHEREAS, it appearing to the City Council of the City of Polson, Montana, that the following tracts of land are contiguous to the City of Polson, Montana, to-wit:

The South Half of the Northwest Quarter of the Southwest Quarter (S $\frac{1}{2}$ NW $\frac{1}{4}$ SW $\frac{1}{4}$) Section 10, Township 22 North, Range 20 West, M.P.M., Lake County, Montana;

AND

A portion of the Southwest Quarter of the Southwest Quarter (SW $\frac{1}{4}$ SW $\frac{1}{4}$) Section 10, Township 22 North, Range 20 West, M.P.M., Lake County, Montana. Beginning at a point that bears South 89°43' East 560.00 feet from the Northwest corner of said SW $\frac{1}{4}$ SW $\frac{1}{4}$; thence South 89°43' East 762.20 feet; thence South 0°01' East 537.70 feet to the Northerly right of way of Skyline Drive; thence along said right of way North 88°00' West 120.00 feet; South 81°15' West 100.00 feet; and South 72°11' West 570.31 feet; thence North 0°03' West 737.04 feet to the point of beginning.

AND

FURTHER GRANTING:

An easement for the construction, repair and replacement of buried sewer and water lines along the boundary line between Block 21 and 22 of GRANDVIEW, an addition to the City of Polson, according to the map or plat thereof on file and of record in the office of the County Clerk and Recorder of Lake County, Montana, as reserved by grantor in that certain deed recorded under Micro #214489 of the records of said County.

SUBJECT TO easements, reservations and rights of way apparent or of record, and liens of the Flathead Irrigation District and Project.

and in the judgment of the City Council of the City of Polson, Montana, it will be to the best interests of the said City and the inhabitants thereof, and the inhabitants of the hereinabove described contiguous tracts, that the boundaries of the City of Polson, Montana, shall be extended so as to include the hereinbefore described contiguous tracts of land within the corporate limits therefor;

NOW THEREFORE, be it resolved by the City Council of the City of Polson, Lake County, Montana, that it is their intention to extend the boundaries of the City of Polson, Montana, so as to include the above-described contiguous tracts of land within the corporate limits thereof, and

BE IT FURTHER RESOLVED that in the judgment of the City Council of the City of Polson, Montana, it will be to the best interests of the City and the inhabitants thereof, and in the best interests of the inhabitants of the hereinbefore described contiguous tracts, that the boundaries of the City of Polson be extended so as to include the same within the corporate limits of the City of Polson, Montana.

BE IT FURTHER RESOLVED that the City Clerk of the City of Polson, Montana, forthwith notify in writing all property holders within the boundaries of the hereinbefore described tract of land, and cause to be published in the Flathead Courier, a newspaper published in the City of Polson once a week for two successive weeks, a notice of the passage of this resolution, which notice shall further state that for a period of twenty (20) days after the publication thereof, the City Clerk will receive expressions of approval or disapproval in writing of the proposed extension of the boundaries of the City of Polson, Montana, as in this resolution provided, from free holders of the territory herein proposed to be embraced in the corporate limits of the City of Polson, Montana.

The foregoing resolution was duly and regularly passed by the City Council of Polson, Montana, and adopted and approved by the Mayor of the City of Polson this 17th day of April, 1978.
