## DESOLUTION NO. \_9

A Resolution to Establish Sprinkling District No 1, and to create a fund therefore.

Be it resolved by the City Council of the City of Polson, Lontona

That for the purpose of sprinkling the Streets, alleys and public places within the City of Polson, Montana, there is hereby created "Sprinkling District No. 1".

That said Sprinkling District No. 1 shall include all of the property abutting on the Streets and Avenues and within the boundaries of said Sprinkling District No. 1 which boundaries are declared to be as follows:

Commonding at a point where the westerly line of Lootensi Avenue intersects the west line of Pourth Street (extended), thence south along the west line of Fourth Street to the northmost point of Lot 1 Block I, thence in a southwesterly direction ecross Lots 1 and 2, Block I, to the center of the south line of Lot 2 Block I, thence in the same direction to the center line of A Street, to she west along the center line of A Street to the east line of Mootenai Avenue, thence southwesterly along the east line of Mootenei Avenue to the center line of the Alley between Third, and Mourth Streets; thence south along the center line of said alley to the center of E Street; thence west along the center line of E Street to its intersection with the center line of the alley between Second and Third Streets; thence north along the center line of said alley to the north line of B Street themes west along the center line of said alley to the north line of B Street, thence vest along the north line of B Street to the southwest corner of Block 4; thence along the let line of Like Street to the center line of A Street; thence exet along the center line of A Street; thence exet along the center line of A Street; thence exet along the center line of Lotenai Avenue; thence northeast along the vest line of Lotenai Avenue; thence northeast along the vest line of Lotenai Avenue; of beginning. Said district to include the west one-half of Lotenai and 2 of Plock 5, all of Block 4, Lotenai 7, 8 and 9 of Block 5, the west half of Blocks 10, 14 and 19, and the east half of Blocks 11, 13 and 20 of the Government Townsite of Polson, Nontana.

That there is also created a Sprinkling District Fund Lo. 1 and that said Fund is hereby created for the pur ose of receiving all taxes collected for sprinkling in the aforesaid District.
