

RESOLUTION NO. 11.

A resolution to Establish Sprinkling District No. 1, and to create a fund therefore.

Be it Resolved by the City Council of the City of Polson, Montana.

That for the purpose of sprinkling the Streets, alleys, and public places within the City of Polson, Montana, there is hereby created "Sprinkling District NO. 1".

That said Sprinkling District No. 1 shall include all of the property abutting on the Streets and Avenues and within the boundaries of said Sprinkling District No. 1 which boundaries are declared to be as follows:

Commencing at a point in the North line of Kootenai Avenue directly North of the center of the alley in Block two (2); thence South to the center of Block six (6); thence East to the City Limits; thence South to the center of the alley of Block eight (8) thence West to the center of Block nine (9); thence South to the South line of "G" Street; thence West along the South line of "G" Street to a point opposite the center of Block thirty (30) thence North to the center of Block twenty-three (23); thence West to the East line of second street; thence North to the Northwest corner of Lot seven (7) in Block twenty (20); thence East to the center of the alley in Block twenty (20); thence North to the North side of "B" Street; thence West to the Southwest corner of Block four (4); thence Northeasterly along the East line of Lake Street to the North line of "A" street; thence East to the West line of Kootenai Avenue; thence northeasterly along the Westerly and Northerly sides of Kootenai Avenue to the point of beginning. Said District to include the West one-half ($\frac{1}{2}$) of Blocks numbered 2, 6, 9, 15, 18, 25, and 28; the whole of Blocks Numbered 3, 4, 5, 10, 14, 19, 24 and 29; the East one-half ($\frac{1}{2}$) of Blocks numbered 11, 13, 20, 23, and 30; the South one-half ($\frac{1}{2}$) of Block seven (7); the North one-half ($\frac{1}{2}$) of Block eight (8); lots numbered 10, 11 and 12 in Block six (6); Lots numbered 1, 2, and 3 in Block nine (9); Lots numbered 4, 5, and 6 in Block twenty-three (23); and Lot number seven in Block twenty (20) of the original plat of the City of Polson, Montana.

That there is also created a Sprinkling District Fund No. 1 and that said fund is hereby created for the purpose of receiving all taxes collected for sprinkling in the aforesaid District.

All sprinkling districts heretofore created by resolution or ordinance passed by the City Council of the said City of Polson, Montana, are annulled and superseded hereby.

This ordinance shall be in full force and effect immediately after its passage and approval.

RESOLUTION NO. 12.

A RESOLUTION ESTABLISHING AND CREATING SPECIAL SEWER IMPROVEMENT DISTRICT NO. I IN THE CITY OF POLSON, COUNTY OF PLATHEAD, STATE OF MONTANA, FOR THE PURPOSE OF CONSTRUCTING SEWERS IN SAID DISTRICT AND DESCRIBING BOUNDARIES THEREOF AND THE PROPERTY TO BE ASSESSED.

WHEREAS, the within and foregoing resolution Number 10 was on the 7th day of June, A. D. 1915, duly and regularly passed and adopted by the City Council of the City of Polson, Montana, and filed in the office of the City Clerk of said City of Polson:

AND WHEREAS the said City Council causes notice of the passage and adoption of said resolution to be published in the Pluthead Courier a weekly newspaper, published in the City of Polson;

AND WHEREAS, the City Clerk of the City of Polson did on the 14th day of June A. D. 1915, being the day of the first publication of said notice, mail to each and every person, firm, corporation, or known agent thereof, having property within the proposed district, directed to the last known address of such person, firm, corporation, or agent, a notice of the passage and adoption of said resolution.

AND WHEREAS, said notices so published and mailed as aforesaid describe the general character of the improvement proposed to be made in said district, the estimated cost thereof, and stated the time and place set for the hearing of protest against the making of said improvement and the creation of said proposed district; and which said notices referred to said resolution for the boundaries of said proposed district and for further particulars with reference thereto;

AND WHEREAS, the City Council have met in the regular session at the time and place fixed and set by said resolution and aforesaid notices for the hearing of the protests against the making of said proposed improvement and the creation of said proposed district and have heard and fully considered all such protests;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

That no protests have been made or filed with the City Clerk of the City of Polson, against the making of such proposed improvements and against a creation of such proposed district within the time specified and provided in resolution Number 10:
