RESOLUTION NO. 13.

A RESOLUTION DECLARING IT TO BE THE INTENTION OF THE CITY COUNCIL OF THE CITY OF POLSON, FLATHEAD COUNTY; MONTANA, TO CREATE SPECIAL SEWER IMPROVEMENT DISTRICT NUMBER 2 IN THE CITY OF POLSON, FLATHEAD COUNTY, MONTANA, FOR THE PURPOSE OF CONSTRUCTING SEWERS AS HEREIN PROVIDED AND DESCRIBED.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF POLSON, MONTANA:

Section 1. That it is the intention of the City Council to create and establish in the City of Polson, Montana, a Special Improvement District for the purpose of making and constructing sewers along all that portion of the City of Polson, Montana, including all streets, alleys, intersections within the boundaries hereinafter particularly described.

Section 2. The said Special Improvement District shall be known and designaged as Special Sewer Improvement District Number 2 of the City of Polson, Montana.

Section 3. The boundaries of said Special Sewer Improvement District Number 2 of the City of Polson, Montana, are hereby designated and described as follows, to-wit:

Section 6. That the character of the said improvements which are to be made in said Special Sewer Improvement District Number 2 are as follows, to-wit:

The said improvements shall consist of a Water Carriage Gravity Sewer System primarily for the conveying of house sewage, but to a certain extent to be used for combined storm and house sewage, said sewage to be emptied directly into Flathead river without treatment. In the construction of the said Sewer system circular vitrified pipe ranging in size from eight to eighteen inches in dismeter, inside measure, will be used, cast iron pipe will be used for discharging into the river.

Section 7. The location of the said proposed sewer is as follows: Beginning at the intersection of the center line of the alley in Block 31 of the Original Townsite of said City of Polson and the west property line of Lots 8 and 9 in the said Block 31; thence in an easterly direction 440 feet along the center line of the alley in Block 31 to the intersection of said alley and the center line of Second street; thence in an easterly direction 380 feet along the center line of the alley in Block 30 to the intersection of said alley and the center line of Third street; thence in an easterly direction 380 feet along the center line of the alley in Block 29 to the intersection of said alley and the center line of Fourth street; thence in an easterly direction 380 feet along the center line of the alley in Block 28 to the intersection of said alley and the center line of Fifth Street; thence in an easterly direction 340 feet along the center line of the alley in Block 27 to the intersection of said alley and the center line of the alley in Block 27 to the intersection of said alley and the east property line of Lots 1 and 12 in the said Block 27 of the Original Townsite of the said City of Polson; and

Beginning at the intersection of the center line of the alley through Block 9 and the west property line of Lots 6 and 7 of said Block 9 in the Original Townsite of the City of Polson; thence in an easterly direction 340 feet along the center line of the alley in Block 9 to the intersection of said alley and the center line of Fifth street; thence in an easterly direction 340 feet along the center line of the alley in Block 8 to the intersection of said alley and the east property line of Lots 1 and 12 in the said Block 8 in the Original Townsite of the City of Polson: and Polson; and

Beginning at the intersection of the center line of "C" street and the center line of Second street in the Original Townsite of the City of Polson; thence in a sourtherly direction 190 feet along the center line of Second street to the intersection of said Second street with the center line of the alley through Block 12 of the Original Townsite of the City of Polson; thence in a westerly direction 240 feet along the center line of the alley in Block 12 to the intersection of said alley and the east property line of Lot 6 in the said Block 12 of the Original Townsite of the City of Polson; and the City of Polson: and

Beginning at the intersection of the center line of "C" street with the center line of Third street; thence in a westerly direction 380 feet along the center line of "C" street to the intersection of said "C" street and the center line of Second street; thence in a westerly direction along the center line of "C" street produced, 615 feet to the shore of the Flathead river; thence with a deflection of 12 degrees to the right 600 feet to a point in the Flathead River.

Said system will contain suitable flush tanks, catchment basins, man holes, and lamp holes to insure the proper operation and in-

spection and maintenance.

The construction of this system will require the placing of approximately the following amount of circular vitrified pipe;

6193 lineal feet of 8 inch pipe 1432 " " " 10 " " 4640 " " " 15 " " 1749 " " 18 " "

Also 600 lineal feet of 18 inch cast iron pipe for discharging int the river.

In the said sewer system there will also be approximately 36 man holes, 7 flush tanks, 29 lamp holes, and 18 catchment basins. Said sewer system is to be constructed in accordance herewith, and with plans and specifications now on file with the City Clerk of the City of Polson, Montana.

Section 8. That the entire cost and expense of said improvements shall be assessed against all of said Special Improvement Sewer. District Number 2, and each lot and parcel of land within said district shall be assessed for that part of the whole cost which its area bears to the area of the entire district, exclusive of streets, alleys, avenues and public places.

Section 9. That the estimated cost and expense of making said improvements is the sum of \$81.00 per lot for each lot 50 feet in width by 140 feet in depth, and other tracts in proportion thereto according to their area; that the total estimated cost and expense of making said improvements is \$25,285.00.

Section 10. That the cost and expense of making said improvements shall be assessed and paid in the following manner, to-wit:

That the assessment levied to defray the cost of said improvements shall be extended over a period of eight years, and paid in eight annual installments or payments, the first of which shall be paid in the year 1916; deferred payments or installments shall bear interest at the rate of six per cent per annum, payable annually.

Section 11. That warrants issued against Special Sewer Improvement District Number 2 fund, to be created for said Special Sewer Improvement District Number 2 shall be issued in the payment of the costs and expense of making said improvements in said Special Sewer Improvement District Number 2, and that such warrants shall be issued in denominations of \$100.00 or fraction or multiples thereof.

Section 12. That the special assessment to be levied upon and assessed against the property within said Special Sewer Improvement District Number 2 to pay the cost and expenses of making said improvement may be paid in installments extending over a period of eight years.

Section 13. That at any time within fifteen days after the date of the first publication of notice of the passage of this Resolution any owner of property within said District which will be assessed for the cost and expense of making said improvement, may make and file in the office of the City Clerk of the City of Polson, Montana, a written protest against the proposed work, or against the extent, or creation of said district, or both, and that the City Council will proceed to hear and pass upon all such protests at a regular meeting thereof to be held on the 24th day of January, 1916, at eight o'clock P. M. of said day in the City Hald of the City of Polson, Montana.
