

RESOLUTION NO. 14.

A RESOLUTION ESTABLISHING AND CREATING SPECIAL SEWER IMPROVEMENT DISTRICT NUMBER 2 IN THE CITY OF POLSON, COUNTY OF FLATHEAD, AND STATE OF MONTANA, FOR THE PURPOSE OF CONSTRUCTING SEWERS IN SAID DISTRICT, DESCRIBING THE BOUNDARIES THEREOF AND THE PROPERTY TO BE ASSESSED.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF POLSON, MONTANA:

WHEREAS, the City Council of the City of Polson on the 3rd day of January A. D. 1916 duly and regularly passed and adopted Resolution No. 13 of said City declaring its intention to create Special Sewer Improvement District Number 2 of the said City of Polson; and

WHEREAS, pursuant to the said Resolution the said City Council caused notice of the passage and adoption of said Resolution to be published in the Flathead Courier, a weekly newspaper published in the City of Polson, in the issues of said paper of January 6th, 13th and 20th, 1916, and for a period of more than fifteen days immediately preceding the 24th day of January A. D. 1916; and

WHEREAS, the said City Council caused notice of the passage and adoption of said Resolution, together with copy of the said Resolution, to be posted by the City Clerk throughout the City on the 8th day of January 1916, at three of the most public places within the City, to-wit; one at the office of the Police Judge, one at the office of the City Clerk, and one at the office of the City Treasurer; and

WHEREAS, pursuant to the said Resolution No. 13 the City Clerk of the City of Polson did on the 6th day of January A. D. 1916, the same being the same day that said notice was first published in the Flathead Courier, mail to each and every person, firm or corporation, or agent of such person, firm or corporation, having property within the said proposed District, and directed to the last known address of said person, firm, corporation or agent, a notice of the passage and adoption of said Resolution of the intention to create Special Sewer Improvement District Number 2 of said City; and

WHEREAS, said notice was published, posted and mailed as aforesaid, describing the general character of the improvement proposed to be made in said District, the estimated cost thereof, and designating the time when, and the place where, said Council of the City of Polson would hear and pass upon all protests made against the making of said improvement, of the creating of said District, and which said notice refers to said Resolution No. 13 on file in the office of the City Clerk for a description of the boundaries of said Special Sewer Improvement District Number 2, and for plans, specifications and details thereof; and

WHEREAS, the City Council of the City of Polson has met in regular session at the time and place fixed and set by said Resolution, and the aforesaid notice; for the hearing of the protests against the making of said proposed improvement, and the creation of said proposed district, and have heard and full considered all such protests;

NOT THEREFORE, Be it resolved by the City Council of the City of Polson, Montana, that the City Council having heard and passed upon all protests made and delivered to the City Clerk of the City Council of the City of Polson, against the making of said proposed improvement and against the extent and creation of the proposed district within the time specified and provided in Resolution No. 13, and finding said protests to be insufficient, and that the protests are not made by the owners of more than one-half of the area of the property to be assessed for said improvement, and said protests are hereby overruled and denied.

That there be, and there is, hereby created the said Special Improvement District to be known and designated as Special Sewer Improve-

ment District Number 2 of the City of Polson, Montana, in accordance with Resolution No. 13 of its intention heretofore introduced and passed by the City Council; that the character of the said improvements to be made in said Special Sewer Improvement District Number 2 is described as follows, to-wit:

The said improvements shall consist of a Water Carriage Gravity Sewer System primarily for the conveying of house sewage, but to a certain extent to be used for combined storm and house sewage, said sewage to be omitted directly into Flathead river without treatment. In the construction of the said sewer system, circular vitrified pipe ranging in size from eight to eighteen inches in diameter, inside measure, will be used, cast iron pipe will be used for discharging into the river.

Said system will contain suitable flush tanks, catchment basins, man holes and lamp holes to insure the proper operation and inspection and maintenance.

The construction of this system will require the placing of approximately the following amount of circular vitrified pipe:

Also 600 linear feet of eighteen-inch cast iron pipe for discharging into the river. In the said sewer system there will also be approximately 36 man holes, 7 flush tanks, 29 lamp holes, and 18 catchment basins. Said sewer system is to be constructed in accordance herewith, and with the plans and specifications now on file with the City Clerk of the City of Polson, Montana.

That the location of said proposed sewer is along the streets, alleys, avenues and public places of the City of Polson, Montana, as follows, to-wit:

Beginning at the intersection of the center line of the alley in Block 31 of the Original Townsite of said City of Polson and the west property line of Lots 8 and 9 in the said Block 31; thence in an easterly direction 440 feet along the center line of the alley in Block 31 to the intersection of said alley and the center line of Second street; thence in an easterly direction 360 feet along the center line of the alley in Block 30 to the intersection of said alley and the center line of Third street; thence in an easterly direction 360 feet along the center line of the alley in Block 29 to the intersection of said alley and the center line of Fourth street; thence in an easterly direction 360 feet along the center line of the alley in Block 28 to the intersection of said alley and the center line of Fifth street; thence in an easterly direction 340 feet along the center line of the alley in Block 27 to the intersection of said alley and the east property line of Lots 11 and 12 in the said Block 27 of the Original Townsite of the said City of Polson; and

Beginning at the intersection of the center line of the alley through Blocks 28 and 29 of the Original Townsite of the said City of Polson and the center line of Fourth street; thence in a northerly direction 570 feet along the center line of Fourth street to the intersection of said Fourth street with the center line of "E" street of the Original Townsite of the said City of Polson; thence 120 feet in a westerly direction along the center line of "E" street to the intersection of the same with the center line of the alley through Block 19; thence in a northerly direction 360 feet along the center line of the alley in Block 19 to the intersection of said alley and the center line of "D" street; thence in a northerly direction 360 feet along the center line of the alley in Block 14 to the intersection of said alley and the center line of "C" street; thence in a northerly direction 360 feet along the center line of the alley in Block 10 to the intersection of said alley and the center line of "B" street; thence in a northerly direction 360 feet along the center line of the alley in Block 5 to the intersection of said alley and the center line of "A" street; thence in an easterly direction 190 feet along the center line of "A" street to the intersection of said "A" street and the center line of Fourth street; thence in a southerly direction 190 feet along the center line of Fourth street to the intersection of said Fourth street and the center line of the alley through Block 6; thence in an easterly direction 360 feet along the center line of the alley in Block 6 to the intersection of said alley and the center line of Fifth street; thence in a southerly direction 190 feet along the center line of Fifth street to the

intersection of said Fifth street and the center line of "B" street; thence in a southerly direction 380 feet along the center line of Fifth street to the intersection of said Fifth street and the center line of "C" street; thence in a southerly direction 380 feet along the center line of said Fifth street to the intersection of said Fifth street and the center line of "D" street; thence in a southerly direction 190 feet along the center line of Fifth street to the intersection of said Fifth street and the center line of the alley through Block 17; and

Beginning at the intersection of the center line of the alley in Block 24 and the west property line of Lots 6 and 7 in the said Block 24 in the Original Townsite of the said City of Polson; thence in an easterly direction 340 feet along the center line of the alley in Block 24 to the intersection of said alley and the center line of Fourth street; thence in an easterly direction 380 feet along the center line of the alley in Block 25 to the intersection of said alley and the center line of Fifth street; thence in an easterly direction 340 feet along the center line of the alley in Block 26 to the intersection of said alley and the east property line of Lots 1 and 12 in said Block 26 in the Original Townsite of the City of Polson; and

Beginning at the intersection of the center line of the alley through Block 15 and the west property line of Lots 6 and 7 of said Block 15 in the Original Townsite of the City of Polson; thence in an easterly direction 340 feet along the center line of the alley in Block 15 to the intersection of said alley and the center line of Fifth street; thence in an easterly direction 340 feet along the center line of the alley in Block 16 to the intersection of said alley and the east property line of Lots 1 and 12 in said Block 16 of the Original Townsite of the City of Polson; and

Beginning at the intersection of the center line of the alley through Block 9 and the west property line of Lots 6 and 7 of said Block 9 in the Original Townsite of the City of Polson; thence in an easterly direction 340 feet along the center line of the alley in Block 9 to the intersection of said alley and the center line of Fifth street; thence in an easterly direction 340 feet along the centerline of the alley in Block 8 to the intersection of said alley and the east property line of Lots 1 and 12 in the said Block 8 in the Original Townsite of the City of Polson; and

Beginning at the intersection of the center line of the alley through Blocks 6 and 7 with the center line of Fifth street; thence in an easterly direction 265 feet along the center line of the alley in Block 7; thence in a northerly direction on a line parallel to and 75 feet distance from, the east boundary of Block 7, 190 feet to the intersection of the same with the center line of "A" street; thence in a westerly direction 265 feet along the center line of "A" street to the intersection of said "A" street and the center line of Fifth street; thence in a northerly direction 190 feet along the center line of Fifth street; and

Beginning at the intersection of the center line of the alley through Block 2 and the north property line of Lot 15 of said Block 2 in the Original Townsite of the City of Polson; thence in a southerly direction 440 feet along the center line of the alley in Block 2 to the intersection of said alley and the center line of "A" street; thence in a westerly direction 190 feet along the center line of "A" street to the intersection of said "A" street and the center line of Fourth street; thence in a northerly direction 117 feet along the center line of Fourth street; and

Beginning at the intersection of the center line of the alley through Blocks 5 and 10 in the Original Townsite of the City of Polson and the center line of "B" street; thence in a westerly direction 190 feet along the center line of "B" street to the intersection of the said "B" street with the center line of Third street; thence in a northerly direction 142 feet along the center line of Third street; and

Beginning at the intersection of the center line of "B" street and the center line of third street in the Original Townsite of the City of Polson; thence in a westerly direction 190 feet along the center line of "B" street to the intersection of the center line of the alley through Block 11; thence in a southerly direction 380 feet along the center line of the alley in Block 11 to the intersection of said alley and the center line of "C" street; thence in a southerly direction 380 feet along the center line of the alley in Block 13 to the intersection of said alley and the center line of "D" street; thence

southerly direction 340 feet along the center line of the alley in Block 20 to the intersection of said alley and the southerly property line of Lots 6 and 7 in the said Block 20 in the Original Townsite of the City of Polson; and

Beginning at the intersection of the center line of "D" street and the center line of Third street in the Original Townsite of the City of Polson; thence in a westerly direction 190 feet along the center line of "D" street to the intersection of the center line of "D" street with the center line of the alley through Block 13 and 20; and

Beginning at the intersection of the center line of "C" street and the center line of Second street in the Original Townsite of the City of Polson; thence in a southerly direction 190 feet along the center line of Second street to the intersection of said Second street with the center line of the alley through Block 12 of the Original Townsite of the City of Polson; thence in a westerly direction 240 feet along the center line of the alley in Block 12 to the intersection of said alley and the east property line of Lot 6 in the said Block 12 of the Original Townsite of the City of Polson; and

Beginning at the intersection of the center line of "C" street with the center line of Third street; thence in a westerly direction 380 feet along the center line of "C" street to the intersection of said "C" street and the centerline of Second street; thence in a westerly direction along the center line of "C" street produced, 615 feet to the shore of the Flathead river; thence with a deflection of 12 degrees to the right 600 feet to a point in the Flathead river.

The boundaries of the said Special Sewer Improvement District Number 2 shall be, and the same are hereby declared to be, the same as described in Resolution No. 13 to which reference is hereby made for a particular description thereof.

Said lots, pieces or parcels of land being benefitted by and assessed for the construction of said sewer are as follows, to-wit:

All of the foregoing lots, pieces and parcels of land being located in the City of Polson, Flathead County, Montana, according to the original government plat thereof now on file.

That reference to Resolution No. 13 is hereby made for further particulars.

That is hereby ordered and directed that said improvements be made in said Special Sewer Improvement District Number 2 in accordance with the plans and specifications thereof now on file in the office of the City Clerk of the City of Polson.

That the entire cost and expense of said improvements shall be

assessed against all of said Special Sewer Improvement District Number 2, and each lot and parcel of land within said district shall be assessed for that part of the whole cost which its area bears to the area of the entire district, exclusive of streets, alleys, avenues and public places.

That the estimated cost and expense of making said improvements is the sum of \$81.00 per lot for each lot 50 feet in width by 150 feet in depth, and other tracts in proportion thereto according to their areas, that the total estimated cost and expense of making said improvements is \$25,285.00.

That the cost and expense of making said improvements shall be assessed and paid in the following manner, to-wit:

That the assessment levied to defray the cost of said improvements shall be extended over a period of eight years, and paid in eight annual installments or payments, the first of which shall be paid in the year 1916; deferred payments or installments shall bear interest at the rate of six per cent per annum, payable annually.

That warrants issued against Special Sewer Improvement District Number 2 fund, to be created for said Special Sewer Improvement District Number 2 shall be issued in the payment of the costs and expense of making said improvements in said Special Sewer Improvement District Number 2, and that such warrants shall be issued in denominations of \$100.00 or any fraction or multiple thereof.

That the special assessment to be levied upon and assessed against the property within said Special Sewer Improvement District Number 2 to pay the cost and expenses of making said improvement may be paid in installments expending over a period of eight years.

ORDINANCE NUMBER 109

Introduced by E.N. Stoughton

AN ORDINANCE DEFINING CERTAIN PUBLIC OFFENCES AND PROVIDING  
PENALTIES FOR THE VIOLATION OF THE SAME.

It shall be unlawful for the owner or driver of teams or single animals to obstruct the crossings of streets or alleys of the City of Polson by halting or hitching such team or teams, animal or animals before the same, or for any person or persons within the said City of Polson to deposit, store or leave wagons, implements, sleighs, machinery, lumber or wood at and along the street or streets of the City of Polson that may obstruct or hinder the free and unlimited travel of the public, either on foot or with team or teams or other means of transportation. It is hereby made the duty of the Street Commissioner or the Chief of Police and Policemen to see that the provisions of this section are enforced, and after notice and proper request to any person so obstructing the street or streets, alley or alleys to remove such team or single animal, or such obstruction, and if such person shall continue to obstruct the street or alley, he shall be deemed guilty of a misdemeanor and on conviction thereof shall be fined in any sum not exceeding \$500.00 Dollars.

The passage of this ordinance being deemed immediately necessary for peace, health and safety to the City of Polson and the inhabitants thereof, it is hereby declared to be "An Emergency Measure" and to be and to become immediately effective from and after its passage and survival.
