

## RESOLUTION NO. 21.

Whereas, the citizens and owners of the hereinafter described platted tracts and parcels of land contiguous to the City of Polson, Montana, are desirous of being annexed to and form a part of the City of Polson, Montana, and

Whereas, it appearing to the City Council that it will be to the best interests of the City of Polson, Montana, its inhabitants and to the inhabitants of the hereinafter described platted tracts and parcels of land, that the said territory embraced therein be included within the corporate limits of the City of Polson, Montana,



BE IT THEREFORE RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, That it is the judgment of the City Council that it will be to the best interests of the City of Polson, Montana, its inhabitants and the inhabitants of the hereinafter described platted tracts and parcels of land, that the boundaries of the said City of Polson, Montana, be extended so as to include within the corporate limits of the said City, all the platted tracts and parcels of land located within the following described territory contiguous to the City of Polson, Montana, to-wit:

Beginning at the 1/16 Cor., - on the Sec. line between Secs. 4 and 9, - the said 1/16 cor. being 1318.75 ft. Westerly of the Sec. Cor. common to Secs. 3, 4, 9 and 10, T 22 N., R 20 W. M. M. - thence South 21.2 ft., thence west 14.75 ft., thence South 491.2 ft. to the N.W. Cor. of Blk. 4 of "Polson City Center Addition", thence South along the West boundary line of Polson City Center and Elevation Additions to the N. W. Cor. Blk. 7 of "Elevation Addition", thence East 660 ft. to the N.E. Cor. Blk 6 of Elevation Addition", thence North 765 ft. to the S.E. Cor. Blk 11 of "Polson City Center Addition, thence East 682.6 ft. to the intersection of the Sec. line between Secs. 9 and 10, thence south along said Sec. line 1635 ft., thence East 30 ft. to the S. W. Cor. Blk. 21 of "Grandview", thence East along the south boundary line of "Grandview" to the S.E. Cor. Blk. 28 of "Grandview", thence North along the East boundary of Grandview to the N.E. Corner Blk. 1 of "Grandview", thence North 55 ft. to the S.E. Cor. Blk 8 of " Polson Heights", thence North along the East boundary line of Polson Heights to the Northeast Cor. Blk. 1 Polson Heights, thence North 1320 ft. more or less, to the 1/16 Cor. on the Sec. line between Secs. 3 and 10, thence Westerly along said Sec. line, 1320 ft more or less, to the Sec. Cor. common to Secs. 3, 4, 9 and 10, thence Westerly along the Sec. Line between Secs. 4, and 9, 1318.75 ft. to the point of beginning.

Be it further resolved that the City Clerk forthwith cause to be published in the Flathead Courier of Polson at least once a week for two successive weeks, a notice of the passage of this resolution and that for a period of twenty days after the first publication of said notice the City Clerk will receive written expressions of approval or disapproval of the proposed extension of said boundaries of said City of Polson, Montana, from resident freeholders of said territory proposed to be embraced therein.
