RESOLUTION NO. 22.

WHEREAS, the City Council of the City of Polson, on the 27th day of August, 1917 duly and regularly passed and adopted a resolution declaring it to be to the best interest to the City of Polson and of the inhabitants of the hereinafter described platted tracts and parcels of land, that the boundaries of the said City be extended so as to include within the Corporate Limits the said platted tracts and parcels of land, and

WHEREAS, the City Council caused to be published in the Flathead Courier, a paper nearest to the said platted tracts and parcels of land, once a week for two successive weeks, a notice to the effect that said resolution had been duly and regularly passed and that for a period of twenty (20) days from the first publication of said notice, the City Clerk would receive expressions of approval or disapproval in writing, of the proposed extension of the boundaries of said City, from the resident freeholders of the territory proposed to be embraced therein, and

WHEREAS, more than twenty (20) days have elapsed since the first publication of the said notice, and this being the first regular meeting of the Council after that said expiration of the said twenty (20) days, and

WHEREAS, the City Clerk has lain before the City Council all the communications received by him relative to the said proposed extensions of the boundaries and the City Council after considering the same, deems that the boundaries should be extended, and the said resolution sould be passed; BE IT THEREFORE

RESOLVED, That the boundaries of the City of Polson, Montana, shall be extended so as to embrace and include the said Additions end-treets platted tracts and parcels of land, which are bounded and described as follows, to-wit: -

Beginning at the 1/16 Cor., on the Sec. line between Secs. 4 and 9, - the said 1/16 Cor. being 1318.75 ft. Westerly of the Sec. Cor. common to Secs. 3,4,9 and 10, T. 22 N., R. 20 W.H.M.-thence South 21.2 ft.; thence west 14.75 ft.; thence south 491.2 ft. to the N.W. Cor. of Blk. 4 of "Polson City Center Addition"; thence south along the West boundary line of Polson City Center and Elevatione Additions to the N.W. Cor. of Blk. 7 cf "Elevation Addition"; thence east 660 ft. to the N.E. Cor. of Blk. 6 of "Elevation Addition"; thence north 765 ft. to the S.E. Cor. of Blk. 11 of "Polson City Center Addition"; thence east 682.6 ft. to the intersection of the Sec. line between Secs. 9 and 10; thence south along said Sec. line 1635 ft.; thence east 30 ft. to the S.T. Cor. of Blk. 21 of "Grandview"; thence east along the south boundary line of "Grandview" to the S.E. Cor. of Blk. 28 of "Grandview"; thence north along the east boundary of "Grandview" to the N.E. Cor. of Blk. 1 of "Grandview"; thence north along the east boundary of "Grandview" to the S.E. Cor. of Blk. 8 of "Polson Heights"; thence north along the east boundary line of "Polson Heights"; thence north along the east boundary line of "Polson Heights"; thence north 1320 ft. more or less, to the 1/16 Cor. on the Sec. line between Secs. 3 and 10; thence westerly along said Sec. line 1320 ft. more or less, to the Sec. Cor. common to Secs. 3.4,9 and 10; thence westerly along the Sec. line between Secs. 4 and 9, 1318.75 ft. to the point of beginning.

This Resolution shall take effect on the 1st day of October, 1917.

ORDINALICE NO. 121

AN CRDINANCE PROVIDING FOR THE ESTABLISHMENT OF WARDS AND THEIR BOUNDARIES, CREATING AN ELERGENCY, AND RÉPEALING ORDINANCE NO. 19 OF FIE CITY OF POLSON, LIONEANA. _..

BE IT CRDAINED BY THE CITY COUNCIL OF THE CITY OF YOUSON.

Section 1 - That the territory embraced within the corporate limits of the City of Polson, shall be and the same is hereby divided into two wards, bounded and described as hereinafter set forth;

Section 2 - All that territory within the corporate limits of the City of Polson which lies east of "4" Street shall embrace and compose Ward No. 1.

Section 3 - All that territory within the corporate limits of the City of Polson which lies west of "4" Street shall embrace and compose Ward No. 2.

Section 4 - Ordinance number Eineteen (19) of the City of Polson approved February 24th, 1911, as well as all other Ordinances or parts of Ordinances in conflict herewith are hereby repealed.

Section 5 .- Whereas emergency exists and it is inactiately necessary for the preservation, peace, health and safety of the inhabitants of the City of Polson, this Ordinance shall take effect and be in full force immediately upon its passage and approval as provided by law.
