## RESOLUTION NUMBER 24

A RESOLUTION DECLARING IT TO BE THE INTENTION OF THE CITY COUNCIL OF THE CITY OF POLSON, FLATHEAD COUNTY, MONTANA, TO CREATE SPECIAT IMPROVEMENT DISTRCIT NUMBER FOUR IN THE CITY OF POLSON, FLATHEAD COUNTY, MONTANA FOR THE PURPOSE OF GRADING THE STREETS AND CONSTRUCTING SIDEWALKS, CURBS AND GUTTERS AND MAKING CERTAIN OTHER STREET IMPROVEMENTS AS HEREIN PROVIDED AND DESCRIBED.

BE IT RESOLVED BY THE CITY COUNDIL OF THE CITY OF POLSON, MONTANA:

Section 1 - That it is the intention on the City Council to create and establish in the City of Polson, Montana, Special Improvement District for the purpose of grading the streets and constructing side-walks, curbs and gutters along all that portion of the City of Polson, Montana, including all streets, alleys and intersections within the boundaries hereinafter particularly described.

Section 2 - The said Special Improvement District shall be known and designated as as SPECIAL IMPROVEMENT DISTRICT NUMBER FOUR of the CITY OF POLSON, MONTANA.

Section 3 - The boundaries of the said Special Improvement
District Number Four of the City of Polson, Montana are hereby designated and described as follows, to-wit: 
Beginning at the point of intersection of the canter line

Beginning at the point of intersection of the canter line of the alley in block 20 and the line between lots 9 and 10 in block 20 of the Original Townsite of Polson; thence in a westerly direction pn the line between lots 9 and 10 to the center of second street; thence west in the direction of a straight line forming the center of the alley in block 21 of the Original Townsite of Polson to the point of intersection with a line parallel to the west boundry line of First Street and Fifty feet west of the said west boundry line of First Street; thence north along the said parallel line for a distance of 173 feet; thence east to the west boundry line of First Street; thence northeasterly direction to the west corner post of lot 7 block 12 Original Townsite; thence in a Northeasterly direction along the boundry line between Block 12 and the Public Park to the point of intersection with the line formingthe center line of the alley in block 12 of the Original Teeite Townsite of Polson; thence east along the center line of the alley in block 12 to the center of Second Street; thence South along the center of Second Street to the point of intersection with the line forming the boundry between lots 7 and 8 in block 13 of the Original Townsite of Polson; thence East along

the line which forms the boundry between lots 7 and 8 in block 13 to the point of intersection with the center of line of the alley in block 13; thence South along the center line of the alley in blocks 13 and 20 to the point of intersection with the line which forms the boundry between . lots 9 and 10 of block 20, the same being the point of beginning.

Section 4 - That the District included within the said boundaries is hereby declared to be the District benefited by the making of said improvements and that the property included within the boundaries of said District is hereby declared to be the property to be assessed for the cost and expense of making said improvements.

Section 5 - Said lots, pieces or parcels of land being benefited by and assessed ror the said grading and construction of the said side-walks, curbs and gutters are as follows, to-wit:

All of lots 10, 11 and 12, in block 20 Original Townsite of Polson.

All of lots 1,2,3,4,5,6,7, and 8 of block 21 Original Townsite of Polson.

All of lots 2,3,4,5nd 5 of block 12 Original Townsite of Polson.

All of lot 7 of block 13 Original Townsite of Polson. Each of the foregoing lots being of the dimensions of 50 feet in width by 140 feet in depth.

Also the following irregular shaped lots; Lot 6 of block 12 of the original Townsite of Polson being of the dimensions of 105 feet by 60 feet by 140 feet by 13.4 feet by 58.2 feet.

Lot 7 of block 12 Original Townsite of Polson being of the dimentions 140 feet by 105 feet by 175 feet.

J.L.McIntire Tract addition being of dimensions 50 feet

by 173 feet.

· All of the foregoing lots, pieces and parcels of land being located in the City of Polson, Flathead County, Montana, according to plats thereof now on file.

Section 6 - That the character of the said improvements which are to be made in said Special Improvement District Number Four of the City of Polson, Montana are as follows, to-wit:

The said improvements shall consist of grading the streets and the construction of concrete sidewalks and concrete curbs with gutters in the same streets in front of the lots or parcels of land described as being within the boundries of Special Improvement District Number Four of the City of Polson, Montana.

Section 7 - The location of the said proposed grading and concrete sidewalks and concrete curbs with gutters is as follows:

All those portions or parts of D Street, Second Street and First Street which lie within the boundries of Special Improvement District Number Four of the City of Polson, Montana and to be graded and to be put on the grade regularly adopted by the Concrete sidewalks and curbs with proper gutters are to be City Council.

constructed as follows:

On the North side of Lot 12 of Block 20 Original Townsite

On the West side of Lots 10, 11 and 12 of block 20 Original Townsite of Polson.

On the East side of Lot 1 of block 21 Original Townsite of of Polson.

On the North side of lots 1, 2, 3, 4, 5, 6, 7 and 8 of
Block 21 Original Townsite of Polson.
On the West side of lot 8 of block 21 Original Townsite of

On the West side of First Street beginning at a line corresponding to the center line of the alley in block 21 and extending north to a line corresponding to the north side of the walk on the South side of D Street.

On the South side of lots 2, 3, 4, 5, 6, and 7 of block

12 Original Townsite.

On the East side of lot 2 of block 12 Original Townsite. On the West side of lot 7 of block 13 Original Townsite. On the south side of lot 7 of block 13 Original Townsite.

Section 8 - That the entire cost and expense of the said improvements shall be assessed against all of said Special Improvement District Number Four of the City of Polson, Montana, and each lot and parcel of land within the said District shall be assessed for that part of the whole cost which its area bears to the area of the entire district, exclusive of streets, alleys, avenues and public places.

Section 9 - That the total estimate cost and expense of making the said improvements is the sum of \$6,500.00 which is to be proportioned against each each lot or parcel of land according to their area.

Section 10 - That the cost and expense of making said improvements shall be assessed and paid in the following manner, to-wit;

That the assessment levied to defray the cost of said improvements shall be extended over a period of eight years and paid in eight annual installments or payments, othe first of which shall be paid in the year 1919, deferred payments or installments shall bear interest at the rate of six per cent per annum, payable annually.

Section 11 - That warrants issued against Special Imprevement District Number Four fund, to be created for said Special Improvement District Number Four shall be issued in the payment of the cost and expense of making said improvements in the said Special Improvement District Number Four, and that such warrants shall be issued in denominations of \$100.00 or fraction or multiples thereof.

Section 12 - That the Special assessment to be levied upon and assessed against the property within said Special Improvement District Number Four to pay the cost and expense of making said improvements may be paid in installments extending over a period of eight years.

Section 13 - That at any time within fifteen days after the date of the first publication of notice of passage of the Resolution any owner of property within said District which will be 'assessed for the cost and expense of making said improvements, may make and file in the office of the City Clerk of the City of Polson, Montana, a written protest against the proposed work, or against the extent, or creation of the said District, or both, and the City Council will proceed to hear and pass upon all such protests at a regular meeting to be held on the 7th day of April, 1919, at Seven-thirty o'clock P.M. of the said day in the City of Hall of the City of Polson, Montana.
