RESOLUTION NUMBER 26

District Number 4 in the City of Polson, Montana, and stating the character of the improvements to be made and an approximate estimatemof the cost thereof, in accordance with the Resolution of Intention heretofore adopted by the Council of said City.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON? MONTANA:

Thet-th

Section 1 - That there is hereby created and established in the City of Polson, Montana, Special Improvement District No. 4 for the purpose of grading the streets and constructing side-walks, curbs and gutters along all that portion of the City of Polson, Montana, including all streets, alleys and intersections within the boundaries hereinafter particularly described.

Section 2 - The said Special Improvement District shall be known and designated as SPECIAL IMPROVEMENT DISTRICT NUMBER FOUR of the CITY OF POLSON? MONTANA.

Section 3 - The boundaries of the said Special Improvement District Number Four of the City of Polson, Montana are hereby designated and described as follows, to-wit: -

Beginning at the point of intersection of the center line of the alley in block 20 and the line between lots 9 and 10 in block 20 of the riginal Townsite of Polson; thence in a westerly direction on the line between lots 9 and 10 to the center of second street; thence west in the direction of a straight line forming the center of the alley in block 21 of the Original Townsite of Polson to the point if ubtersection with a line parallel to the west boundary line of First Street and Fifty feet west of the said west boundary line of First Street; thence north along the said parallel line for a distance of 173 feet; thence east to the west boundary line of First Street; thence northeasterly direction to the west corner post of lot 7 block 12 Original Townsite; thence in a northeasterly direction along. The boundary line between Block 12 and the Public Fark to the point of intersection with the line forming the center line off the alley in block 12 to the center of Section Street; thence South along the center of Section Street; thence South along the center of Second Street to the point of intersection with the line forming the boundary between lots 7 and 8 in block 13 of the Original Townsite of Polson; thence east along the line which forms the boundary between lots 7 and 8 in block 13 to the point of intersection with the center of line of the alley in block 13; thence south along the center line of the alley in blocks 13 and 20 to the point of intersection with the line which forms the boundary between lots 9 and 10 of block 20, the same being the point of beginning.

Section 4 - That the District included within the said boundaries is hereby declared to be the District benefited by the making of said improvements and that the property included within the boundaries of said District is hereby declared to be the property to be assessed for the cost and expense of making said improvements.

Section 5 - Said lots, pieces or parcels of land being benefited by and assessed for the said grading and construction of the said side-walks, curbs and gutters are as follows, to-wit:

All of lots 10, 11 and 12, in block 20 Original Townsite of Polson.

All of lots 1, 2, 3, 4, 5, 6, 7 and 8 of block 21 Original Townsite of Polson.

All of lots 2, 3, 4, and 5 of block 12 Original Townsite of Polson.

All of lot 7 of block 13 Original Townsite of Polson. Each of the foregoing lots being of the dimensions of 50 feet in width by 140 feet in depth.

Also the following irregular shaped lots: Lot 6 of block 12 of the Original Townsite of Polson being of the dimensions of 105 feet by $\bar{60}$ feet by 140 feet by 13.4 feet by 58.2 feet.

Lot 7 of block 12 Original Townsite of Polson being of the dimensions 140 feet by 105 feet by 175 feet.

J.L.McIntire Tract Addition being of dimensions 50 feet

by 173 feet.

All of the foregoing lots, pieces and procels of land being located in the City of Polson, Flathead County, Montana, according to plats thereof now on file.

Section 6 - That the character of the said improvements which are to be made in said Special Improvement District
Number Four of the City of Polson, Montana are as follows, to-wit:
Rhw said improvements shall consist of grading the streets

and the construction of concrete sidewalks and concrete curbs with gutters in the said streets in front of the lots or parcels of land described as being within the boundaries of Special Improvement District Number Four of the City of Polson, Montana.

Section 7 - The location of said proposed grading and concrete sidewalks and concrete curbs with gutters is as follows:

All those portions or parts of D Street, Second Street and Dirst Street which lie within the boundaries of Special Improvement District Number Four of the City of Polson, Montana and to be graded and to be put on the grad regularly adopted by the City Council.

Concrete sidewalks and curbs with proper gutters are to be constructed as follows:

On the north side of lot 12 of block 20 Driginal Townsite of Polson.

On the West side of Lots 10, 11 and 12 of block 20 Original تأليبه مد Townsite of Polson.

On the East side of Lot 1 of Block 21 Original Townsite of Polson.

On the North side of Lots 1, 2, 3, 4, 5, 6, 7 and 8 of block 21 Original Townsite of Polson.

On the west side of lot 8 of block 21 Original Townsite of Polson.

On the west side of First Street beginning at a line corresponding to the center line of the alley in block 21 and extending north to a line corresponding to the north side of the walk on the south side of D Street.

On the south side of lots 2, 3, 4, 5, 6, and 7 of block 12 Original Townsite.

On the east side of lot 2 of block 12 Original Townsite. On the west side of lot 7 of block 13 Original Townsite. On the south side of Lot 7 of block 13 Original Townsite. Section 8 - That the entire cost and expense of the said improvements shall be assessed against all of said Special Improvement District Number Four of the City of Pobson, Montana, and each lot and parcel of land within the said District shall be assessed for that part of the whole cost which its area bears to the area of the entire district, exclusive of streets, alleys, avenues and public places.

Section 9 - That the total extimate cost and expense of making the said improvements is the sum of \$6,500.00 which is to be proportioned against each lot or parcel of land according to their area.

Section 10 - That the cost and expense of making said improvements shall be assessed and paid in the following manner, to-wit:

shall be assessed and paid in the following manner, to-wit:

That the assessment levied to defray the cost of said improvements shall be extended over a period of eight years and paid in eight annual installments or payments, the first of which shall be paid in the year 1919, deferred payments or installments shall bear interest at the rate off six per cent per annum, payable annually.

Section 11 - That warrants issued against Special Improvement District Number Four fund, be created for said Special Improvement District Number Four shall be issued in the payment of the cost and expense of making said improvements in the said Special Improvement District Number Four, and that such warrants shall be issued in denominations of \$100.00 or fraction or multiples thereof.

Section 12 - That the Special assessment to be levied upon and assessed against the property within said Special Improvement District Number Four to pay the cost and expense of making said improvements may be paid in stallments extending over a period of eight years;

Section 13 - That at any time within fifteen days after the date of the first publication of notice of passage of the Resolution any owner of property within said District which will be assessed for the cost and expense of making said improvements, may make and file in the office of the City Clerk of the City of Polson, Montana, a written protest against the proposed work, or against the extenty or creation of the said District, or both, and the City Council will proceed to hear and pass upon all such protests at a regular meeting to be held on the 7th day of April, 1919, at Seven-thirty o'clock P.M. of the said day in the City Hall of the City of Polson; Montana.

A RESOLUTION DEGLARING IT TO BE THE INTENTION OF THE CITY COUNCIL OF THE CITY OF POLSON FLATHEAD COUNTY MONTANA. TO CREATE SPECIAL IMPROVEMENT DISTRICT. NUMBER 5 IN THE CITY OF POLSON FLATHEAD COUNTY, STATE OF MONTANA. FOR THE PURPOSE OF PLANTING SHADE AND ORNAMENTAL TREES IN THE PARKINGS OF THE RESEDENTIAL SECTIONS OF SAID CITY AND CONSTRUCTING GUARD FOR THE PROTECTION AS HEREIN PROVIDED AND DESCRIBED.

Be it resolved by the city council of the City of Polson Montana,.
Section-1-

That it is the intention of the city council to create and establish in the City of Polson Montana, a special improvment district for the purpose of planting trees and constructing guards to protect the same.

Section -2-

The said Special Improvement District shall be known and designated as Special Improvement District Number 5 of the City of Polson Montana.

Section-3-

The boundries of the said Special Improvement District Number 5 of the City of Polson, Montana are hereby designated and described as follows to-wit:

Beginning at the North-east corner of the Original Townsite of Polson thence due south on the east boundary line of Polson to the center line of G street, thence west on the center line of G street to the intersection of the center line of Birch Ave. thence north of E street (Riverside Addition) thence in a north-easterly direction on the center line of E street to the intersection of the center line of Maple avenue, thence East on the center line of E street to the intersection of the West bound ry line of the Original Townsite of Polson, thence N 00'17'E 412.6 feet to the Northwest corner of the Original Townsite of Polson, thence in a North-easterly direction on the meander lines of Flathead River and Flathead Lake to the point of beginning.

That the district included within the said boundaries is hereby declared to be the district benefited by the making of said improvments and that the property included withing the said boundaries of said district is hereby declared to be the property to be assessed for the cost and expense of making said improvments.
