## Supplemental Resolution No. 26A.

A SUPPLEMENTAL RESOLUTION PROVIDING FOR THE PAYMENT OF WARRANTS OF SPECIAL IMPROVEMENT DISTRICT No.FOUR OF THE CITY OF POLSON, STATE OF MONTANA, TOGETHER WITH INTEREST THEREON, AND THE LEVY OF AN ANNUAL TAX SUFFICIENT TO PAY THE INTEREST THEREON AND REDEEM ONE EIGHTH OF THE SAME EACH YEAR BEGINNING WITH THE YEAR 1921.

Be it ordained by# the Council of the City of Polson, Montana,.

Whereas, the City ######## Council of the City of Polson did pursuant to law on the 7th, day of April 1919, create Special Improvement District number 4 for the construction of certian improvements in said district.

Whereas it was determined that the payment for the said improvements should be evidenced by improvement warrants payable in eight annual installments for the date of issuance, and resolution No.26 so provided, and

Whereas, the council by said resolution No.26 decided to redeem one eighth of the said warrants in the year 1920 and one-eighth each year thereafter until the entire amount was paid, and

Whereas, the Council by said resolution No.26 did provide# for the levy of an annual tax upon all the property of the said Special Improvement District No 4 for the payment of the annual interest on said warrants, together with one-eighth of the warrants, and

Whereas, since the passage of the said resolution No.26 and award and settlement has been made with Frank Jette on account of damages sustained by him to his property to-wit Lot 2 of Block 12 by reason of the construction of said special improvements, and the said damage and award being agreed upon at \$550.00 and\$88.65 costs.

Whereas, in accordance with section 19 of the Laws of 1913 Chapter 89 Page 406, it is necessary to pass a supplemental resolution to provide for the issuance of the said warrants and the levy of the annual tax to pay the installment and interest, thereon,.

BE IT THEREFORE RESOLVED, By the Council of the City of Polson, Montana, that the City of Polson issue its Special Improvement warrants for \$638.65 drawn upon the Special Improvement District No.4 and that the City of Polson redeem one-eighth of said Special Improvement District No.4 warrants each year for the years 1921-1922-1923-1924-1925-1926-1927- and 1928 inclusive and that an annual tax be levied a and collected, as provided by law, upon all the taxable real estate in said District sufficient to pay the interest on said warrants and create a sinking fund for their redemption; and the said taxes so levied and collected shall be used in the payment of the said interest and warrants, and for no other purpose; and that said warrants be redeemed consecutively according to their numerical order, beginning with No. 77.
