

RESOLUTION No. 29

A RESOLUTION OF INTENTION TO CREATE A SPECIAL IMPROVEMENT DISTRICT, OF THE CITY OF POLSON, FLATHEAD COUNTY MONTANA, DESIGNATING THE NUMBER OF SAID DISTRICT, DEFINING THE BOUNDARIES THEREOF, STATING THE CHARACTER OF THE IMPROVEMENTS TO BE MADE, AND AN APPROXIMATE OF THE COST THEREOF.

Be it resolved by the City Council of the City of Polson, Montana, .

Section 1.

That it is the intention of the City Council of the city of Polson in Flathead County, Montana, to create a special improvement district, the boundaries of which are hereinafter described, .

Section 2.

That said special improvement district shall be known and designated as Special Improvement District No.6 of the city of Polson, Montana, .

Section 3.

That the boundaries of said Special Improvement District No 6 of the City of Polson, Montana, are hereby described as follows, The boundary lines of the corporate limits of the city of Polson, Montana, as shown by the official city record at the date of the passage of this resolution, and further described as follows; The original townsite of the City of Polson, Flathead County, Montana, and all the additions annexed t thereto, to-wit; Riverside Addition, Church Addition, City Center Addition, Elevation Heights Addition, Grandview Addition, Polson Heights Addition, Central Addition, Lewis Addition, ~~###~~ Pend O'Reille Heights Addition and Cramer's Sub-division, all of said additions are included with ~~##~~ the Original townsite of the city of Polson, Montana, and within the corporate limits of said city, and included within said Special Improvement District No. 6 together with all the acerage or tracts that may be within said corporate limits of said city, .

Section 4.

That the district included within said boundaries is hereby declared to be the district benefited by making of the improvement, and the property included within the boundaries of said district is hereby declared to be the property to be assessed for the cost and expense of making such improvement, .

Section 5.

That the character of the improvement to be made for the benefit of said Special Improvement District No.6 is as follows; The construction of a gravity water supply system and the building of a pipe line, or conduit to convey said water, from a point 71° 47' east and 1183 feet distant from the Northeast corner of Section four (4) Township twenty-two (22) North, Range nineteen (19) West N.M. to the distribution reservoir of the city of Polson, Montana, a distance of 24,840 feet, and the obtaining of an adequate supply of pure water, .

Section 6.

That the estimated cost for the making of said improvement is the sum of fifty thousand dollars (\$50,000.00)

RESOLUTION NUMBER 30

NOTICE OF THE PASSAGE OF A RESOLUTION OF INTENTION BY THE CITY COUNCIL OF THE CITY OF POLSON TO CREATE A SPECIAL IMPROVEMENT DISTRICT DESCRIBING THE GENERAL CHARACTER OF THE IMPROVEMENT PROPOSED, GIVING AN ESTIMATE OF THE COST THEREOF, AND THE TIME WHEN AND THE PLACE WHERE SAID CITY COUNCIL WILL HEAR AND PASS UPON ALL PROTESTS THAT MAY BE MADE AGAINST THE MAKING OF SAID IMPROVEMENT.

Be It Resolved by the City Council of the City of Polson, Montana;..

Section 1.

Notice is hereby given that the City Council of the City of Polson, Montana, did on the 2nd, day of Aug. 1920. pass a resolution of its intention to create a special improvement district of the entire city of Polson, which improvement district will be known and described as Special Improvement District No. 6 of the City of Polson.

Section 2.

That the general character of the improvement to be made for the benefit of said Special Improvement District No. 6 of the City of Polson is hereby declared to be the construction, laying and installing of a gravity water supply system and the building of a pipe line to convey said water from a point 71° 47' east and 1183 feet distant from the Northeast corner of Section four in Township twenty-two North, Range nineteen West M.M. to the distribution reservoir of the city of Polson, Montana, a distance of 24,840 feet, and the obtaining of an adequate supply of pure mountain water,.

Section 3.

That the estimated cost for the making and installing of said improvement is the sum of fifty thousand dollars (\$50,000.00).

Section 4.

That the City Council of Polson, Montana, will be in session at the Council Chamber in the City Hall of the City of Polson on the 30th, day of August 1920, at eight o'clock P.M. of said day, at which time and place it will hear and consider all objections to the creation of said special improvement district,. That at any time between the passage of this resolution and the 30th, day of August 1920.
