---RESOLUTION NUMBER 31---

A RESOLUTION ESTABLISHING AND CREATING SPECIAL SEWER IMPROVEMENT DISTRICT NUMBER 3 IN THE CITY OF POLSON COUNTY OF FLATHEAD AND STATE OF MONTANA, FOR THE PURPOSE OF CONSTRUCTING SEWERS IN SAID DISTRICT, DESCRIBING THE BOUNDARIES THEREOF AND THE PROPERTY TO BE ASSESSED?.

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF POLSON MONTANA: WHEREAS, the City Council of the City of Polson on the 6th, day of July A.D. 1920 duly and regularly passed and adopted Resolution No. 28 of the said City of Polson declaring its intention to create Special Sewer Improvement District Number 3 of the City of Polson: and

Whereas, pursuant to the said Resolution the said City Council caused notice of the passage and adoption of said Resolution to be published in the Flathead Courier, a weekly newspaper published in the City of Polson, in the issues of said paper of July 8th and 15th, 1920, and for a period of more than 15 days immediately preceding the 26th, day of July 1920. and

Whereas, the said City Council caused notice of the passage and adoption of said Resolution, together with copy of said Resolution, to be posted by the City Clerk thruout the City on the 8th, day of July 1920, at three of the most public places within the City, to-wit one in the Post Office, one in the office of City Treasurer, and one in the office of the City Clerk: and

Whereas, pursuant to the said Resolution No. 28 the City Clerk of the City of Polson did on the 8th, day of July 1920. the same being the same day that said notice was first published in the Flathead Courier, mail to each and every person, firm or corporation, or agent of such person, firm or corporation, having property within the said proposed District, and directed to the last known address of said person, firm, corporation or agent, a notice of the passage and adoption of said Resolution of the intention to create Special Sewer Improvement District Number 3 of said City: and

Whereas, said notice was published, posted and mailed as aforesaid, describing the general character of the improvement proposed to be made in said District, the estimated cost thereof, and designating the time when and the place where, said Council of the City of Polson would hear and pass upon all protests made against the making of said improvement, or the creating of said district, and which said notice refers to said Resolution No. 28 on file in the office of the City Clerk, for a description of the boundaries of said Special Sewer Improvement District Number 3, and for plans specifications and details thereof: and

Whereas, the City Council of the City of Polson has met in regular session at the time and place fixed and set by said Resolution, and the aforesaid notice, for the hearing of the protests against the making of said proposed improvement, and the creation of said proposed district and have heard and fully considered all such protests:

NOW THEREFORE, Be it resolved by the City Council of the City of Polson, Montana, that the City Council having heard and passed upon all protests made and delivered to the City Clerk of the City Council of the City of Polson, against the making of said proposed improvement and against the extent and creation of the proposed district within the time specified and provided in Resolution No. 28, and finding said protests to be insufficient, and that the protests are not made by the owners of more than one half of the area of the property to be assessed for said improvement,

and said protests are hereby overruled and denied,.

That there be, and there is, hereby created the said Special Improvement District to be known and designated as Special Sewer Improvement District Number 3 of the City of Polson, Montana, in accordance with Resolution No. 28 of its intention heretofore introduced and passed by the City Council; that the character of said improvements to be made in said Special Sewer Improvement District Number 3 is described as follows,.

The said improvements which are to be made in said Special Sewer Improvement District Number 3 are as follows, the said improvement shall consist of a combination domestic and storm gravity Sewer, said untreated sewage to be discharged into the Flathead River at the north end of Birch Ave. In the construction of said system circular vitrified pipe ranging in size from six to ten inches in diameter, inside measure, will be employed,.

Said proposed system to be provided with flush tanks, catchment basins, man holes, lamp holes, and any further necessary appliances, fittings or structures that may be required to insure proper operation and maintenance. The construction of this system will require the placing of approximately the following amount of circular vitrified pipe and the following number of man holes, flush tanks, lamp holes, and catchment basins,.

966 lineal feet of 10' inch vit pipe
 1773 lineal feet of 8 inch vit pipe
 180 lineal feet of 6 inch vit pipe
 60 lineal feet of 10 inch rev. steel pipe.
 2 flush tanks
 7 man holes
 3 lamp holes
 6 catchment basins,.

That the location of said proposed sewer is along the streets, alleys, avenues and public places of the City of Polson, Montana, as follows, to-wit;

Beginning at the intersection of the center line of F street with the center line of alley extending North and South through Blocks 2 and 6; thence in a westerly direction along the center line of F street 796 feet to the intersection of the center line of Birch Avenue; thence north along the center line of Birch avenue, and on said center line produced, 230 feet to a point in Flathead River, -and

Beginning at the intersection of the center line of the alley (running north and south through Blocks 2 and 6) with the north property line of lots 1 and 12, Block 2; thence south along center line of said alley 680 feet to the intersection of the South property line of Lots 6 and 7 Block 6, - and

Beginning at the intersection of the center line of the alley (running north and south through block 5) with the South property line of lots 6 and 7 Block 5; thence north along the center line of said alley 340 feet to the intersection of the center line of "F" street, -- and

Beginning at the intersection of the center line of the alley (running North and South through Block 4) with the south property line of Lots 6 and 7 Block 4; thence North along the center line of said alley 340 feet to the intersection of the center line of " F " street; and

Beginning at the intersection of the center line of the alley (running in a Southwesterly direction through Block 3) with the east property line of Lots 1 and 16, Block 3; thence in a Southwesterly direction along the center line of said alley 413 ft. to the intersection of the center line of " F " Street, .

The boundaries of the said Special Sewer Improvement District number 3 shall be, and the same are hereby declared to be, the same as described in Resolution No. 28 to which reference is hereby made for a particular description thereof,;

Said lots peices or parcels of land being benefitted by and assessed for the construction of said sewer are as follows, to-wit;

Lots 1-2-3-4-5-6-7-8-9-10-11-12- of Block 2
 Lots 1-2-3-4-5-6-7-8-9-10-11-12- of Block 5
 Lots 1-2-3-4-5-6-7-8-9-10-11-12- of Block 6

Each of the foregoing lots being of the dimensions of Fifty feet in width by One Hundred and Forty feet deep.

Also the following lots.

Lots 1-2-3-4-5-6-7-8-9-10-11-12- of Block 4.

Each of the foregoing lots being of the dimensions of Fifty feet in width by Ninety Seven and One half feet deep.

Also the following irregular shaped lots;.

Lots 1-2-3-4-5- and 6 of Block 3, being of the dimensions of 50 ft. by 54.55 ft. by 140 ft.

Lot 7, Block 3, being of the dimension of 60 ft by 65.5 ft. by 134.5 ft by 140 ft.

Lot 8, Block 3, being of the dimension of 50 ft. by 54.55 ft. 111.3 ft by 134.5 ft.

Lot 9 Block 3, being of the dimension of 50 ft. by 54.55 ft. by 111.3 ft by 134.5 ft.

Lot 10, Block 3 being of the dimension of 60 ft. by 62.9 ft. by 65.5 ft. by 89.3 ft.

Lot 11, Block 3 being of the dimension of 40 ft. by 51.7 ft. by 56.09 ft. by 62.9 ft.

Lot 12 Block 3 being of the dimension of 39.7 ft. by 60 ft. by 63.2 ft.

Lot 13 Block 3 being of the dimension of 39.7 ft. by 59 ft. by 60 ft. by 65.5 ft.

Lot 14, Block 3 being of the dimensions of 50 ft. by 54.55 ft. by 59 ft. by 83.8 ft.

Lot 15 Block 3 being of the dimension of 50 ft. by 54.55 ft. by 83.8 ft. by 108 ft.

Lot 16 Block 3 being of the dimension of 50 ft. by 54.55 ft. by 108 ft. by 132.7 ft.

All of the foregoing Blocks and lots being located in the Riverside Addition to the City of Polson, Flathead County, Montana,.

That reference to Resolution No. 28 is hereby made for further particulars;

That it is hereby ordered and directed that said improvements be made in said Special Improvement District No. 3 in accordance with the plans and specifications thereof now on file in the office of the City Clerk of the City of Polson,.

That the entire cost and expense of said improvement shall be assessed against all of said Special Improvement Sewer District Number 3 and each lot and parcel of land within said district shall be assessed for that part of the whole cost which its area bears to the area of the entire district, exclusive of streets, alleys, avenues and public places,.

That the estimated cost and expense of making said improvement is the sum of \$117.00 per lot for each lot 50 feet in width by 140 feet in depth, and other lots in proportion thereto according to their area; that the total estimated cost of making said improvement is \$6,669.00.

That the cost and expense of making said improvements shall be assessed and paid in the following manner to-wit; that the assessment levied to defray the cost of said improvements shall be extended over a period of eight years, and paid in eight annual installments or payments, the first of which shall be paid in the year 1921, deferred payments or installments shall bear interest at the rate of six per cent per annum payable annually,.

That warrants issued against Special Sewer Improvement District Number 3 fund, to be created for said Special Sewer Improvement District Number 3 shall be issued in the payment of the costs and expense of making said improvements in said Special Sewer Improvement District Number 3, and that such warrants shall be issued in denominations of \$100.00 or fraction or multiples thereof,.

That the special assessment to be levied upon and assessed against the property within the said Special Sewer Improvement District Number 3, to pay the cost and expense of making said improvement, may be paid in installments extending over a period of eight years,.



Resolution Number 32.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, CREATING SPECIAL IMPROVEMENT DISTRICT NO. 6 PROVIDING THE MANNER OF PAYMENT FOR THE WORK, ADOPTING THE PLANS AND SPECIFICATIONS PREPARED BY THE CITY ENGINEER, AND DIRECTING THE CITY CLERK TO CAUSE A NOTICE TO BE PUBLISHED IN THE MANNER PROVIDED BY LAW INVITING BIDS OR PROPOSALS FOR THE CONSTRUCTION OF SAID IMPROVE*MENT PROPOSED TO BE MADE IN SAID SPECIAL IMPROVEMENT DISTRICT.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

WHEREAS, Resolution No. 29 of the City of Polson was duly passed by the City Council on the 2nd, day of August, 1920, and approved by the Mayor on said date declaring the intention of said City to create Special Improvement District No. 6 for the purpose of constructing the improvement as outlined in said resolution, and;

WHEREAS notice of the passage of said resolution of intention No. 29 was duly and properly given to the property owners of said Special Improvement District in the manner and form as required by law, and by publication in the Flathead Courier, a weekly newspaper published in the city of Polson, and;

WHEREAS the time limit by law, to-wit; fifteen days after the date of the first publication of said notice of the passage of said resolution of intention No. 30 has previously expired, and there being no protests made or filed with the City Clerk of the City of Polson in the time prescribed by law; and,

WHEREAS said Resolution of Intention No. 30 appointing the 30th, day of August, 1920, at eight o'clock P.M. of said day at the Council Chambers in the City Hall as being the time and place for hearing of protests, and,

WHEREAS a quorum for the transaction of business was then and there present as appears by the minutes of said meeting; and,

WHEREAS no persons appeared at said meeting for the purpose of protesting against the creation of said district and but one written protest by the owner of two lots being filed; and,

WHEREAS the City Council has acquired jurisdiction to create said Improvement District No. 6,

NOW, THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, .
