A RESOLUTION OF THE CITY COULCIL OF THE CITY OF POLSON, MONTANA, CREATING SPECIAL IMPROVEMENT DISTRICT NO. 6 PROVIDING THE MANNER OF PAYMENT FOR THE WORK, ADOPTING THE PLANS AND SPECIFICATIONS PREPARED BY THE CITY ENGINEER, AND DIRECTING THE CITY CLERK TO CAUSE A NOTICE TO BE PUBLISHED IN THE MANNER PROVIDED BY LAW INVITING BIDS OR PROPOSALS FOR THE CONSTRUCTION OF SAID IMPROVE* - MENT PROPOSED TO BE MADE IN SAID SPECIAL IMPROVEMENT DISTRICT.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON? MONTANA:

WHEREAS, Resolution No. 29 of the City of Polson was duly passed by the City Council on the 2nd, day of August, 1920 and approved by the Mayor on said date declaring the intention of said City to create Special Improvement District No.6 for the purpose of constructing the improvement as outlined in said resolution, and;

WHEREAS notice of the passage of said resolution of intention No. 29 was duly and properly given to the property owners of said Special Improvement District in the manner and form as required by law, and by publication in the Flathead Courier, a weekly newspaper published in the city of Polson, and;

WHEREAS the time limit by law, to-wit; fifteen days after the date of the first publication of said notice of the passage of said resolution of intention No. 30 has previously expired, and there being no protests made or filed with the City Clerk of the City of Polson in the time prescribed by law; and,

WHEREAS said Resolution of Intention No.30 appointing the 30th, day of August, 1920, at eight o'clock P.M. of said day at the Council Chambers in the City Hall as being the time and place for hearing of protests, and,

WHEREAS a quorum for the transaction of business was then and there present as appears by the minutes of said meeting; and,

WHEREAS no persons appeared at said meeting for the purpose of protesting against the creation of said district and but one written protest by the owner of two lots being filed; and,

WHEREAS the City Council has acquired jurisdiction to create said Improvement District No.6,

NOW THEREFORE BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA,.

Section 1.

That Special Improvement District No.6 referred to in Resolution No. 29 be and is hereby created with the boundaries and for the purpose of doing the work set forth in said resolution No. 29. reference to which is hereby made for further particulars as to the boundaries and improvements and all things therein contained.

Section 2,

That the whole cost and expense incurred in the construction of the improvement proposed to be made in said Special Improvement District No.6 shall be paid for by Special Improvement District No.6 fund hereby created for said Special Improvement District No.6, and the whole cost of said improvement to be assessed against the entire district, each lot or parcel of land within said district to be assessed that part of the whole cost of said work which its area bears to the area of the entire district, exclusive of streets, alleys, and public places, said assessment to be spread over a period of fifteen years and payable in fifteen equal installments with interest at the rate of six per cent per annum,.

Section 3.

That said Special Improvement District bonds shall be drawn substantially in accordance with Section 3389 of the Revised Code..

Section 4. That the City Clerk of the City of Polson is hereby directed to cause to be printed and published in the Flathead Courier a weekly newspaper published in the city of Polson, in the manner prescribed by law a notice inviting bids for the construction of the improvement proposed to be made in said Special Improvement District No.6 which said notice shall refer to the specifications of the proposed improved omprovement on file in the office of the City Clerk.
