A resolution declaring it to be the intention of the City Council of the City of Polson, Flathead County, Montana to create a Special Sewer Improvement District Number 4 in the City of Polson, Flathead County, Montana for the purpose of constructing sewers as herein provided and described.

Be it resolved by the City Council of the City of Polson,

Section 1

That it is the intention of the City Council to create and establish in the city of Polson, Montana, a Special Improvement District for the purpose of making and constructing sewers along all that portion of the City of Polson, Montana, including all streets, alleys and intersections with the boundaries hereinafter particularly described.

Section 2.

The said Special Improvement District shall be known and designated as Special Sewer Improvement District No. 4 of the City of Polson, Montana.

Section 3.

The boundari's of said Special Sewer Improvement District No. 4 of the City of Polson, Montana are hereby designated and described

as follows, to wit:-

Beginning at the intersection of the center line of "G" street and Hawthorne Avenue; thence in a northerly direction on the center line of Hawthorne Avenue 747 feet to the intersection of the center line of "E" street; thence in a westerly direction on the center line of "E" Street 360 feet to the intersection of the center line of Maple Avenue; thence in a southerly direction on the center line of "G" street; thence in an easterly direction on the center line of "G" street; thence in an easterly direction on the center line of "G" street 360 feet to the intersection of the center line of Hawthorne Avenue, the same being the point of beginning.

Section 4

That the District included within said boundaries is hereby declared to be the District benefited by the making of said improvements and that the property included within the boundaries of said District is hereby declared to be the property to be assessed for the cost and expenses of making said improvements

Section 5

Said lots being benefited by and assessed for the construction of said sewers are as follows to wit:Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and 12 of Block 2; Lots 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11 and 12 of Block 6; each of the foregoing lots being of the dimension of 50 feet in width by 140 feet deep and all of the foregoing lots and blocks being located in the Riverside Addition to the City of Polson, Flathcad County,

Section 6.

That the character of the said improvements which are to be made in said Special Sewer Improvement District No. 4 are as follows, to wit: The said improvement shall consist of a Combination Domestic and Storm, Gravity Sewer; said untreated sewage to be discharged into Sewer No. 1 on the center line of "E" street, halfway between Hawthorne avenue and First Street. In the construction of said system an eight inch circular vitrified pipe inside measure shall be used.

Section 7.

The location of said sewer is as follows:-

Beginning at the intersection of the center line of the alley (running north and south through blocks 2 and 6) with the south property line of lots 6 and 7 block 6; thence north along the center line of said alley 720 feet to the center line of "E" street; thence east on the center line of "E" street 680 feet to a point in Sewer No. 1.

Said proposed system to be provided with flush tanks, catchment basins, man holes, lamp holes and any further necessary appliances fittings or structures that may be required to insure proper operation and maintenance. The approximate quantities are as follows:

1400 linear feet of 8 inch vit. pipe.

1 flush tank. 2 man holes.

Section 8.

That the entire cost and expense of said improvement shall be assessed against all of said Special Sewer Improvement District No. 4 and each lot or parcel of land within said district shall be assessed for that part of the whole cost which its area bears to the area of the entire district, exclusive of streets, alleys, avenues and public places.

Section 9.

That the estimated cost and expense of making said improvement is the sum of \$100.00 per lot and that the total estimated cost of making said improvement is \$2400.00.

Section 10.

That the cost and expense of making said improvement shall be assessed and paid in the following manner, to wit:-

That the assessment levied to defray the cost of said improvement shall be extended over a period of eight years and paid in eight annualminstallments or payments, the first of which shall be paid in the year 1922. Deferred payments or installments shall bear interest at the rate of six per cent per annum, payable annually.

Section 11.

That warrants issued against Special Sewer Improvement Diistrict No. 4 fund to be created for said Special Sewer Improvement District No. 4 shall be issued in the payment of the costs and expense of making said improvements in said Special Sewer Improvement District No. 4 and that such warrants shall be issued in denominations of \$100.00 or fraction or multiples thereof.

Section 12. That the Special Assessment to be levied upon and assessed against the property within said Special Sewer Improvement District No. 4 to pay the cost and expense of making said improvement may be paid in installments extending over a period of eight years.

Section 13.

That at any time within fifteen days after the date of the first publication of notice of the passage of this Resolution, any owner of property within said District which will be assessed for the cost and expense of making said improvement, may make and file in the office of the city clerk of the city of Polson, Montana, a written protest against the proposed work or against the extent of creation of said district, or both, and that the city council will proceed to hear and pass upon all such protests at a regular meeting thereof to be held on the 7th day of November, 1921 at 8 o'clock P.M. of said day in the City Hall of the City of Polson, Montana.
