RESOLUTION NO. 40

A RESOLUTION OF THE COUNCIL OF THE CITY OF POLSON, MONTANA? levying and assessing a tax upon all real estate in Special Sewer Improvement District No. 5 in the City of Polson, to defray the cost of the improvements in said Special Sewer Improvement District.

THAT, WHEREAS, the council of the city of Polson, Montana, did, on or about the 22nd day of Sept. 1922, create a Special Sewer Improvement District No. 5, by a resolution duly passed upon said date, reference to which resolution is hereby made, and did thereafter order and cause to be made therein the following improvements, to wit- the construction of a sewer along the alleys running through Blocks 2 and 3 in the Lewis Addition and Blocks 4 and 5 in the Riverside Addition to the City of Polson.

WHEREAS, the council did thereafter cause the said improvements to be constructed as provided for in said resolution above mentioned all of which work has been fully performed

and completed at a total expense of \$3,726.88,
WHEREAS, the property in said Special Sewer Improvement District No. 5 is to be assessed to defray the expenses of said improvement, each lot and parcel of land to be assessed for that part of the whole cost which its area bears to the area the entire district, exclusive of streets, alleys and public places, and

WHEREAS, the council has and does hereby find, fix and determine that each and every said several lots or parcels of land within said improvement district has been specially benefited by said improvements.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF POLSON, MONTANA,

That to defray the cost and expense of constructing said improvements in Special Sewer Improvement District No. 5 there be and there is hereby levied and assessed a tax upon the property in said Special Sewer Improvement District No. 5 amounting to the sum of \$3,726.88; that the description of each lot or parcel of land within said Special Sewer Improvement District which is hereby levied upon and assessed with the name of the owner and the amount of each partial payment, the date when same becomes due and the amount assessed against each lot or parcel of land in said Special Sewer Improvement District No. 5 is set forth in the Special Improvement District Warrant and Assessment Records in the office of the City Clerk, to which reference is hereby made and which is made a part of this Resolution.

And be it further resolved by the Council of the City of

Polson, Montana.

That the council of said city will be in session at the City Hall in the City of Polson, Montana, on Monday the 19th day of March, 1923 at 8 o'clock P.M. on said day, at which time and place the said city council will hear objections to the final adoption of this resolution.

That the clerk be and he is hereby authorized and directed to publish at least once in a newspaper published in the city of Polson, Montana, a notice signed by the clerk stating that this Resolution levying the special assessment to defray the cost of said improvements is on file in his office, subject to inspection for a period of five days; that said notice shall state the time and place at which objection to the final adoption of this resolution will be heard by the council and that said notice shall be published at least five days before the time set by the council for hearing objections to the final adoption of this resolution.

Passed by the council and approved by the Mayor this 5th day of March, 1923.

of Polson, Montana and which is made a part of this Resolution and to which reference is hereby made.
