

RESOLUTION NO. 42

WHEREAS, the City Council of the City of Polson, on the 5th day of June, 1923, duly and regularly passed and adopted a resolution declaring it to be to the best interest to the City of Polson and of the inhabitants of the hereinafter described platted tract and parcel of land, that the boundaries of the said City be extended so as to include within the Corporate Limits the said platted tract and parcel of land, and

WHEREAS, the City Council caused to be published in the Flathead Courier, a paper nearest to the said platted tract and parcel of land, once a week for two successive weeks, a notice to the effect that said resolution had been duly and regularly passed and that for a period of twenty (20) days from the first publication of said notice, the City Clerk would receive expressions of approval or disapproval in writing, of the proposed extension of the boundaries of said City, from the resident freeholders of the territory proposed to be embraced therein, and

WHEREAS, The City Clerk has laid before the City Council all the communications received by her relative to the said proposed extensions of the boundaries and the City Council after considering the same, deems that the boundaries should be extended, and the said resolution should be passed: - BE IT THEREFORE

RESOLVED, That the boundaries of the City of Polson, Montana, shall be extended so as to embrace and include the said platted tract and parcel of land, which is bounded and described as follows, to-wit:-

All of Lot No. Five (5) of Section No. Three (3) in Township No. Twenty-two (22) North, Range Twenty (20) West of the M. M. Montana, Containing Twenty-three and 23/100 (23.23) acres, as shown by the supplemental plat of Lot No. Four (4) of said Section Three (3) approved August 18th A. D. 1915 by the U. S. Surveyor General's Office at Helena, Montana, and filed with the U. S. Land Office at Kalispell, Montana on October 15th, 1915, and commonly known as LAKE SHORE ADDITION TO THE CITY OF POLSON, MONTANA.

This Resolution shall take effect on the 2nd day of July, 1923.
