A RESOLUTION GRANTING PERMISSION TO THE MOUNTAIN STATES POWER COMPANY TO ERECT POLES, EXCAVATE CONDUITS, STRING WIRES AND MAINTAIN THEM FOR TELEPHONE PURPOSES ON THE STREETS, ALLEYS, AVENUES, HIGHWAYS, PUBLIC PARKS AND PUBLIC PLACES IN THE CITY OF POLSON.

BE IT RESOLVED by the City Council of the City of Polson that;

WHEREAS, the Mountain States Power Company have made application to this body for a permit to erect its poles, excavate conduits, string wires and maintain them for telephone purposes, on the streets, alleys, avenues, highways, public parks and public places in the City of Polson in accordance with the Laws of the State of Montana and Ordinances of the City of Polson, regulating the same, and

WHEREAS, the said company has filed its plat of its proposed line together with the approximate location of the poles and conduits, and

WHEREAS, the said company agrees to place their poles as near the property line as practicable and at such places in the alleys, streets, avenues, highways and public places so as to interfere as little as possible with private property or public travel, and

WHEREAS, the said company has agreed to save the said City harmless on account of excavations or falling or poles, and

WHEREAS, the said Company is desirous of beginning the immediate construction of said line,

BE IT THEREFORE RESOLVED, that a permit be and is hereby granted the Mountain States Power Company, a corporation, its successors and assigns, in accordance with its said petition, to erect and maintain poles and conduits in the streets and alleys, avenues, highways and public places of the City of Polson, Montana and its additions thereto, and string wires thereon, also to lay underground wires and conduits for telephone purposes in providing a means of communication between the inhabitants thereof, and elsewhere through a central switchboard be-longing to said Mountain States Power Company or its successors and assigns; also, the right to operate, maintain, repair and extend said system as applicant shall deem best; provided, however that said company shall use poles of customary height and interfere as little as possible with other lines now constructed; and provided further, that the location of all present and future poles and conduits shall be subject to the approval of the City Council or in emergency, by either the Mayor or City Clerk of said City.
