RESOLUTION NO. 45

A RESOLUTION DECLARING IT TO BE THE INTENTION OF THE CITY COUNCIL
OF THE CITY OF POLSON, LAKE COUNTY, MONTANA, TO CREATE A SPECIAL
SEWER IMPROVEMENT DISTRICT NO. 6 IN THE CITY OF POLSON, LAKE COUNTY,
MONTANA, FOR THE PURPOSE OF CONSTRUCTING SEWERS AS HEREIN PROVIDED
AND DESCRIBED.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA/

That it is the intention of the city council of the City of Polson, Montana, to create and establish in the city of Polson, a special improvement district for the purpose of making and constructing sewers along all that portion of the city of polson, Montana, including all streets and alleys and intersections within the boundaries hereinafter particularly described.

Section 11.

That said special improvements district shall be known and designated as Special Sewer Improvement District No. 6 of the city of Polson, Montana.

Section III.

The boundaries of said Special Sewer Improvement District
No. 6 of the city of Polson, Montana are hereby designated and
described as follows, to wit: All of Cramer's Sub-Division to the
city of Polson except Block One in said Sub-Division, and all of
Lake Shore Addition to the city of Polson except the North Half of
Block One of Lake Shore Addition to the city of Polson, more particularly described as follows:

Commencing at the northwest west corner of Block 2 in Cramer's Sub-Division to the city of Polson, Montana; thence east along the center of "C" street to the point where the same intersects with the center of Lake Street; thence in a southeasterly direction to the center line of 10th and Lake Streets; thence south on the center line of 10th street to the alley running through Block 1 in Lake Shore Addition to the city of Polson; thence east to the northeast corner of the South Half of Block 1; thence due south to "G" street; thence due west on "G" street to the south west corner of Block 9 in Cramer's Sub-Division to the city of Polson; thence due north on 7th street to place of beginning.

Section 1V.

That the district included within said boundaries is hereby declared to be the district benefited by the making of said improvements and that the property included within the boundaries of said district is hereby declared to be the property to be assessed for the cost and expenses of making said improvements.

Section V.

Said lots benefited by and assessed for the construction of said sewers are as follows, to wit: - Lots 1 to 12 inclusive in Block 2; Lots 1 to 12 inclusive in Block 3; Lots 1 to 12 inclusive in Block 5; Lots 1 to 12 inclusive in Block 5; Lots 1 to 12 inclusive in Block 6; Lots 1 to 12 inclusive in Block 7; Lots 1 to 12 inclusive in Block 8 and Lots 1 to 12 inclusive in Block 9, all in Cramer's Sub-Division to the city of Polson, in Block 9, all in Cramer's Sub-Division to the city of Polson, Montana. in accordance with the plat thereof on file and of record with the Clerk and Recorder of Lake County. Also Lots, 4, 5, 6, and 7 of Block 1 in Lake Shore Addition to the city of Polson; Lots 1 to 12 inclusive in Block 2; Lots 1 to 12 inclusive in Block 5; Lots 1 to 12 inclusive in Block 6; Lots 1 to 8 inclusive in Block 7; Lots 1 to 12 inclusive in Block 8; Lots 1 to 12 inclusive in Block 11; Lots 1 to 8 inclusive in Block 12; Lots 1 and 2 of Block 10, all in Lake Shore Addition to the City of Polson, Montana in accordance with the plat thereof on file and of record with the Clerk and Recorder of Lake County, Montana.

Section 6.

That the character of said improvements which are to be made in said Special Sewer Improvement District No. 6 are as follows, to wit: The construction of a disposal plant consisting of settling, septic and chlorination tanks and the discharge of the chlorinated effluent into the lake at a point approximately 600 feet notheast of the northeast corner of the proposed district. This chlorination treatment deoderizes as well as sterilizes the effluent. The said improvement consists of a combination domestic

and gravity sewer to be discharged into the septic tank described herein.

Section 7.

The location of said sewer is as follows: - Commencing at the intersection of center line of 10th street and center line of alleys through Block 11 and 12 in Lake Shore Addition to the city of Polson; thence north on 10th street to intersection of center line of alley through Blocks 1 and 2 of said Lake Shore Addition to the city of Polson; thence in an easterly direction 846 feet to disposal plant. Said trubk line sewer to be 10 inches in diameter and service laterals extending through all alleys of Cramer's Subdivision and Lake Shore Addition to the city of Polson, said service laterals to be 8 inches in diameter.

Section 8.

That the entire cost and expense of said improvement shall be assessed against all of said Special Sewer Improvement District No. 6 and each lot or parcel of land within said district shall be assessed for that part of the whole cost which its area bears to the area of the entire district, exclusive of streets, alleys, avenues and public places.

Section 9.

That the estimated cost and expense of making said improvement is the sum of \$82.55 per lot and that the total estimated cost of making said improvement is \$14,199.56

Section 10.

That the cost and expense of making said improvements shall be assessed and paid in the following manner to wit:—
That the assessment levied to defray the cost of said improvement shall be extended over a period of eight years and paid in eight annual installments or payments, the first of which shall be paid in the year 1929. Deferred payments or installments shall bear interest at the rate of 6 per cent per annum, payable annually.

Section 11.

That warrants issued against said Special Sewer Improvement District No. 6 fund to be created for said Special Sewer Improvement District No. 6 shall be issued in the payment of the cost and expense of making said improvements in said Special Sewer Improvement District No. 6 and that such warrants shall be issued in denominations of \$100.00 or a fraction or a multiple thereof.

Section 12.

That the special assessment to be levied upon and assessed against the property within said Special Sewer Improvement District No. 6 to pay the cost and expense of making said improvements, may be paid in installments extending over a period of eight years. Section 13.

That at any time within 15 days after the date of the first publication of notice of the passage of this resolution, any owner of property withinsaid district which shall be assessed for the cost and expense of making said improvement, may make and file in the office of the City Clerk of the city of Polson, Montana a written protest against the proposed work or against the extent of the creation of said district, or both, and that the City Council will proceed to hear and pass upon all such protests at a regular meeting thereof to be held on the 18th day of June 1928 at 8 o'clock P.M. of said day in the City Hall of the city of Polson, Montana.
