RESOLUTION NO. 46

RESOLUTION CREATING AN OIL SPRINKLING DISTRICT TO BE KNOWN AND DESIGNATED AS OIL SPRINKLING DISTRICT NO. 1, DEFINING THE BOUNDARIES OF SAID DISTRICT, AND GIVING THE AREA THEREIN AND THE PROPERTY AFFECTED THEREBY.

Sec. 1
BE IT RESOLVED by the City Council of the City of Polson,
Montana, that an Oil Sprinkling District to be known and
designated as Oil Sprinkling District No. 1, is hereby
created.

Sec. 2. That the boundaries of said oil sprinkling district and the area embraced therein and the property to be assessed therefor and the streets to be sprinkled under this resolution border upon the following described lots and blocks in said city: Lots 1,2,3 in Block 4; Lots 1,2,3,4,5,6,7,8, and 9 of Block 5; Lot 2 Block 3; Lot 8 Block 2; Lots 4,5,6,7,8,9 of Block 6; Lots 1,2,3,4,5,6 Block 11; Lots 1,2,3,4,5,6,7,8,9,10,11 and 12 of Block 10; Lots 4,5,6,7,8,9 of Block 9; Lots 1,2,3,4,5,6,of Block 13; Lots 1,2,3,4,5,6,7,8,9,10,11 and 12 of Block 14; Lots 4,5,6,7,8,9,10,11 and 12 of Block 15; Lots 7,8,9,10,11 and 12 of Block 16; Lots 1,2,3,4,5,6, Block 17; North and west sides of Block 18 and 150 feet on south side of Block 18; Lots 1,2,3,4,5,6,7,8,9,10,11 and 12 Block 19; Lots 1,2,3,4,5,6,Block 20; Lots 1,2,3 and 12 of Block 23; Lots 1,2,3,4,5,6,7 and 12 of Block 24; Lots 4,5,6,and 7 Block 25; all in the original townsite of the city of Polson, Lake County, Montana.

Sec. 3. That the district including the property above described is hereby declared to be the district benefited by the oiling of said streets, alleys and public places and is hereby declared to be the property to be assessed for the cost and expense thereof. That the property to be assessed for sessed for the same is all set out in section 2 hereof.

Sec. 4. That the method of paying for said work shall be 50 % on area and 50% on linear basis.
