RESOLUTION NO.50

A Resolution declaring it to be the intention of the city council of the city of Polson, Lake County, Montana to create a Special Sewer Improvement District No. 7 in the city of Polson, Lake County, Montana, describing the general character of the proposed improvement, giving an estimate of the cost thereof and the time when and the place where said city council will hear and pass upon all protests that may be made against the making of said improvement.

Be it resolved by the City Council of the city of Polson, Lake County; Montana.

Section 1. That it is the intention of the city council of the city of Polson, Montana to create and establish in said city of Polson, a special sew er improvement district for the purpose of constructing and establishing sewers along all that portion of the city of Polson, Montana, including all streets and alleys and intersections within the boundaries hereinafter particularly described.

Section 2. That said special sewer improvement district shall be known and designated as Special Sewer Improvement District No. 7 of the City of Polson, Montana.

Section 3. That the boundaries of said Special Sewer Improvement District No. 7 of the City of Polson, Montana are hereby designated and described as follows to wit:

All of Cramer's Sub-Division to the City of Polson, except Block One (1) in said Sub-Division, and all of Lake Shore Addition to the city of Polson, except the North Half of Block One (1) of Lake Shore Addition to the City of Polson.

That the district included within said boun-Section 4. daries is hereby declared to be the district benefited by the making of said improvements and that the property included within the boundaries of said district is hereby declared to be the property to be assessed for the cost and expenses of making said improvement Section 5. Said lots benefited by and assessed for the construction of said sewers are as follows to wit -Lots 1 to 12 inclusive in Block 2; Lots 1 to 12 inclusive in Block 3; Lots 1 to 12 inclusive in Block 4; Lots 1 to 12 inclusive in Block 5; Lots 1 to 12 inclusive in Block 6; Lots 1 to 12 inclusive in Block 7; Lots 1 to 12 inclusive in Block 8 and Lots 1 to 12 inclusive in Block 9, all in Cramer's Sub-Division to the City of Polson, Montana, in accordance with the plat thereof on file and of record with the Clerk and Recorder of Lake County. Also Lots 4,5,6 and 7 of Block 1 in Lake Shore Addition to the city of Polson; Lots 1 to 12 inclusive in Block 2; Lots 1 to 12 inclusive in Block 5; Lots 1 to 8 inclusive in Block 6; Lots 1 to 8 inclusive in Block 7; Lots 1 to 12 inclusive in Block 8; Lots 1 to 12 inclusive in Block 11; Lots 1 to 8 inclusive in Block 12; Lots 1 and 2 of Block 3; Lots 1 and 2 of Block 4; Lots 1 and 2 of Block 9, and Lots 1 and 2 of Block 10, all in Lake Shore Addition to the City of Holson, Montana in accordance with the plat thereof on file and of record with the Clerk and Recorder of Lake County, Montana

Section 6. The character of said improvements to be made in said Special Sewer Improvement District No. 7 are as follows, to wit: - the construction of a sewerage system to serve the property within the boundaries of said described improvement district.

Section 7. That the entire cost and expense of said improvements shall be assessed against all of said Special Sewer Improvement District No. 7 and each lot or parcel of land within said district shall be assessed for that part of the whole cost which its area bears to the area of the entire district, exclusive of streets, alleys, avenues and public places.

Section 8. That the estimated cost and expense of making said improvement is the sum of \$85.00 per lot, and the total estimated cost of said improvement is \$14,620.00

Section 9. That the cost and ex pense of making said improvement shall be assessed and paid in the following manner: - to wit, That the assessment levied to defray the cost of said improvement shall be extended over a period of eight years and paid in eight annual installments or payments, the first of which shall be paid in the year 1931. Deferred payments or installments shall bear interest at the rate of 6 per cent per annum, payable annually.

Section 10. That at any time within 15 days after the date of the first publication of notice of passage of this Resolution, any owner of property within said district which shall be assessed for the cost and expense of making said improvements may make and file in the office of the city clerk of the city of Polson, Montana, a written protest against the proposed work and against the extent or the creation of said district, or both, and that the city council will proceed to hear and pass upon all such protests at a Special meeting thereafter to be held on the 12th day of May 1930 at 8 o'clock P.M. of said day in the City Hall of the city of Polson, Montana.
