RESOLUTION NO. 54

A RESOLUTION CREATING OIL SPRINKLING DISTRICT NO. 4 AND DEFINING THE BOUNDARIES THEREOF AND ESTIMATING THE COST THEREOF.

BE IT RESOLVED by the City Council of the City of Polson, Lake County, Montana.

SECTION 1 - That an oil sprinkling district to be known as designated as oil sprinkling District No. 4 is hereby created.

SECTION 2 - That the boundaries of said oil sprinkling district No. 4 are and shall be such as to include all of the area or that portion of the City of Polson, including the streets upon which the following described lots and blocks border, to-wit:

ORIGINAL TOWNSITE

Lots 4, 5, and 6 in Block 1; Lots 1 to 6 inclusive Block 2; Lots 7 to 15 inclusive in Block 2; Lots 1 and 2 in Block 3; Lots 1, 2 and 3 in Block 4; 58,826 square feet of Public Reserve; All of Block 5; All of Block 6; Lots 6 to 12 inclusive in Block 7; All of Block 8; All of Block 9; All of Block 10; All of Block 11; All of Block 12; All of Block 13; All of Block 14; All of Block 15; All of Block 16; Lots 1 to 7 inclusive in Block 17; All of Block 18 (City Park); all of Block 19; All of Block 20; All of Block 21; All of Block 22; All of Block 23; All of Block 24; All of Block 25; Lots 6 to 12 inclusive in Block 26; All of Block 27; All of Block 28; All of Block 29; All of Block 30; All of Block 31;

RIVERSIDE ADDITION

SECTION 4 - Whereas an emergency exists and it is immediately necessary for the preservation of the peace, health and safety of the inhabitants of Polson that this resolution shall take effect immediately upon its passage and approval.

SECTION 5 - That all resolutions or parts of resolutions in conflict herewith are hereby repealed.
