' BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON. LAKE COUNTY, MONTANA.

SECTION 1 - That an oil sprinkling district to be known and designated as oil sprinkling District No. 5 is hereby created.
