A RESOLUTION CREATING OIL SPRINKLING DISTRICT NO. 6 AND DEFINING THE BOUNDARIES THEREOF AND ESTIMATING THE COST THEREOF.

BE IT RESOLVED by the City Council of the City of Polson, Lake County, Montana.

SECTION 1. - That an oil sprinkling district to be known and designated as oil sprinkling District No. 6 is hereby created.
