Section 4. It shall be unlawful for any person to swim within the breakwater or to use the same for bathing purposes.

Section 5. The breakwater may be used by the public for boats, but no boat of any kind shall be anchored therein or within one hundred feet from the intrance thereto, and all boats using said breakwater must be made fast to the dock. Boats may moor temporarily to the float for the purpose of loading or unloading passengers, but shall not remain moored to said float to the exclusion of other boats desiring to dock at said float.

Section 6. Any person violating any of the provisions of this ordinance shall upon conviction thereof, be deemed guilty of a misdemeanor and shall be punished by a fine in a sum not less than \$5.00 nor more than \$100.00 or by imprisonment in the City jail for not less than five days nor more than sixty-days, or by both such fine and imprisonment.

Section 7. Whereas an emergency exists, now therefore this ordinance shall take effect immediately upon its passage by the Council and approval by the Mayor.

RESOLUTION NO. 63

A RESOLUTION PROPOSING TO EXTEND THE CORPORATE LIMITS OF THE CITY OF POLSON SO AS TO INCLUDE MICHEL ADDITION THEREIN.

Wheras, that territory or portion of the Angeline Michel Gingras, formerly Angeline Michel, Indian allotment in Section Four (4), of Township Twenty-two (22) North, Range Twenty (20) West M. M. Lake County, Montana lying south of the north boundary line of "C" Street, has been surveyed and laid off into streets and blocks as an addition thereto, to-wit: "Michel Addition", and a map or plat thereof has been filed in office of the County Clerk and Recorder of Lake County, Montana within which County said land is situate and said plat has been approved by the Mayor and the City council of the City of Polson and said territory is contiguous to the City of Polson, and

WHEREAS, it appears to the Mayor and City Council of the City of Polson That it will be to the best interests of the City of Polson and the inhabitants thereof and of the inhabitants of said territory or parcel of land, as aforesaid, that the boundaries of the City of Polson shall be extended so as to include the same within the corporate limits thereof.

NOW THEREFORE, BE IT RESOLVED by the City Council of the City of Polson that it is the judgment of said Council that it will be to the best interests of the City of Polson and the inhabitants thereof and of the inhabitants of said territory or parcel of land as aforesaid and here-inafter described and platted as Michel Addition, that the boundaries of the City of Polson be extended so as to include within the corporate limits of said City all of that portion of the Angeline Michel Gingras, formerly Angeline Michel, Indian Allotment in Section Four (4), in Township Twenty-two (22)North, Range Twenty (20) West M. M. lying south of the north boundary line of "C" Street.

BE IT FURTHER RESOLVED that the City Clerk shall forthwith notify in writing all property holders within the boundaries of said territory and cause to be published in the Flathead Courier, the newspaper published nearest said Addition, at least once a week for two successive weeks, a notice to the effect that this resolution has been duly and regularly passed and that for a period of twenty days after the publication of

said notice, said City Clerk will receive expressions of approval or disapproval in writing of the proposed extension of the boundaries of the City of Polson from freeholders of the territory proposed to be embraced therin.

ORDINANCE NO. 185

AN ORDINANCE PROHIBITING THE DISTURBANCE OF THE PEACE AND AFFIXING A PENALTY THEREFOR, AND REPEALING ORDINANCE NO. 31.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON:

Section 1. That any person who shall, within the corporate limits of the City of Polson, wilfully and maliciously or intentionally and unnecessarily disturb the peace and quiet of any street, neighborhood, person or family by loud and unusual noises or by a disorderly, offensive or drunken conduct, or who shall warrel, fight, scold, or threaten to quarrel or fight or who shall provoke an assault and battery or curse and swear or utter any obscene, vulgar or indecent language, or by any other means whatever disturb the peace, shall be deemed guilty of a misdemeanor and upon conviction thereof, shall be punished by a fine in a sum not less than Five Dollars (\$5.00) nor more than One
Hundred Dollars (\$100.00), or shall be imprisoned in the City jail for a period of not less than five (5) days nor more than fifty (50) days, or by both such fine and imprisonment.

Section 2. Any person permitting any disturbance described in the foregoing section upon premises owned or occupied by him or her, shall be deemed guilty of maintaining a nuisance and upon conviction thereof, shall be punished by a fine in the sum of not less than Five Dollars (\$5.00) nor more than One Hundred Dollars (\$100.00) or by imprisonment in the City jail for not less than five (5) days nor more than fifty (50) days, or by both such fine and imprisonment.

Section 3. Whereas an emergency exists and this ordinance is immediately necessary for the preservation of the peace, health and safety of the inhabitants of the City of Polson, therefore this ordinance shall take effect immediately upon its passage and approval.

Section 4. Ordinance No. 31 is hereby repealed.
