

RESOLUTION NO. 65

A RESOLUTION CREATING OIL SPRINKLING DISTRICT NO. 7 AND DEFINING THE BOUNDARIES THEREOF AND ESTIMATING THE COST THEREOF.

BE IT RESOLVED by the City Council of the City of Polson, Lake County, Montana.

SECTION 1. - That an oil sprinkling district to be known and designated as oil sprinkling District No. 7 is hereby created.

SECTION 2. - That the Boundaries of said oil sprinkling district No. 7 are and shall be such as to include all of the area or that portion of the City of Polson, including the streets upon which the following described lots and blocks border, to wit:

All of Block 1, all of Block 2, all of Block 3, all of Block 4, all of Block 5, all of Block 6, lots 1 to 8 inc. Block 7, lots 5 to 12 inc. Block 8, all of Block 9, all of Block 10, all of Block 11, all of Block 12, all of Block 13, all of Block 14, all of Block 15, all of Block 16, all of Block 18, all of Block 19, all of Block 20, all of Block 21, all of Block 22, all of Block 23, all of Block 24, all of Block 25, Lots 5 to 12 inc. Block 26, all of Block 27, all of Block 28, all of Block 29, all of Block 30 and all of Block 31, in the Original Townsite of Polson, Montana.

All of Block 1, all of Block 2, Lots 1 and 2 and lots 7 to 16 inc. Block 3, all of Block 4, all of Block 5, all of Block 6 and all of Block 7 in Riverside Addition to Polson, Montana.

Lots 7 to 12 inc. Block 2, Lots 7 to 12 inc. Block 3, Lots 1 to 6 inc. and lots 11 and 12 Block 4, Lots 1 to 6 inc. Block 5, Lots 1, 2, 11, 12 Block 7, Lots 1 and 2 and lots 7 to 12 inc. Block 8, Lots 7 to 12 inc. Block 9, all in Cramer's Sub-Division to Polson, Montana.

Lots 4, 5, 6, 7 Block 1, Lots 7, 8, 9, 10, 11 & 12 Block 2, Lots 1 to 8 inc. Block 5, Lots 1, 2, 3 & 4 Block 6, Lots 5, 6, 7 & 8 Block 8, and Lots 5, 6, 7 & 8 in Block 11, all in Lake Shore Addition to Polson, Montana.

Lots a, b & c in Block 6, Lots 5, 6, 7 & 8 in Block 7 of Polson Hights Adn. to Polson, Montana.

Lots 5, 6, 7 & 8 Block 2, Lots 1, 2 & 11 Block 3, Lots 1, 2, 11 & 12 Block 6, Lots 5, 6, 7 & 8 Block 7 Grandview Addition to Polson, Montana.

All of Block 1 of Church Addition to Polson, Montana.

Lots 1 to 6 Block 1, Lots 1 to 6 Block 2, Lots 1 to 6 Block 3 and Lots 1 to 4 Block 4 of Lewis Addition to Polson, Montana.

Lots 1 to 6 inc. Block 1, Lots 1 to 8 inc. Block 2 and the Polson Flour Mills Block in Central Addition to Polson, Montana.

Roman Catholic Bishop (Church) and the N. P. Ry. Co. property in Center Addition to Polson, Montana.

Lots 1, 2, 3 Block 2, Trach 8, and two lots of Geo. Elmore on "G" St. in Michell Addition to Polson, Montana.

The McIntire Tract adjoining Riverside Addition to Polson, Montana.

Section 3. - That the estimated cost of oiling said district is the sum of \$6,000.00.

Section 4. Whereas an emergency exists and it is immediately necessary for the preservation of the peace, health and safety of the inhabitants of Polson that this resolution shall take effect immediately upon its passage and approval.

Section 5. - That all resolutions or parts of resolutions in conflict herewith are hereby repealed.
