

A RESOLUTION CREATING OIL SPRINKLING DISTRICT NO. 8 AND DEFINING THE BOUNDARIES THEREOF AND ESTIMATING THE COST THEREOF.

BE IT RESOLVED BY THE City Council of the City of Polson, Lake County, Montana.

SECTION 1. - That an oil sprinkling district to be known and designated as oil sprinkling district No. 8 is hereby created.

SECTION 2. - That the Boundaires os said oil sprinkling distriict No. 8 are and shall be such as to include all of the area or that portion of the City of Polson, including the streets upon which the following described lots and blocks border, to-wit:

All of Block 1, all of Block 2, all of Block 3, all of Blk. 4, all of Blk. 5, all of Blk. 6, lots 1 to 8 inc. Blk. 7, lots 5 to 12 inc. Blk. 8, all of Blk. 9, all of Blk. 10, all of Blk. 11, all of Blk. 12, all of Blk. 13, all of Blk. 14, all of Blk 15, all of Blk 16, all of Blk. 17, all of Blk. 18, all of Blk. 19, all of Blk. 20, all of Blk. 21, all of Blk. 22, all of Blk. 23, all of Blk. 24, all of Blk. 25, all of Blk. 26, all of Blk. 27, all of Blk. 28, all of Blk. 29, all of Blk 30 and all of Blk. 31, in the Original Townsite of Polson, Montana.

All of Block 1, all of Blk. 2, Lots 1 and 2 and lots 7 to 16 inc. Blk. 3, all of Blk. 4, all of Blk. 5, all of Blk. 6 and all of Blk. 7 in Riverside Addition to Polson, Montana.

Lots 7 to 12 inc. Blk. 2, Lots 7 to 12 inc. Blk. 3, Lots 1 to 5 inc. and lots 11 and 12 Blk. 4, lots 1 to 6 inc. Blk. 5, lots 1,2,11,12 Blk. 7, lots 1 and 2 and lots 7 to 12 inc. blk 8, lots 7 to 12 inc. blk. 9, all in Cramer's Sub-Division to Polson, Montana.

Lots 4,5,6,7 blk. 1, lots 7,8,9,10,11 & 12 blk. 2, lots 1 to 8 inc. blk. 5, lots 1,2,3,4 blk. 6, lots 5,6,7,8 blk. 8, and lots 5,6,7,8 in blk. 11, all in Lake Shore Addition to Polson, Montana.

Lots a, b & c in blk. 6, lots 5,6,7,8 blk 7 of Polson Hights Addn. to Polson, Montana.

Lots 5,6,7,8 Blk 2, lots 1,2, 11 blk. 3, lots 1,2,11,12 blk. 6, lots 5,6,7, 8 blk 7 Grandview Addition to Polson, Montana.

All of Block 1 of Church Addition to Polson, Montana.

Lots 1 to 6 inc. blk. 1, lots 1 to 6 inc. blk 2, lots 1 to 6 inc. blk. 3 and lots 1 to 4 blk. 4 of Lewis Addition to Polson, Montana.

Lots 1 to 6 inc. blk. 1, lots 1 to 8 inc. blk. 2 and the Polson Flour Mills blk. in Central Addition to Polson, Montana.

Roman Catholic Bishop (Church) and the N. P. Ry. Co. property in Center Addition to Polson, Montana.

Lots 1,2,3 blk. 2 Tract 8, and one lot of Geo. Elmore on "G" St. in Michell Addition to Polson, Montana.

The McIntire Tract adjoining Riverside Addition to Polson, Montana.

SECTION 3. That the estimated cost of oiling said district is the sum of \$3,000.00.

Section 4. Whereas an emergency exists and it is immediately necessary for the preservation of the peace, health and safety of the inhabitants of Polson that this resolution shall take effect immediately upon its passage and approval.

SECTION 5. - That all resolutions or parts of resolutions in conflict herewith are hereby repealed.
