RESOLUTION NO 68

BE IT RESOLVED, by the city council of Polson:-

WHEREAS, the city reservoir has suddenly cracked and sprung a large leak and will no longer hold water in a sufficient amount for the needs of the inhabitants of the cityof Polson, and for fire protection, and will require considerable repairs; and

WHEREAS, it is necessary to restore said reservoir to a condition of usefullness by repairing same, and by enlarging the capacity thereof, or by constructing a twin reservoir, all of which is necessary to protect and preserve the peace and health of the inhabitants of the city of Polson, now therefore,

BE IT RESOLVED, that said conditions and circumstances constitute a public emergency and that a public emergency exists which could not have been reasonably forseen at the time of making a city budget; and

BE IT FURTHER RESOLVED, that the estimated cost or amount of money necessary to be expended by the city of Polson to purchase materials and to pay the labor necessaryly required to meet such emergency, is the sum of two thousand five hundred dollars (\$2,500.00); and

BE IT FURTHER RESOLVED: That a hearing to be held on this resolution in the city hall in the city of Polson, Lake county, Montana on monday, March 6th, 1939 at 7:30 o'clock P. M. at which time and place any taxpayer may appear and be heard for or against the expenditure of said sume of money, or so much thereof as may be necessary for the purchase of said materials and paying the necessary labor; and

BE IT FURTHER RESOLVED, that this resolution, together with a notice of said hearing, shall be published once in the Flathead Courier at least one week prior to the date of said hearing.
