

RESOLUTION 69

A RESOLUTION CREATING OIL SPRINKLING DISTRICT NO. 9 AND DEFINING THE BOUNDARIES THEREOF AND ESTIMATING THE COST THEREOF.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY MONTANA.

SECTION 1 That an oil sprinkling district to be known and designated as OIL SPRINKLING DISTRICT NO 9 is hereby created.

SECTION 2 That the boundaries of said oil sprinkling district No. 9 are and shall be such as to include all of the area or that portion of the City of Polson, Montana, including the streets upon which the following described lots and blocks border, to-wit:

~~SECTION XXX:~~ All of Block 1, all of Block 2, all of Block 3, all of Block 4, all of Block 5, all of Block 6, lots 1 to 8 inc. Blk 7, lots 6 to 12 inc. Blk 8, all of Block 9, all of Block 10, all of Block 11, all of Blk 12, all of Blk 13, all of Blk 14, all of Blk 15, all of blk 16, all of blk 17, all of blk 18, all of blk 19, all of blk 20, all of blk 21, all of blk 22, all of blk 23, all of blk 24, all of blk 25, all of blk 26, all of blk 27, all of blk 28; all of blk 29, all of blk 30 and all of blk 31 of the Original Townsite of Polson.

All of blk 1, all of blk 2, Lots 1 and Lots 7 to 16 inc. Blk 3, all of blk 4, all of blk 5, all of blk 6 and all of blk 7 of Riverside Addition.

Lots 7 to 12 inc. blk 2, Lots 7 to 12 inc. blk 3, Lots 1 to 5 inc. and lot 12 blk 4, Lots 1 to 6 inc. Blk 5, Lots 1 and 12 blk 7, Lots 1 ~~and~~ lots 7 to 12 inc. blk 8, lots 7 to 12 inc. blk 9, all in Cramer Sub-Division to Polson.

Lots 4,5,6,7 blk 1, lots 7,8,9,10,11 and 12 blk 2, Lots 1 to 7 inc. blk 5, Lots 1,2,3,4 blk 6, Lots 6 and 7, blk 8, and lots 6 and 7, blk 11, all in Lakeshore Addition to Polson

All of Block 1 of Church Addition to Polson.

Lots 1 to 6 inc. blk 1, lots 1 to 6 inc. blk 2, lots 1 to 6 inc. blk 3 and lots 1 to 4 inc. blk 4 of Lewis Addition to Polson.

Lots 1 to 6 inc blk 1, lots 1 to 8 inc. blk 2, and the Polson Flour Mills blk in Central Addition to Polson.

Roman Catholic Bishop (Church) and the Northern Pacific Ry Co. property in Center Addition to Polson.

Lots 1,2,3 blk 2 Tract 8, and one lot of Geo. Elmore on "G" St. in Michel Addition to Polson.

The McIntire Tract adjoining Riverside Addition.

SECTION 3 That the estimated cost of oiling said district is the sum of \$3,000.00.

SECTION 4 That an emergency exists and it is necessary immediately for the preservation of the peace, health and safety of the inhabitants of the city of Polson that this RESOLUTION shall take effect immediately upon its passage and approval.

SECTION 5 That all resolutions or parts of resolutions in conflict herewith are hereby repealed.
