Resolution No. 70

A RESOLUTION ALTERING THE BOUNDARIES OF THE CITY OF POLSON AND EXCLUDING CERTAIN TERRITORY THEREFROM

Be it resolved by the City Council of the City of Polson:

Section 1. Whereas, E.C. Claffey and Ruby A. Claffey filed with th City Clerk of the City of Polson, praying that certain t rritory be excluded from the corporate limits of the City of Polson, and

Section 2. Whereas, the City Council, on February 5th, 1940, duly and r gularly passed and adopted a resolution finding that said petition was signed by the owners of all of the property sought to be excluded and that the trritory petitioned to be excluded was within the corporate limits of the city of Polson and on the boundary thereof, and that the granting of said petition would be to the best interests of the City of Polson and the inhabitants thereof and would not materially mar the symetry of said city granting said petition, and

Section 3. Whereas, the City Clerk forthwith caused to be published in the Flathead Courier, a weekly newspaper regularly printed and published in the City of Polson, Lake County, Montana, the paper nearest the territary petitioned to be excluded, once a week for two successive weeks, to the effect that such resolution had been duly and regularly passed and that for a period of twenty days after the first publication of such notice, such Clerk would receive expressions of approval or disapproval in writing of the proposed alterations of the boundaries of the City of Polson by the exclusion of the territory petitioned to be excluded, and said twenty days having expired and no expressions of approval or disapproval in writing of the proposed alterations of the boundaries of the City having been received by said Clerk, and the said Clerk having laid before this Council said petition, resolution and affidavit of publication of notice, at this, the next regular meeting of this Council, as the expiration of said period of twenty days.

Section 4. NOW? THEREFORE? BE IT RESOLVED that the boundaries of the City of Polson be, and the same are hereby, altered so as to exclude the territory described in said petition as follows, to-wit:

Beginning at a point which is 27.5 feet North of the 1. E. corner f Bleck 1, of "Polson Heights", an approved, certified and recorded sub-division located in the Sz of the above described NW½ NW½, thence N. 89 degree 50' W. 605 feet, thence N. o degree03' W. 236.65 feet, more or less, to the South boundary line of the Northern Pacific Rwy. Company's station grounds, thence S. 89 degree 50' E. along the above described Northern Pacific boundary line for a distance of 605 feet, thence S. O degree 03' E. 236.65 feet to the point of beginning. Containing 3.286 acres, more or less, of the N½ of NW½ of the NW¼, Section 10, Twp. 22 N., Rge. 20 W. of the Principal Meridian, Montana.

from the corporate limits thereof and that the boundaries of said city be changed accordingly.

Section 5. That said territory has never been platted and that there are no streets, avenues, alleys or other public places in said excluded territory which are to be vacated and abandoned.

Section 6. That this resolution shall become effective thirty days after its passage and approval.
