ORDINANCE NO 213

AN ORDINANCE PROVIDING A METHOD FOR OILING THE STREETS EMBRACED WITHIN THE OILING DISTRICT OR SPRINKLING DISTRICT NO 14A, PAYING FOR THE SAME, AND CREATING AN EMERGENCY.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON; IN LAKE COUNTY, MONTANA:

Section 1. That all of the streets included within sprinkling district No $14~\mathrm{A}$, shall be oiled during the summer season of 1947 by forces employed by the city.

Section 2. That the cost and expenses of sprinkling said streets with oil shall be assessed against all of said property exclusive of parks and public places, embraced within such sprinkling district on an area basis.

Section 3. Whereas an emergency exicts, and it is necessary for the preservation of the peade, health and safety of the public, this ordinance shall take effect immediately upon its passage and approval.

RESOLUTION NO. 80

A RESOLUTION SUBMITTING TO THE REGISTERED ELECTORS OF THE CITY OF POLSON? WHOSE NAMES APPEAR UPON THE LAST PRECEDING ASSESSMENT ROLL FOR STATE AND COUNTY TAXES; AS TAXPAYERS UPON PROPERTY WITHIN THE CITY OF POLSON, THE QUESTION OF AUTHORIZING AND EMPOWERING THE COUNCIL OF THE CITY OF POLSON, TO ISSUE, NEGOTIATE AND SELL BONDS IN THE SUM OF FIFTEEN THOUSAND DOLLARS (\$15,000.00) UPON THE CREDIT OF THE CITY OF POLSON, AT THE NEXT GENERAL CITY ELECTION TO BE HELD ON MONDAY, APRIL 7, 1947, AND PROVIDING FOR THE GIVING OF NOTICE OF SUCH ELECTION.

WHEREAS, There has been presented to the city council of the City of Polson, Lake County, Montana, a petition asking said Council to submit to the registered electors of the City of Polson, whose names appear upon the last preceding assessment roll for State and County taxes (being the assessment roll for State and County for the year 1946) as taxpayera upon property within said city, at a general of especial election duly called for that purpose as authorized by Chapter 399 of the Political Code of Montana, 1935, and the acts amendatory thereof and supplemental thereto, the question of authorizing and empowering the City Council of the City of Polson to issue, negotiate and sell coupon bonds, either amortization or serial bonds, as the Council shall prescribe, in the sum of \$15,000.00, on the credit of the City of Polson, for the purpose of purchasing fire apparatus, including a new fire truck and a fire alarm system and the installation thereof, and which petition estimates the sum of \$15,000.00 to be necessary and adequate for the single purpose herein stated; and

WHEREAS, There was duly attached to the said complete Petition the affidavits of the persons who circulated or assisted in circulating such Petitions to the effect that he or they believe the signatures thereon were genuine and that the signers knew the contents thereof before signing the same; and

WHEREAS, The said Petition was heretofore and on the <u>lst</u> day of March, 1947, duly delivered and presented to the city Clerk of the City of Polson and by him duly filed in his said office on said date; and

WHEREAS, The City Clerk of the City of Polson, Lake County, Montana, did within fifteen (15) days after the filing of said Petition, carefully examine the same and the County records relating to the qualifications of the signers of said Petition and attach thereto his certificate, under his signature and offical seal of his office, which certificate sets forth

- (1) The total number of persons who are registered electors and whose names appear upon the last completed assessment roll for State and County taxes as taxpayers within the City of Polson,
- (2) Which and how many of the persons whose names are subscribed to such petition are possessed of all of the qualifications required of signers of such petitions,
- (3) That the qualified signers to said completed Petition constituted more than twenty percent (20%) of the registered electors whose names appear upon the last completed assessment roll for State and County taxes, to-wit: 20% as required by Chapter 399 of the Political Code of Montana, 1935, and the acts amendatory thereof and supplemental thereto; and

WHEREAS, The said City Clerk has found that said Petition has a sufficient number of signers qualified to sign the same and has placed said Petition before the City Council at its first meeting held after he had attached his certificate thereto; and

WHEREAS, The purpose for which said bonds are proposed to be issued is to purchase new fire apparatus, including a new fire truck and a fire alarm system and installing the same; and

WHEREAS, The estimated amount of bonds to be issued for said purpose is the sum of \$15,000.00; and

WHEREAS, It appears that the issuance and sale of coupon bonds, either amortization or serial, in the said sum of \$15,000.00 with all outstanding and unpaid indebtedness to said city, will not exceed three percent (3%) of the taxable property therein as ascertained by the last completed assessment roll for State and County taxes, and that said bonds may be sold at a lower rate of interest than six percent (6%) per annum.

NOW, THEREFORE, BE IT RESOLVED, by this City Council of the City of Polson that, under the authority and in full compliance with the provisions of Chapter 399 of the Political Code of the State of Montana, 1935, and the acts amendatory thereof and supplemental thereto, that the question of authorizing and empowering the City Council of the City of Polson, Lake County, Montana, to issue, Negotiate and sell coupon bonds, either amortization or serial as the City Council shall prescribe, in the sum of \$15,000.00 upon the credit of the City of Polson, for the purpose aforesaid, be submitted to the registered electors of the City of Polson whose names appear upon the last preceding assessment roll for State and County taxes (being the assessment roll for the year 1946) as taxpayers upon property within the said city, at the next general election to be held Monday, April 7, 1947.

AND BE IT FURTHER RESOLVED, That the City Clerk of this city be, and he is hereby directed to give notice of such election and arrange for the conduct of the same, and to take such other steps as are required by law for the holding of such election.
