RESOLUTION NO 81 -

A RESOLUTION CREATING OIL SPRINKLING DISTRICT NO.14-A AND DEFINING THE BOUNDARIES AND ESTIMATING THE COSTS THEREOF.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON; LAKE COUNTY, MONTANA.

Section 1. That an oil sprinkling district, to be known and designated as Oil Sprinkling District No 14-A is hereby created.

Section 2. That the boundaries of said Oil Sprinkling District No 14-A are and shall be such as to include all of the area or that portion of the City of Polson, Montana, including the streets upon which the following described lots and blocks border, to-wit:

Section 5. That all resolutions or parts thereof in conflict herewith are hereby repealed.
