## RESOLUTION NO 91

A RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF POLSON MONTANA TO CREATE SPECIAL SEWER IMPROVEMENT DISTRICT NUMBER (9) nine in said city of Polson, Montana, for the purpose of acquiring, building, extending and maintaining a sewer in the interest of health of the property owners of said district; designating the number of said district; describing the boundaries of said proposed district; stating the general character of the improvements proposed to be made therein; stating the approximate estimate of the cost thereof; providing for the giving of notice of the time and place for hearing protests against the proposed work or against the extent or creation of the district to be assessed, or both.

Be it resolved by the city council of the city of Polson, Lake County, Montana:

Section 1: That the public health, convenienc and sanitary safety require, and it is deemed necessary to order and create, and the

City Council of the city of Polson, Montana, hereby declares its intention so to create a Special Improvement District, the Boundaries of which, and the character of the improvements to be made are hereinafter set forth.

Section 2: That the said special improvement district shall be known and designated as "Special Sewer Improvement District Number Nine".

Section 3: That the district shall include the following areas, within its boundaries, as hereinafter described to wit: All of blocks one and two of Central addition, and all of block one of Lewis addition, both additions being in the city of Polson, Lake County Montana, and in accordance to the plat now on file in the office of the County Clerk and Recorder of Lake County Montana, and city clerk of the city of Polson,

That the boundaries of said proposed district, the same being special sewer district number 9 shall be and are designated as commencing at the Northeast corner of lot 1, Block 1, Central addition of and in the city of Polson, thence west to the Northwest corner of lot 6 Block 1, Lewis addition of and in the city of Polson, Montana, thence south to the southwest corner of lot 7 block 1, Lewis addition of and in the city of Polson, Montana, thence east to the southeast corner of lot 12, block 1, of Central addition, of said city, thence North to the Point of beginning.

That all of said lots, blocks and tracts are the real estate and property included within the boundaries of said Special sewer Improvement district number nine, and the Council finds and determine that all of the real estate situated in said proposed district will be specially benefited, and effected by such improvement.

Section 4: That the district included within said boundaries is hereby declared to be the district benefited by said improvements, and the real estate above described included within the boundaries of said district is hereby declared to be the property to be assessed for the costs and expenses of making and acquiring said proposed improvements.

Section 5: That the general character of the proposed improvements to be made in said proposed Special sewer Improvement district number nine is hereby declared to be as follows: the acquiring; building, extending, and maintaining a sewer and sewer system, all of which said improvements are in accordance with the plans and specifications adopted by the council of the city of Polson, Montana, and which plans and specifications will be on file in the office of the city clerk, and are hereby refered to and by this reference are made a part hereof to all intents and purposes the same as the the said plans and specifications were fully set forth and incorporated at length in this resoulution, said plan and specifications being herewith adopted and approved by said council.

Section 6: That the approximate, estimate of the costs of building, making, and acquiring said proposed improvements is the sum of \$5605.00 or \$140 plus cents per lot.

Section 7: That it is the intention of this council that all the cost and expense incurred in the acquiring, building, extending and maintaining said improvements shall be paid by special improvement district bonds in from as the law requires, and which bonds shall be drawn against Special Sewer Improvement district Number nine fund, hereinafter to be ordered and created, and that the entire cost and expense of making said proposed improvement shall be paid by the special improvement district, and each lot or parcel of land within such district shall be assessed for the part of the whole cost according to the square foot which its area bears in relationship to the area of the entire district, exclusive of streets, avenues, alleys and federal property. That said assessment shall be paid for in ten annual installments, and are to be extended over a period of ten years, and bear interest at a interest at a rate not exceeding 6 per cent annum from the date of registration, interest to be paid annually on defferred payments;

and the said payments shall constitute a fund to be known as Special Sewer Improvement district number nine Fund, and it is intended that special improvement district bonds shall be issued against said fund, the denomination and maturity dates of which bonds to be fixed by resolution to be hereafter adopted.

Section 8: That at any time within 15 days after the date of the first publication of the notice of the passage of this resolution any owner or agent of the owner of the property effected, within said district, which will be assessed for costs and expenses of making and acquiring said improvements may make and file in the office of the city clerk of the city of Polson, Montana, a written protest against the proposed work, or against the extent creation of the district to be assessed or both, and that the said city council will proceed to hear and pass upon all protests at a regular meeting of said Council to be held on Tuesday the 6th day of July 1948. 8 O'Clock P.M. City hall, city of Polson, Montana.

Section 9: Upon the final passage of this resolution, the city clerk, for this council, is hereby directed to give notice of the passage of this resolution of intention by publishing notice thereof in two issues of and in the Flathead Courier, a weekly newspaper published in the city of Polson, Montana, which said notice must describe the general character of the improvements proposed in this resolution to be made, and shall state the estimated costs thereof, and shall designate the time and place when and where the council will hear and pass upon protests that may be made against the making of such improvements or the creation of said district, such notice shall refer to this resolution on file in the offic of the clerk of this city for the description of the boundaries, further the city clerk is hereby directed to mail a copy of said notice to every person, firm, or corporation having property within said proposed district, and at his or its last known address upon the same day such notice is first published.
