and the said payments shall constitute a fund to be known as Special Sewer Improvement district number nine Fund, and it is intended that special improvement district bonds shall be issued against said fund, the denomination and maturity dates of which bonds to be fixed by resolution to be hereafter adopted.

Section 8: That at any time within 15 days after the date of the first publication of the notice of the passage of this resolution any owner or agent of the owner of the property effected, within said district, which will be assessed for costs and expenses of making and acquiring said improvements may make and file in the office of the city clerk of the city of Polson, Montana, a written protest against the proposed work, or against the extent creation of the district to be assessed or both, and that the said city council will proceed to hear and pass upon all protests at a regular meeting of said Council to be held on Tuesday the 6th day of July 1948. 8 O'Clock P.M. City hall, city of Polson, Montana.

Section 9: Upon the final passage of this resolution, the city clerk, for this council, is hereby directed to give notice of the passage of this resolution of intention by publishing notice thereof in two issues of and in the Flathead Courier, a weekly newspaper published in the city of Polson, Montana, which said notice must describe the general character of the improvements proposed in this resolution to be made, and shall state the estimated costs thereof, and shall designate the time and place when and where the council will hear and pass upon protests that may be made against the making of such improvements or the creation of said district, such notice shall refer to this resolution on file in the offic of the clerk of this city for the description of the boundaries, further the city clerk is hereby directed to mail a copy of said notice to every person, firm, or corporation having property within said proposed district, and at his or its last known address upon the same day such notice is first published.
