Resolution No. 99

A RESOLUTION GRANTING AN EASEMENT FOR RAILROAD RIGHT-OF-WAY EASEMENTS OVER CERTAIN STREETS AND ALLEYS IN THE CITY OF POLSON, IN LAKE COUNTY, MONTANA TO THE NORTHERN PACIFIC RAILWAY COMPANY OR NORTHERN PACIFIC RAILROAD COMPANY, IN WHATEVER STYLE ITS CORPORATE NAME MAY BE USED AND DESIGNATED, SO THAT SAID COMPANY MAY EXTEND ITS RAILROAD TO INDUSTRIAL SITES IN DAID CITY, REPEALING ALL RESOLUTIONS IN CONFLICT AND FIXING THE EFFECTIVE DATE OF THIS RESOLUTION.

Be it resolved by the city council of the city of Polson, Montana:

Whereas the Northern Pacific Railway Company or Northern Pacific Railroad Company, by whatever name it is designated, a corporation, desires to acquire an easement over Division Street and First Street in Central Addition of and in the city of Polson in Lake County, Montana, to build, use, construct, operate its railroad tracks thereover and make an extension of its present tracks thereof,

Whereas it appears to best interest of said city and its inhabitants that said easement be granted,

Now therefore be it hereby resolved that said city of Polson, acting through said city council, and this city council does hereby grant and authorize the granting of an easement to said Railway company by whatever name it is so legally designated, to build, construct, use and maintain its railway and railroad tracks, in such distance and width it so requires, over and upon and through Division Street and First Street in Central addition of and in the city of Polson, in Lake County, Montana, and the Mayor and the city clerk of the city of Polson are hereby directed and authorized to execute said easements in due and proper form under the seal of said city and deliver to the said grantee named herein in its proper and legal name, in accordance to the attached plat hereof, and as supplemented by such blueprints to be hereinafter filed in the clerk's office.

All resolutions in conflict are hereby repealed.

This resolution takes effect 30 days after its passage and approval.

## Ordinance No. 223

AN ORDINANCE TO PROVIDE FOR THE NUMBERING OF THE HOUSES AND BUSINESS PLACES IN THE CITY OF POLSON? MONTANA, FIXING THE DUTIES OF STREET COMMISSIONER, FIXING EFFECTIVE DATE FOR ORDINANCE, DECLARING AN EMERGENCY, AND REPEALING ALL ORDINANCES IN CONFLICT.

Be it ordained by the city council of the city of Polson, Montana,

Section 1. Even numbers are hereby given to houses and business places on the east and north sides of all streets and odd numbers on the west and south sides of all streets.

All houses fronting on public streets in the City of Polson snall be numbered in conformity with the following provisions:
