

Ordinance No. 226

AN ORDINANCE REPEALING SECTION 259, ARTICLE 7, OF THE REVISED ORDINANCES OF THE CITY OF POLSON, 1937, DECLARING AN EMERGENCY, FIXING THE EFFECTIVE DATE.

Be it ordained by the City Council of the City of Polson:

Section 1. Section 259 of Article 7, Revised Ordinances of the City of Polson, 1937, is hereby repealed.

Section 2. An emergency exists effecting the welfare, peace, and police protection of the inhabitants of the City of Polson, and by reason thereof, this ordinance becomes effective upon the date of passage and approval.

Resolution No. 100

A RESOLUTION CREATING OIL DISTRICT NO. 14-C AND DEFINING THE BOUNDARIES THEREOF AND ESTIMATING THE COSTS THEREOF.

Be it resolved by the City Council of the City of Polson, County of Lake, Montana.

Section 1: That an oil sprinkling district, to be known and designated as oil sprinkling district No. 14-C is hereby created.

Section 2; That the boundaries of said oil sprinkling district No. 14-C are and shall be as to include all of the area or that portion of the city of Polson including the streets upon which the following described lots and blocks border:

All of Blocks 1, 2, 3, 4, 5, 6, Lots 2 to 12 inclusive in Block 7, Lots 1 to 12 inclusive in Block 8, all of Blocks 9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21, 22, 23, 24, 25, 26, 27, 28, 29, 30, and 31 of the Original Townsite of Polson.

All of Block 1, 2, Lots 1 and 7 to 16 inclusive in Block 3, all of Blocks 4, 5, 6, and 7 of Riverside Addition to the City of Polson.

Lots 6 and 7, Block 2, Lots 1 and 12 of Block 3, Lots 6 and 7 of Block 4, Lots 7 to 12 inclusive of Block 5, Lots 1 and 12 of Block 6, Lots 6 and 7 of Block 7, Lots 5 and 6 inclusive of Block 10, Lots 1 and 12 of Block 11, Lots 7 to 12 inclusive of Block 12, Lots 7 to 11 inclusive of Block 13, Lots 1 to 6 inclusive of Block 14, Lots 6 and 7 of Block 15, Lots 6 and 7 of Block 18, Lots 1 and 12 of Block 19 of the Grandview Addition to the City of Polson.

(Lots 1 to 4 inclusive of Block 2, and 5 to 8 Block / Pollman Addition, Hank Meyers property, Lots 6 and 7 in Block 2, Lots 1 to 6 inclusive in Block 3, Lots 7 to 12 inclusive in Block 4, Ben McNeeley, Frank Bare, Leo James Properties, Lots 6 and 7 in Block 7, Polson Heights addition to the City of Polson.

Lot A in Block 12, Lots 1 and 12 in Block 17, and hospital Block of Pend. Heights Addition to the City of Polson.

Lot 1 of Block 1, Lots 22 to 34 inclusive of Block 1, Lots 13 to 24 inclusive of Block 8, Lots 13 to 24 inclusive of Block 9, (Roman Catholic Bishop (Church) and the Northern Pacific Railway Property,) Lots 12 to 25 inclusive in Block 4, Lots 1 to 12 inclusive in Block 5, and Lots 1 to 12 inclusive in Block 12 of City Center Addition to the City of Polson.

Lots 1, 2, and 3 in Block 2, Dewey Lumber Tract, and 1 lot of George Elmore on G. Street in Michel Addition to the City of Polson.)⁷⁵⁰

The McIntire Tract adjoining Riverside Addition to the City of Polson.

Lots 1 to 12 inclusive in Block 2, Lots 1 to 12 inclusive in Block 3, and Lots 1 to 7 inclusive in Block 7 of Elevation Addition to the City of Polson.

All of Block 1 of Church Addition to the City of Polson, Lots 1 to 6 in Block 1, Lots 1 to 6 in Block 2, Lots 1 to 6 in Block 3, and Lots 1 to 4 inclusive in Block 4 of Lewis Addition to the City of Polson.

Lots 1 to 6 inclusive in Block 1, Lots 1 to 8 inclusive in Block 2, Lot 12 in Block 1, the Polson Flour Mills Block, Lots 1 and 12 in Block 5, Lots 6 and 7 in Block 5,

Lots 1 and 12 in Block 4, Lots 1, 6, 7, and 12 in Block 6, Lots 1 and 12 in Block 7, Lots 1 and 12 in Block 11, Central Addition to the City of Polson.

All of Block 1, 2, and 3, Lots 1 to 6 inclusive and Lot 12 in Block 4, Lots 1 to 6 in Block 5, Lots 1 and 12 in Block 7, Lot 1 and Lots 7 to 12 inclusive in Block 8, Lots 7 to 12 inclusive in Block 9, Cramer Addition to the City of Polson.

Lots 4 to 7 inclusive in Block 1, Lots 5 to 12 inclusive in Block 2, Lots 1 to 7 inclusive in Block 5, Lots 1 to 4 inclusive in Block 6, Lots 7 and 6 in Block 8, Lots 6 to 12 inclusive in Block 11, Lots 5 to 8 inclusive in Block 12, Lakeshore Addition to the City of Polson.

Section 3: That an emergency exists and it is necessary immediately for the preservation of the peace, health and safety of the inhabitants of the City of Polson that this resolution shall take effect immediately upon its passage and approval.

Section 4: That the estimated cost of oiling said district shall be the sum of \$6,000.00.

Section 5: That all resolutions or parts thereof in conflict are hereby repealed.

Resolution No. 101

A RESOLUTION CREATING OIL SPRINKLING DISTRICT NO. 14-D, DEFINING THE BOUNDARIES THEREOF AND ESTIMATING THE COSTS THEREOF.

Be it resolved by the City Council of the City of Polson, County of Lake, Montana:

Section 1: That an oil sprinkling district to be known and designated as oil sprinkling district No. 14-D is hereby created, at a cost of approximately \$2500.00.

Section 2: That the boundaries of said oil sprinkling district shall be such as to include all of the area of the City of Polson, Montana, including the streets and avenues upon which the following described lots and blocks border:
