Kootenai Avenue to be named and known as Kootenai Avenue; A Street east of Main to be named and known as First Avenue East; A. Street west of Main to be named and known as First Avenue West; B Street east of Main and Lake Street in Cramer's Subdivision to be named and known as Second Avenue East;
B Street west of Main to be named and known as Second Avenue West; C Street east of Main to be named and known as Third Avenue East; C Street west of Main to be named and known as Third Avenue West: D Street east of Main to be named and known as Fourth Avenue East; D Street west of Main to be named and known as Fourth Avenue West; E Street east of Main to be named and known as Fifth Avenue East; E Street west of Main to be named and known as Fifth Avenue West; F Street east of Main to be named and known as Sixth Avenue East; F Street west of Main to be named and known as Sixth Avenue West; G Street east of Main to be named and known as Seventh Avenue East; G Street west of Main to be named and known as Seventh Avenue West; Division Street and H Street east of Main to be named and known as Eight Avenue H Street west of Main to be named and known as Eighth Avenue West; Lake Street, in Polson Heights Addition, and I Street east of Main to be named and known as Ninth Avenue East; I Street west of Main to be named and known as Ninth Avenue West; High Street, in Polson Heights Addition, and J Street east of Main to be named and known as Tenth Avenue East; J Street west of Main to be named and known as Tenth Avenue West; First Avenue, in Center and Polson Heights Addition, and K Street east of Main to be named and known as Eleventh Avenue East; K Street west of Main to be named and known as Eleventh Avenue West; Second Avenue, in . Elevation and Grandview Additions, and L Street east of Main to be named and known as Twelfth Avenue East; L Street west of Main to be named and known as Twelfth Avenue West; Third Avenue, in Elevation and Grandview Additions, and M. Street east of Main to be named and known as Thirteenth Avenue East; M Street west of Main to be named and known as Thirteenth Avenue West: Fourth Avenue, in Elevation and Grandview Additions, to be named and known as Fourteenth Avenue East; N Street to be named and known as Fourteenth Avenue West; Fifth Avenue, in Elevation and Grandview Additions, to be named and known as Fifteenth Avenue East; Sixth Avenue, in Elevation and Grandview Additions, to be named and known as Sixteenth Avenue East. Section 2. All ordinances and parts of ordinances in conflict herewith are hereby repealed.

Section 3. The Council hereby declares that an emergency exists and, therefore, this ordinance shall be in full force and effect immediately after its passage and approval.

Resolution No. 102

RESOLUTION RELATING TO THE CALLING AND CONDUCT OF A SPECIAL ELECTION TO VOTE UPON IMPROVING THE CITY'S WATER SYSTEM AND THE ISSUANCE AND SALE OF REVENUE BONDS FOR SUCH PURPOSE.

BE IT RESOLVED by the Council of the City of Polson, Montana, as follows:

1. This Council does hereby find, determine, and declare: that it is essential to the health, safety and welfare of the City and its inhabitants for the City to acquire, purchase, construct, reconstruct, improve, better, and extend an undertaking consisting of its water system, and all parts thereof and appurtenances thereto, including, but not limited to, supply and distribution systems, reservoirs, and dams; that said project can best be carried out as a single undertaking, and paid for by the issuance of Revenue Bonds in conformity with Session Laws of Montana for 1939, Chapter 126; that said project can be so carried out at a total cost of

Fifty Thousand Dollars (\$50,000.00); that gross revenues can be derived in the form of rates, charges, and rentals imposed for the use of the facilities provided by such system sufficient in amounts and times of receipt to pay and discharge all costs of operation, repairs, and maintenance of said system, plus a reasonable depreciation reserve, plus the sinking fund amounts needed to meet all payments of principal and of interest on the Revenue Bonds which may be so authorized, issued, and sold, as such principal and interest respectively becomes due and during the period of years trhough which such bonds are to be paid, as therein specified; that such bonds, if authorized, issued, and sold, shall be payable as to both principal and interest solely from, and shall be a valid claim of the holders thereof only against the sinking fund and the net income and revenues of the system pledged thereto, and shall not constitute an indebtedness of the City within the meaning of any charter, statutory, or constitutional limitation upon the incurring of indebtedness, nor shall the City incur in respect thereto any obligation for the payment of which taxes may be levied; that the proposal to issue such Revenue Bonds and use the proceeds thereof for such purpose should be submitted to the qualified taxpayer voters of the City; and that such qualified taxpayer voters include all, but only, the duly registered electors of the City whose names appear upon the last completed assessment roll for state and county taxes as taxpayers upon property within the City of Polson.

2. A special election is hereby called and directed to be held in and for the City on Thursday, the 4th day of May, 1950, for the purpose of voting on the question

stated in the form of ballot hereinafter prescribed.

3. At said election all, but only, the duly registered and qualified electors of the City whose names appear upon the last preceding assessment roll for State and County taxes as a taxpayer upon property within the City shall be entitled to vote. The City Clerk is hereby authorized and directed to give notice forthwith to the County Clerk of the Call of said election. The County Clerk, shall, after giving due notice of closing of the registration books, prepare and post printed lists of the registered voters entitled to vote at said election, and shall prepare poll books for such election for each precinct of the City in the form and manner required by law.

4. The City Clerk is hereby authorized and directed to give notice of the call and holding of said election by publication, once each week for not less than two consecutive weeks in a newspaper published in Polson, Montana, the last such publication to be on the last day on which the newspaper is issued before the day of the election, and by causing notice to be posted in at least three of the most public places in each voting precinct in the City at least ten days prior to the date of said election, which

notice so published and posted shall read substantitally as follows:

NOTICE OF SPECIAL ELECTION CITY OF POLSON, MONTANA

NOTICE IS HEREBY GIVEN that on Thursday, the 4th day of May, 1950, a special election will be held in and for the City of Polson, Montana, for the determination of the question whether said City shall issue and sell its negotiable Revenue Bonds in the amount of Fifty Thousand Dollars (\$50,000.00), to be payable during a term of twenty (20) years from their date of issue, and use the proceeds thereof to finance the acquisition, purchase, construction, reconstruction, improvement, betterment, and extension of an undertaking consisting of its water system and all parts thereof and appurtenances thereto, including, but not limited to, supply and distribution systems, reservoirs, and dams, all in conformity with Session Laws of Montana for 1939, Chapter 126, as amended, such bonds and the interest thereon to be payable solely out of net income and revenues to be derived from rates and charges for the use of the facilities provided by the undertaking, and not to incur any obligation for the payment of which taxes may be levied except to pay for services provided by the undertaking to the City itself.
