The following Resolution was presented by Councilman Funke for the consideration of the Council, whereupon it was moved by Councilman Crawford, seconded by Councilman Schultz that the Resolution hereinafter set forth be adopted, and said motion was deopted by the unanimous vote of the Council present at said meeting, as show hereinafter, which said Resolution was, and is, as follows:

R E S O L U T I O N # 107

WHEREAS, the present method of decentralized sewage disposal and the high ground water table form a combination which presents a potential danger to the health of the City of Polson; and,

WHEREAS, portions of the existing under water drainage system need to be renovated and replaced in order to provide the city with an a dequate underwater drainage system; and,

WHEREAS, it is necessary to provide that protion of the city which lies south of Division Street with an adequate snaitary sewer system; and,

WHEREAS, there has been a definite correlation between the need for a sanitary sewer and underground drainage system since the existing means of sanitary sewage disposal and high ground water table combine to form a grave public health hazard; and

WHEREAS, the City Council of said City has determined that it is necessary to establish, build, construct, reconstruct and extend the storm and sanitary sewer system, and construct a plant for the treatment and disposal of sewage therefrom; and

WHEREAS, the Federal Government has authorized to be appropriated out of any funds in the Treasury, not otherwise appropriated, the sum of \$100,000.00, or so much thereof as may be necessary for the repair and rehabilitation and replacement of the drainage structures of a system of drainage of lands lying partly within the City of Polson, Montana;

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF POLSON, MONTANA, as follows:

1. This Council does hereby find and determine and declare that it is essential to the health, safety and welfare of the city and its inhabitants for said city to establish, build, construct, reconstruct and extend the storm and sanitary sewer system, and construct a plant for the treatment and disposal of sewage therefrom, and all parts thereof and appurtenances thereto; that said project can best be carried out as a single undertaking and paid for in part by the issuance of revenue bonds in conformity with Chapter 149 of the Session Laws of Montana of 1943, as amended.

2. The following constructions, reconstructions and extensions shall be made to the storm and sanitary sewerage, subject to the authorization of a majority vote of the qualified electors voting at an election to be held for that purpose, viz:

An eight inch sewer main, running from the intersection of the alley between Sixth Street and Fifth Street and 16th Avenue, and running in a northerly direction through said alley to its intersection with 12th Avenue, thence in a westerly direction to the intersection of that Avenue with the alley running between Fourth Street and Fifth Street, thence in a northerly direction to the alley between Tenth Avenue and Eighth Avenue.

An eight inch sewer main running from the intersection of the alley between Tenth Avenue and Eighth Avenue and Fifth Street, thence in a westerly direction to the alley alying between First Street and Second Street.

A ten inch sewer main commencing at the intersection of the alley between Second Street and First Street, and the alley between Tenth Avenue and Eighth Avenue, thence in a westerly direction to its intersection with First Street, thence in a northerly direction along First Street to its intersection with the alley between Ninth Avenue and Eighth Avenue; thence in a westerly direction along said alley to that alley's intersection with Second Street West.

A twelve inch sewer main running from the above point in a westerly direction along said alley to its intersection with a septic tank lying at the intersection of that alley with Sixth Street West.

An eight inch sewer main running from the intersection of Fourteenth Avenue with the city limits, thence in a northerly direction along the city limits and Second Street West to its intersection with the twelve inch sewer main in the alley between Ninth Avenue and Eighth Avenue.

An eight inch lateral running from the city limits along Sixteenth Avenue to the alley lying between Sixth Street and Fifth Street.

An eight inch lateral running from the eastern boundary of the city limits along Fifteenth Avenue to the aforementioned alley.

An eight inch lateral running from the intersection of the alley between Sixth Street and Seventh Street and Fifteenth Avenue, thence in a northerly direction to that alley's intersection with Fourteenth Avenue.

An eight inch lateral running from the eastern boundary of the city limits along Fourteenth Avenue to its intersection with the alley lying between Sixth Street and Fifth Street.

An eight inch lateral commencing with the intersection of Thirteenth Avenue and the city limits, thence in a westerly direction to the aforementioned alley.

An eight inch lateral running from the eastern boundary of the city limits along Twelfth Avenue to its intersection with the aforementioned alley.

An eight inch lateral running from the eastern boundary of the city limits along Eleventh Avenue to its intersection with the alley lying between Fifth Street and Fourth Street.

An eight inch sewer main running from the intersection of the alley between Fourth Street and Fifth Street and Eleventh Avenue, thence along Eleventh Avenue to its intersection with the alley between Fourth Street and Third Street.

An eight inch lateral running from the eastern boundary of the city limits along Tenth Avenue to its intersection with the alley between Fifth Street and Fourth Street.

An eight inch lateral running from the eastern boundary of the city limits along Ninth Avenue extended and Ninth Avenue to its intersection with Fifth Street.

An eight inch lateral running from the intersection of the alley between Seventh Street and Sixth Street and Tenth Avenue, thence in a northerly direction to that alley's intersection with Eighth Avenue.

An eight inch lateral running from the intersection of the alley between Sixth Street and Fifth Street and Tenth Avenue, thence in a northerly direction to that alley's intersection with Eighth Avenue.

An eight inch lateral running from the intersection of the alley between Fourth Street and Third Street with Twelfth Avenue, thence in a northerly direction along said alley to its intersection with Eleventh Avenue.

An eight inch lateral running from the intersection of the alley between Third Street and Fourth Street with Tenth Avenue, thence in a northerly direction along said alley to its intersection with the main sewer lying in the alley between Tenth Avenue and Eighth Avenue.

An eight inch lateral commencing in the alley between Second Street and Third Street and Fourteenth Avenue, thence in a northerly direction along said alley to its intersection with Thirteenth Avenue.

An eight inch lateral commencing at the intersection of the alley lying between Second Street and Third Street and Twelfth Avenue, thence in a northerly direction to its intersection with the sewer main lying in the alley between Tenth Avenue and Eighth Avenue.

An eight inch lateral commencing at the intersection of the alley lying between First Street and Second Street and Fourteenth Avenue, thence in a northerly direction along said alley to its intersection with Thirteenth Avenue.

An eight inch lateral commencing at the intersection of Fourteenth Avenue with the westerly boundary line of the city limits, thence in an easterly direction along said Avenue to its intersection with Main Street.

An eight inch lateral commencing at the intersection of Thirteenth Avenue with the westerly boundary line of the city limits, thence in an easterly direction along said Avenue to its intersection with First Street East.

An eight inch lateral commencing at the westerly boundary of the city limits with Twelfth Avenue, thence in an easterly direction along Twelfth Avenue to its intersection with First Street East.

An eight inch lateral commencing at the intersection of the alley between Eleventh Avenue and Tenth Avenue with Sixth Street West, thence in an easterly direction along said alley to a point approximately 25 feet to that alley's intersection with Second Street West.

An eight inch main commencing at the intersection of the alley between Tenth Avenue and Ninth Avenue with Sixth Street West, thence in an easterly direction along said alley to its intersection with First Street East.

An eight inch main commencing at the intersection of the alley between Second Street and Third Street and Thirteenth Avenue, thence westerly along Thirteenth Avenue to its intersection with the alley between First Street and Second Street.

An eight inch main commencing at the intersection of Thirteenth Avenue with the alley between Second Street and First Street, thence in a northerly direction to its intersection with the alley between Tenth Avenue and Eighth Avenue.

An eight inch main commencing at the intersection of Fifth Street West with the alley between Tenth Avenue and Eleventh Avenue, thence in a northerly direction to the intersection with the aforementioned alley.

An eight inch lateral commencing at the intersection of the alley lying between Eleventh Avenue and Tenth Avenue with Second Street West, thence in an easterly direction to that alley's intersection with First Street East.

3. The following reconstructions and constructions to the Storm Sewerage Systems shall be made, viz:

A storm sewer commencing at a point approximately 100 feet east of the intersection of Eighth Street with the alley extended between Tenth Avenue and the Northern Pacific Railway Right of Way, thence westerly in said alley extended to First Street; thence northerly along First Street to its intersection with the alley between Eighth Avenue and Ninth Avenue to the west city limits.

Said pipe to be in varying diameters ranging from twelve inch to forty-eight inch.

All the foregoing sanitary sewers and storm sewers shall contain the necessary manholes and lampholes and other appurtenances essential to a sewerage and storm collection system.

4. The Septic Tank Plant is to be constructed on the following property owned by the City of Polson, Montana, viz;

The Septic Tank Plant will be located on the west end of the alley between Eighth Avenue and Ninth Avenue at the west city limits.

and shall include the necessary pumps, chlorinators and all other necessary appurtenances essential to the proper treatment of sewerage.

The foregoing construction description is in accordance with the map, plans and specifications as prepared by Morrison-Maierle, Inc., City Engineer, for the carrying out of the herein described plan of construction, complete details for which said project are fully set forth and specified in the above map, plans and specifications, which said map, plans and specifications have been filed, and are now on file, in the office of the Engineer of the City of Polson, Montana, which said map, plans and specifications are hereby expressly adopted and approved.

The City Council may make such changes in the location of said plant, or in the size of the plant, or any other details of the above described plant prior to, or in the course of, the actual construction, which shall be found necessary and desirable and which will not substantially affect or change said plan of additions, constructions and improvements.

5. That the total cost of doing all the foregoing, it is estimated, will be the sum of \$235,000.00, which amount of \$235,000.00 shall be produced by a Revenue Bond Issue of said City, to be authorized by a majority vote of the qualified electors voting at an election to be held for that purpose. That such Revenue Bonds, if authorized, issued and sold, shall be a valid claim of the holders thereof only against the Special Fund created hereinafter, and shall not constitute an indebtedness of the City within the meaning of any Charter, statutory, or constitutional limitation upon the incurring of indebtedness, nor shall the City incur in respect there to any obligation for the payment of which taxes may be levied.

6. The City of Polson, Montana, shall own, conduct, maintain, control and operate said storm and sanitary sewerage system as herein provided for as a municipally owned utility, charging customers for such use thereof reasonable rates for the service rendered and received.

7. Said revenues and earnings from the foregoing system shall be paid into a Special Fund which is hereby created and ordered to be established in the office of the Treasurer of this City, which Special Fund shall be named, described as, and known as, the "STORM AND SANITARY SEWERAGE SYSTEM SPECIAL FUND OF 1950". The City Council covenants to pledge to the payment of the bonds and the interest thereon the net income and revenues of the system, including all additions thereto, and replacements and improvements thereof, subsequently constructed or acquired, up to an amount sufficient to provide for the payment of the principal and interest on the bonds as such principal and interest shall

become due and payable, and a margin of safety, which together with an unused surplus of such margin carried forward from the previous year, shall equal twenty per cent (20%) of all other amounts so required to be paid in the Sinking Fund.

The said income and revenues above mentioned shall be construed to mean all the gross income from said plant less operating expenses and cost of material and supplies used in operation and less ten per cent (10%) to be set aside for replacements and depreciation of said plant.

Said payments above mentioned shall constitute a first and prior charge and lien on the entire net income and revenues derived from the operation of said system.

8. That the proposal to issue such Revenue Bonds and use the proceeds thereof for such purpose shall be submitted to the qualified electors of said City; and that a "qualified electors" shall mean a registered elector of the municipality whose name appears upon the last completed assessment roll for state and county taxes as a tax-payer upon property within the municipality.

9. A Special Election is hereby called and directed to be held in and for the City of Polson on Friday, the 21st day of July, 1950, for the purpose of voting on the Question stated in the form of ballot hereinafter prescribed.

10. The City Clerk is hereby authorized and directed to give notice forthwith to the County Clerk of the call of said election. The County Clerk shall, after giving due notice of closing of the Registration Books, prepare printed lists of the registered voters entitled to vote at said election and shall prepare poll books for such election for each precinct of the City in the form and manner required by law.

11. The City Clerk is hereby authorized and directed to give notice of the call and holding of said election by publication, once each week for not less than two consecutive weeks in a newspaper published in Polson, Montana, the last such publication to be on the last day on which the newspaper is issued before the day of election, and by causing notice to be posted in at least three of the most public places in each voting precinct in the City at least ten days prior to the date of said election, which notice so published and posted shall read substantially as follows:

NOTICE IS HEREBY GIVEN that on Friday, the 21st day of July, 1950, a special election will be held in and for the City of Polson, Montana, for the determination of the question whether said City shall issue and sell its negotiable Revenue Bonds in the amount of \$235,000.00, to be payable during a term of Twenty (20) years from their date of issue, and use the proceeds thereof to establish, build, construct, reconstruct and extend the storm and sanitary sewer system, and construct a plant for the treatment and disposal of sewage therefrom, and all parts thereof and appurtenances thereto, all in conformity with the Session Laws of Montana for 1943, Chapter 149, as amended, such bonds and the interest thereon to be payable solely out of net income and revenues to be derived from rates and charges for the use of the facilities provided by the undertaking, and not to incur any obligation for the payment of which taxes may be levied except to pay for services provided by the undertaking to the City itself.

Further details as to said matter are set forth in Resolution No. 107, duly passed by the City Council and approved and now on file and of record in the office of the City Clerk.

ORDINANCE NO. 231

AN ORDINANCE PROVIDING FOR THE NUMBERING OF THE HOUSES AND BUSINESS PLACES IN THE CITY OF POLSON, MONTANA: FIXING THE DUTIES OF THE STREET COMMISSIONER, FIXING EFFECTIVE DATE, DECLARING AN EMERGENCY, AND REPEALING ALL ORDINANCES IN CONFLICT.

Be it ordained by the City Council of the City of Polson, Montana:

Section 1. Even numbers are hereby given to houses and business places on the west and south sides of all streets, and odd numbers on the east and north sides of all streets.

All houses fronting on public streets in the City of Polson shall be numbered in conformity with the following provisions:

First -- on Streets running northwardly and southwardly, numbering shall commence with 1 on the east side of all streets and 2 on the west side of all streets.

Thence commencing on the south side of First Avenue with number 101 on the east side of all streets and 102 on the west side of all streets.

Thence commencing on the south side of Second Avenue, Third Avenue, Fourth Avenue, Fifth Avenue, Sixth Avenue, Seventh Avenue, Eighth Avenue, Ninth Avenue, Tenth Avenue, Eleventh Avenue, Twelfth Avenue, Thirteenth Avenue, Fourteenth Avenue, Fifteenth Avenue and Sixteenth Avenue with numbers 201, 301, 401, 501, 601, 701, 801, 901, 1001, 1101, 1201, 1301, 1401, 1501, and 1601 on the east side of all streets; and numbers 202, 302, 402, 502, 602, 702, 802, 902, 1002, 1102, 1202, 1302, 1402, 1502, and 1602 on the west side of all streets, allowing one number to each twenty-five (25) foot lot in the business district, one number to each fifty (50) foot lot in the residential district.

Second -- Commencing on each street running east and west wher it intersects with Main Street, on the east side with number 1 on the north and number 2 on the south side of each street, thence running east with consecutive numbers, the odd on the north and the even on the south, allowing one number to each twenty-five (25) foot lot in the business district and one number to each fifty (50) foot lot in the residential district; and thus continuing as afor said with the number of
