and upon conviction thereof shall pay a fine of not to exceed Three Hundred Dollars (\$300.00) for each separate offense or by imprisonment in the city jail for a period not to exceed ninety (90) days, or by both fine and imprisonment. Any police officer encountering any such article without such stamps affixed thereto shall take possession of such article and same may be used as evidence of such violation.

Ordinance No. 233

AN ORDINANCE MAKING IT UNLAWFUL TO SHOOT, FIRE OFF, OR DISCHARGE A GUN, PISTOL, OR ANY FIREARM, B-B GUN, OR ANY COMPRESSED AIR GUN WITHIN THE LIMITS OF THE CITY OF POLSON, AND PROVIDING A PENALTY THEREFOR:

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA:

Section 1. It shall be unlawful for any person to shoot, fire off, or discharge a gun, pistol, or any firearm, B-B gun, or compressed air gun of any type within the corporate limits of the City of Polson.

Section 2. Any person wilfully violating the provisions of this Ordinance shall be deemed guilty of a misdemeanor, and upon conviction thereof, shall be fined in any sum not to exceed Three Hundred Dollars (\$300.00), or by imprisonment in the City jail, not exceeding ninety (90) days, or by both such fine and imprisonment.

The City Council hereby declares that an emergency exists and Section 3. therefore, this Ordinance shall be in full force and effect immediately after its passage and approval.

A RESOLUTION OF INTENTION TO CREATE A SPECIAL IMPROVEMENT DISTRICT OF AND IN THE CITY OF POLSON, LAKE COUNTY, MONTANA, DESIGNATE THE NUMBER THEREOF, DEFINING THE BOUNDARY OF THE SAME, STATING THE GENERAL CHARACTER OF THE IMPROVEMENTS TO BE MADE, THE APPROXIMATE COST THEREOF, AND ORDERING AND DIRECTING NOTICE TO BE GIVEN UPON THE PASSAGE AND APPROVAL OF THIS RESOLUTION.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA:

Section 1.

That is is the intention of the City Council of the City of Polson, Lake County, Montana, to create a Special Improvement District, the boundary of which is hereinafter described.

That said Special Improvement District shall be known and designated as Special Improvement District Number 15 of the City of Polson, Lake County, Montan a.

That this Special Improvement District is proposed to be created, that certain excavations, filling and refilling, basing and rebasing, and graveling, a portion of a street, and a portion of an avenue in the City of Polson, with provisions for carrying subdrainage into storm sewers, and so preparing the same for paving with oil and gravel surface, the said street and avenue, or portions thereof to be included being:

Main Street of the City of Polson, from Second Avenue to Seventh Avenue, and that portion of Third Avenue between First Street West and First Street East, being in all Seven Blocks, Four Intersections and Two Alley intersections.

That the property included within, and the boundary of said Special Improvement District is determined by the inclusion of each and all of the lots

and parts of lots, and each and every part and parcel thereof, said lots so included being as follows:

Lots One, Two, Three, Four, Five, Six, Seven and Eight, Block Eleven. Lots Seven, Eight, Nine, Ten, Eleven, Twelve and Six, Block Ten. Lots Seven, Eight, Nine, Ten, Eleven, Twelve and One, Block Fourteen. Lots One, Two, Three, Four, Five, Six and Twelve, Block Thirteen.

Lots Seven, Eight, Nine, Ten, Eleven and Twelve, Block Nineteen. Lots One, Two, Three, Four, Five and Six, Block Twenty.

Lots Six and Seven, Block Twenty-Four.

Lots One and Twelve, Block Twenty-Three.

Lots Six and Seven, Block Twenty-Nine, and 1 and 12 Block 30. All of the foregoing being within the Original Townsite of the City of Polson, Lake County, Montana, according to the map or plat thereof on file and of record in the office of the County Clerk and Recorder in and for said County of Lake.

Section 4.

That the district included within the aforesaid boundary, is hereby declared to be the district benefited by the making of said improvements and the property included therein, and within said boundary, is hereby declared to be the property benefited, and hereby declared to be the property to be assessed for the cost and expense of making such improvement.

Section 5. That the general character and nature of said proposed improvements may be described as follows:

The excavation of two feet of the portion of a street and avenue hereinbefore described, and the filling and refilling, basing and rebasing of the same to grade level, and graveling, all from curb to curb, all to be done with suitable sand, rock and gravel, the same compressed therein, and so preparing said street and avenue for oil-gravel surface, as a paving thereon, and provision for subdrainage into storm sewers.

Section 6. That the estimated cost, including engineering fees, is approximately \$21,000.00, which will be approximately \$125.00 per 25 foot frontage on each side of the street and avenue herein mentioned and included, the same including the pro-rata share of the cost of construction of the intersection of streets and the alley intersection. Section 7.

Upon the passage and approval of this resolution the Council of the City of Polson, gives notice thereof, through the Clerk of Said City, and the said Clerk is hereby ordered and directed so to do in accordance with the provisions of Section 11-2204 of the R. C. M. 1947, by mailing and publication as therein provided.

That it is the intention of the City Council of the City of Polson, Lake County, Montana, to create a Special Improvement District, within the Original Townsite of the City of Polson, the boundary of which is hereinafter particularly described and designated.

Section 2. That said Special Improvement District shall be known and designated as Special Improvement District Number 16 of the City of Polson, Lake County, Montana.
