All of the foregoing being within the Original Townsite of the City of Polson, Lake County, Montana, according to the map or plat thereof on file and of record in the office of the County Clerk and Recorder in and for said County of Lake.

Section 4.

That the district included within the aforesaid boundary, is hereby declared to be the district benefited by the making of said improvements and the property included therein, and within said boundary, is hereby declared to be the property benefited, and hereby declared to be the property to be assessed for the cost and expense of making such improvement.

Section 5.

That the general character and nature of said proposed improvements may be described as follows:

The excavation of two feet of the portion of a street and avenue hereinbefore described, and the filling and refilling, basing and rebasing of the same to grade level, and graveling, all from curb to curb, all to be done with suitable sand, rock and gravel, the same compressed therein, and so preparing said street and avenue for oil-gravel surface, as a paving thereon, and provision for subdrainage into storm sewers.

Section 6.

That the estimated cost, including engineering fees, is approximately \$21,000.00, which will be approximately \$125.00 per 25 foot frontage on each side of the street and avenue herein mentioned and included, the same including the pro-rata share of the cost of construction of the intersection of streets and the alley intersection.

Section 7.

Upon the passage and approval of this resolution the Council of the City of Polson, gives notice thereof, through the Clerk of Said City, and the said Clerk is hereby ordered and directed so to do in accordance with the provisions of Section 11-2204 of the R. C. M. 1947, by mailing and publication as therein provided.

Resolution No. 111

A RESOLUTION OF INTENTION TO CREATE A SPECIAL IMPROVEMENT DISTRICT OF AND IN THE CITY OF POLSON, LAKE COUNTY, MONTANA, DESIGNATE THE NUMBER THEREOF, DEFINE THE BOUNDARY OF THE SAME, STATE THE GENERAL CHARACTER OF THE IMPROVEMENTS TO BE MADE, THE APPROXIMATE COSTS THEREOF, AND DIRECTING AND ORDERING NOTICE TO BE GIVEN UPON THE PASSAGE AND APPROVAL OF THIS RESOLUTION OF INTENTION.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA:

Section 1.

That it is the intention of the City Council of the City of Polson, Lake County, Montana, to create a Special Improvement District, within the Original Townsite of the City of Polson, the boundary of which is hereinafter particularly described and designated.

Section 2.

That said Special Improvement District shall be known and designated as Special Improvement District Number 16 of the City of Polson, Lake County, Montana.

Section 3.

This Special Improvement District is proposed to be created, that certain excavation, filling and refilling, basing and rebasing, and graveling of a portion of a certain street, and portion of an intersection in the City of Polson, from curb to curb, with provisions for suitable subdrainage into storm sewers, and thus prepare the same for paving with oil and gravel surface, the portion of street and intersection included being as follows:

That portion of First Street East, from the North edge of the oil paving on Hi-Way 93, extending North to First Avenue, being one block and approximately 15 feet.

The property included in said Special Improvement District, and the boundary thereof is determined by the inclusion of each and all of the lots, and portions thereof, in the following Blocks, to-wit:

Lots One, Two, Three, Four, Five and Six in Block Five.

Lots Six, and Seven in Block Six,

all the foregoing being in the Original Townsite of Polson, Lake County, Montana, according to the plat thereof on file and of record in the office of the County Clerk and Recorder of Lake County, Montana.

Section 4.

That the district and the property within the aforesaid boundary is hereby declared to be the district and the property benefited by the making of said improvements, and the property therein included is hereby declared to be the property to be assessed for the costs and expenses of making said proposed improvements.

Section 5.

That the general nature and character of said proposed improvements are as follows:

The excavation of the portion of street and intersection as hereinbefore mentioned and described, and filling and refilling of the same, basing and rebasing to grade level, and graveling, all from curb to curb, with suitable material, sand, rock and gravel, compressed therein, said excavation to be to a depth of two feet, and with provision for carrying subdrainage into storm sewers, and so preparing said street for oil-gravel surface as a paving thereon.

Section 6.

That the estimated cost, including engineering fees, is approximately \$3000.00, which will be approximately \$125.00 per 25 foot frontage on each side of said street, the same including the pro-rata share of the cost of the construction of said portion of an intersection.

Section 7.

Upon the passage and approval of this resolution, the Council of the City of Polson, gives notice thereof through the Clerk of said City, who is hereby directed to give such notice in accordance with the provisions of Section 11-2204 of the R.C.M., 1947, by publication and mailing as therein provided.

The foregoing resolution is hereby adopted and approved in regular session this 4th day of June, 1951.

RESOLUTION NO. 112

A RESOLUTION OF INTENTION OF THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA, TO CREATE A SPECIAL IMPROVEMENT DISTRICT IN THE CITY OF POLSON, FOR THE PURPOSE OF BUILDING AND CONSTRUCTING A SANITARY SEWER SYSTEM IN SAID DISTRICT, IN THE INTEREST OF THE HEALTH OF THE PROPERTY OWNERS THEREIN AND INHABITANTS THEREIN, DESCRIBING THE BOUNDARY THEREOF, STATE THE GENERAL CHARACTER AND NATURE OF THE PROPOSED IMPROVEMENTS, THE APPROXIMATE COST OF THE SAME, AND PROVIDING FOR THE GIVING OF NOTICE OF THE TIME AND PLACE FOR HEARING PROTESTS AGAINST THE PROPOSED DISTRICT, WORK, OR AGAINST THE CREATION OF SAID DISTRICT OR THE EXTENT THEREOF, OR BOTH.

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA:

Section 1.

That the public health, convenience and sanitary safety require and it is deemed necessary to order, establish and create, and the City Council of the City of Polson, Lake County, Montana, does hereby declare its intentions to create a Special Improvement Sanitary Sewer District, within the City of Polson, Lake County, Montana, the boundary of which is hereinafter particularly described.

Section 2.

That this Special Improvement Sanitary Sewer District shall be designated and known as Special Improvement Sanitary Sewer District Number 10.

Section 3.

That the boundary of said Special Improvement District aforesaid, comprises an area in the southeast portion of the City of Polson, Lake County, Montana, as follows:

Beginning at the northwest corner of Block 1 of City Center Addition to the City of Polson and running south along the property line on the East Side
