That the exact amount of bonds proposed to be issued, be and the same is hereby fixed in the amount of Seventy Five Thousand Dollars, payable over a period of 20 years, and redeemable at the option of the City of Polson, five (5) years from date of issue, and on any interest due date thereafter, for the purpose of obtaining funds for the following purpose, to-wit:
BUILDING AND CONSTRUCTING OF A SEWER SYSTEM, TO BE USED FOR SANITARY AND OTHER DRAINAGE

PURPOSES FOR AND IN THE CITY OF POLSON, LAKE COUNTY, MONTANA,

all of the same to be used by the City of Polson, for the purpose herein stated. ## RESOLUTION No. 114

A RESOLUTION CREATING SPECIAL IMPROVEMENT DISTRICT NO. 15 OF THE CITY OF POLSON, LAKE COUNTY, MONTANA, DEFINING THE BOUNDARY THEREOF, AS STATED AND PROVIDED IN THE RESOLUTION OF INTENTION UNDER DATE OF JUNE 4th, 1951, PROVIDING FOR MANNER OF ASSESSMENT, PROVIDING FOR NOTICE AND CALL FOR BIDS, AND FORM AND SALE OF BONDS.

WHEREAS: The City Council of the City of Polson, did on the 4th day of June, 1951, pass a Resolution of Intentions to create a Special Improvement District within the City of Polson, the same being resolution No. 110, and the district so proposed to be created being No. 15.

AND WHEREAS: Said Resolution of Intentions aforesaid among other matters and things set forth the character and nature of said proposed improvements, reciting that the same was for the excavation of two feet of the portion of a street and portion of an avenue, filling and refilling the same, basing and rebasing the same to grade level and from curb to curb, all done with suitable sand, rock and gravel, compressed therein, and graveling, installing provision for subdrainage into storm sewers, preparatory for an oil surface paving.

AND WHEREAS: Said resolution of intentions among other things provided that the City Clerk of the City of Polson, cause notice of the passing of said resolution to be given to each and all the property owners, persons, forms or corporations or the agent thereof, within said district, as hereinafter described, and that he cause publication thereof in manner and form as by law provided and as stated in Section 11-2204 R.C.M. 1947.

AND NOW, on this date, to-wit: the 2nd day of July, 1951, the same being a regular meeting of the City Council of the City of Polson, at the City Hall of the City of Polson, and at the hour of 8:00 o'clock P.M. of said day, and being the time and place as provided in said Resolution of Intention for hearing upon said resolution in and pertaining to the creation of said proposed improvement district No. 15, the matter came before the Council for hearing.

AND NOW FURTHER it appears to the satisfaction of the City Council of the City of Polson, that due and legal notice has been given of the passage of said Resolution of Intentions to create Special Improvement District No. 15, as evidenced by the affidavit of publication of Notice to Property Owners, and as further evidenced by the affidavit of mailing by the City Clerk of the City of Polson showing that said notice has been mailed to all property owners, persons, forms, corporations or agents thereof within said proposed district, as hereinafter described, and that said Notice to property owners is sufficient as to form.

AND FURTHER it appears to the satisfaction of the City Council of the City of Polson, that less than 40 per cent of the property owners within said proposed district have made objection thereto, either to the character of the improvement or the extent of said district, and that no objections have been made in either or any respect, not even to the manner or form of the proposed assessment.

NOW THEREFORE: BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA:

Section 1. That said Special Improvement District Number 15 be and the same is hereby created.

Section 2. That the property so included within said proposed district and as now created is as follows:

Main Street of the City of Polson, from Second Avenue to Seventh Avenue, and that portion of Third Avenue between First Street West and First Street East, being in all Seven Blocks, Four Intersections and Two Alley Intersections, and all the property included within, the boundary of said district now created being determined by the inclusion of each and all of the lots and parts of lots, and each and every part and parcel thereof, said lots so included being as follows:
