

NOTICE OF SALE OF SPECIAL IMPROVEMENT DISTRICT BONDS.

NOTICE IS HEREBY GIVEN: By the City Council of the City of Polson, Montana, that said City Council will on the 6th day of August, 1951, at the hour of 8 o'clock P.M. at the City Council Chambers, Polson, Montana, sell to the highest and best bidder for cash, bonds of Special Improvement District No. 16 of said City of Polson, Montana, in the amount of \$3000.00 in form as by law provided, for the purpose of making improvements in said Special Improvement District.

Said bonds will be dated the 6th day of August, 1951, with interest not to exceed 6% per annum, payable annually, as by law provided, and in denominations of \$100.00, or \$1000.00 as the City Council may decide, payable over a period of 10 years, reserving to the City of Polson; by and through the Council, the right to redeem said bonds at any time within said 10 years.

Said bonds will not be sold for less than par value and accrued interest, and all bidders must state the lowest rate of interest at which they will purchase said bonds at par. The City Council reserves the right to reject any and all bids and sell said bonds at private sale.

All bids other than by or on behalf of the State Board of Land Commissioners of the State of Montana, must be accompanied by a duly certified check in the sum of \$500, payable to the order of the City Clerk, Harding Hanson, which will be forfeited by the successful bidder in the event he shall fail or refuse to complete the purchase of said bonds in accordance with the terms of his bid.

Said bonds will be in the Statutory form as provided in Section 11-2231 R.C.M. 1947.

RESOLUTION NO. 116

A RESOLUTION CREATING SPECIAL IMPROVEMENT SANITARY SEWER DISTRICT NO. 10, OF THE CITY OF POLSON, LAKE COUNTY, MONTANA, DEFINING THE BOUNDARY BY REFERENCE AS STATED IN RESOLUTION OF INTENTIONS NO. 112, UNDER DATE OF JUNE 4th, 1951, PROVIDING FOR MANNER OF ASSESSMENT, CALL FOR BIDS, AND FORM AND SALE OF BONDS.

WHEREAS: The City Council of the City of Polson, Lake County, Montana, did on the 4th day of June, 1951, pass a Resolution of Intentions, Number 112, to create a Special Improvement Sanitary Sewer District Number 10, within the City of Polson, Lake County, Montana.

AND WHEREAS: Said Resolution of Intentions aforesaid among other matters and things set forth the general character and nature of the work and improvements proposed within said district, defined the boundary thereof, and set forth the proposed manner of assessment, and therein directed the City Clerk of said City of Polson to give notice in manner and form as by law provided to all property owners, persons, firms, corporations, or agent thereof, having or owning property within said district.

AND NOW: On this date, to-wit: the 2nd day of July, 1951, the same being a regular meeting of the City Council of the City of Polson, at the City Hall of said City, and at the hour of 8 o'clock P.M., being the time and place as provided for the hearing upon said Resolution of Intentions aforesaid in and pertaining to the creation of said district, the matter came on for hearing before the said City Council of the said City of Polson.

AND NOW, FURTHER: It appears to the satisfaction of the City Council of the City of Polson, that due and legal notice has been given of the passage of said Resolution of Intentions to create said Special Improvement Sanitary Sewer District No. 10, as evidenced by the affidavit of publication of Notice to Property Owners, and as further appears by the affidavit of the City Clerk of the City of Polson as to mailing Notice to Property Owners to all persons, firms, corporations or agents thereof having or owning any property in said district, and that said Resolution of Intentions aforesaid, and said Notice to Property Owners are each and both proper in form and sufficient in all respects.

AND it further appears to the satisfaction of the City Council that all objections as made and filed against the said district, are less than 40 per cent of the property within said district, and are without merit, and are each and all overruled.

NOW THEREFORE: BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA:

Section 1. That Special Improvement Bonds in the sum of \$59,400.00 be issued and offered for sale against the Special Improvement Sanitary Sewer District No. 10, now created, which said bonds are to be paid by and through the special assessments above mentioned, said bonds to be paid over a period of 20

years, in equal annual installments, and the form of bond shall be as provided in Section 11-2231 R.C.M. 1947, and in denominations of \$100.00 or \$1000.00 as the City Council may determine, and bear interest at a rate not to exceed 6% per annum.

Section 2. Upon the passing and approval of this Resolution creating Special Improvement Sanitary Sewer District No. 10, the City Clerk of the City of Polson is hereby directed to call for bids for the work to be done in accordance with the plans and specifications on file in his office, which said notice shall in all respect conform to the law as stated in reference thereto and as stated in Section 11-2209 R.C.M. 1947.

Said bonds will not be sold for less than par, and accrued interest, and all bidders must state the lowest rate of interest at which they will purchase said bonds at par. The City Council reserves the right to reject any and all bids, and sell said bonds at private sale.

All bids other than by or on behalf of the State Board of Land Commissioners of the State of Montana, must be accompanied by a certified check in the sum of One Thousand Dollars, payable to the order of the City Clerk, Harding Hanson, which will be forfeited by the successful bidder in the event he shall fail or refuse to complete the purchase of said bonds in accordance with the terms of his bid.

RESOLUTION ABANDONING STREET.

WHEREAS: A petition having been presented and filed in the Office of the City Clerk of the City of Polson, asking and petitioning that a certain street, to-wit:

Fourteenth (14) Avenue East, between Seventh and Eighth Streets East in Grandview, an addition to the City of Polson, Lake County, Montana.

AND WHEREAS: On June 4th 1951 the matter was referred to the Committee on streets and alleys, and said committee directed to report on June 8th, 1951.
