RESOLUTION NO. 118

WHEREAS: The City Council of the City of Polson, Lake County, Montana, did on the 8th day of June 1951, pass Resolution No. 113, which provided for the calling of a Special Election, at and within the City of Polson, Montana, in all the wards and precincts thereof, that the qualified electors therein might vote upon the question of issuing bonds of the City of Polson, Montana, in the sum of \$75,000.00, bearing interest at the rate not to exceed 6% per annum, payable semi-annually, during a period of 20 years, and redeemable at the option of the City 5 years from date of issue, which resolution fixed the date of said election aforesaid for Wednesday the 11th of July, 1951, between the hours of 12 o'clock Noon and 8 o'clock P.M. of said day, and the said bonds to be issued for the purpose of securing funds to build and construct a sewer system to be used for sanitary and other drainage purposes for the City of Polson, Lake County, Montana.

AND WHEREAS: It now appears that due and legal notice has been given of the time and place of said election in manner and form, and in all respects, as by law provided, and proof thereof being on file with the City Clerk of the City of Polson.

AND WHEREAS: It appears from the returns of said election, and the record on file in and pertaining to the same, that said Special Election was legally had and conducted according to the notices thereof and pursuant to the Laws of the State of Montana, and that at said election 433 were cast by registered electors duly qualified to vote; that 408 votes were cast in favor of said Bond issue; and that 25 votes were cast against the same; and that there were 784 elegible voters elegible to vote at such election and that more than 40 per cent did in fact so vote.

AND WHEREAS: It appears conclusively that not any one, taxpayer, City, Bidder, or otherwise, have been or will be prejudiced by the passing of this resolution at this time, or by any statutory irregularity, it any there may be, inthese proceedings, but to the contrary it appears that it will be to the best interests of the City of Polson, Montana, and the citizens thereof, that this resolution be now passed.

AND WHEREAS: Through and by virtue of said election the City Council of the City of Polson has been authorized and empowered to issue, negotiate and sell such bonds, and the indebtedness created by said bond issue, together with all other indebtedness of the City of Polson, Montana, will not exceed 5 per cent of the value of the taxable property of said City as ascertained by the last completed assessment for State and County taxes, and does not exceed its constitutional limitations, and that the said City Council now has full authority to issue, negotiate and sell said bonds, for the purpose specified, and in the sum specified.

NOW THEREFORE; BE IT RESOLVED that under and by virtue of the law in the premises and in compliance with the provisions of Chapter 23, Title 11, R.C.M. 1947, and all acts supplemental and amendatory thereof, the City Council of the City of Polson, does hereby proceed to issue Coupon Bonds of the said City of Polson, Montana, in the amount of \$75,000.00, in order to obtain funds, and for the purpose of building and constructing a sewer system, to be used for sanitary and other drainage purposes for and within the City of Polson, Lake County, Montana; such said bonds to be issued as of the 1st day of September, 1951, and payable on the amortization plan or serially over a period of 20 years, and redeemable at the option of the City of Polson, 5 years from date of issue and on any interest payment date thereafter before maturity, and to bear interest at a rate not to exceed 6 per cent per annum, payable semi-annually.

BE IT FURTHER RESOLVED that in the sale and issue of such bonds preference will be given to amortization bonds, and if amortization bonds are issued, the entire issue may be put into one bonds, or be divided into several bonds as the purchaser may indicate in his bid and as the City Council may determine at the time of sale. AND if it be found necessary to issue serial bonds they shall be in the amount of \$3,800.00 each, except the last bond, which will be in the sum of \$2,800.00; the sum of \$3,800.00 of said serial bonds will become due and
