Montana by solicitors, peddlers, hawkers, itinerant merchants or transient vendors of merchandise not having been requested or invited so to do by the owner or owners, occupant or occupants of said private residences for the purpose of soliciting orders for the sale of goods, wares and merchandise and/or disposing of and/or peddling or hawking the same as declared to be a nuisance and punishable as such nuisance as a misdemeanor. SECTION 2. BE IT FURTHER ORDAINED, that any person violating the provisions of this ordinance shall upon conviction thereof be fined not more than \$100.00 or imprisoned not more than 30 days or both fined and imprisoned in the discretion of the Court.

SECTION 3. BE IT FURTHER ORDAINED, that the provisions of this ordinance shall not apply to the sale, or soliciting of order for the sale, or milk, dairy products, vegetables, poultry, eggs and other farm and garden produce so far as the sale of the commodities named herein is now authorize d by law.

SECTION 4. BE IT FURTHER ORDAINED, that it being deemed by the Council of the City of Polson, Montana, that an emergency exists, this ordinance shall be in effect from and after

its passage and approval.

SECTION 5. BE IT FURTHER ORDAINED, that all ordinances or parts of ordinances in conflict herewith are hereby repealed.

Resolution No. 123

A RESOLUTION FIXING THE FORM OF SEWER BONDS DATED SEPTEMBER 1, 1951.

WHEREAS, it has been heretofore determined to issue and sell \$75,000 Sewer Bonds of the City of Polson, and the city council, by resolution duly adopted on July 16, 1951,

called for bids on said bonds, and

WHEREAS, this council met on August 20, 1951, to consider bids for said bonds, and, after duly considering all bids received pursuant to notice as aforesaid, found that amortization bonds could not be issued at an interest rate favorable to the city and did deem it for the best interest of the city to accept the bid of Piper, Jaffray & Hopwood to purchase three percent serial bonds at par and accrued interest plus a premium of

WHEREAS, Piper, Jaffray & Hopwood has offered to pay the cost of printing said bonds,. the form to be prescribed by the city council, provided the bonds are in denomination of

\$1,000 and \$800, and it is advantageous to the city to have the stated maturities, NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Polson, Montana,

as follows:

1. The bid of Piper, Jaffray & Hopwood to purchase bonds bearing interest at the rate of three percent per annum at a price of par and accrued interest plus a premium of \$500 is hereby determined to be the most favorable bid received for said bonds and most advantageous to the city, and is hereby accepted.

2. The city shall forthwith issue its negotiable coupon Sewer Bonds in the aggregate principal amount of \$75,000, said bonds to be 79 in number and numbered 1 to 79, both inclusive, in the denomination of \$1,000 each except bond No. 4 and multiples thereof and bond No. 79 which shall be in the denomation of \$800 each, to be dated September 1, 1951, . to bear interest at the rate of three percent per annum, payable semiannually on September l and March l in each year, and to mature serially on September 1st in the years and amounts as follows: \$3,800 in 1952 to 1970, both inclusive, and \$2,800 in 1971, all bonds maturing after September 1, 1956, being subject to redemption and prior payment on said date and any interest payment date thereafter at par and accrued interest.

3. The bonds shall be payable at the American National Bank of St. Paul in the City of

St. Paul, Minnesota, and the city shall pay the reasonable charges of such bank for its

services as paying agent.

5. Said bonds shall be prepared under the direction of the city clerk and shall be executed on behalf of the city by the signature of the mayor and tressurer, and attested by the city clerk, and sealed with the corporate seal, and the interest coupons thereto attached shall be executed and authenticated by the printed, engraved or lithographed facsimile signatures of said officers, and said bonds shall be registered by the city treasurer in the manner provided by law; and the full faith, credit and taxing powers of the city shall be and hereby are pledged for the prompt and full payment of the principal and interest of said bonds as the same mature.

- When said bonds have been fully executed and registered as required by law, they shall be delivered by the treasurer to the purchaser on payment of the par value thereof and accrued interest to date of payment and delivery, and the purchaser shall not be require to see to the application of said purchase price.

Ordinance No. 237

AN ORDINANCE PROVIDING FOR MEETING OF THE CITY COUNCIL OF THE CITY OF POLSON, MONTANA, TIME OF HOLDING SAID MEETINGS, DATE OF REGULAR MEETINGS, NOTICE OF SPECIAL MEETINGS, AND FIXING PLACE OF ALL MEETINGS, AND REPEALING SECTION 1, OF ARTICLE I, REVISED ORDINANCES OF THE CITY OF POLSON, MONTANA, 1937, AND ALL ORDINANCES IN CONFLICT THEREWITH.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF POLSON, LAKE COUNTY, MONTANA.

Section 1. The City Council of the City of Polson, Montana, shall hold its regular meeting for the transaction of municipal business on the first Monday of each and every month at the hour of 7:30 p.m. or at such other hour as may be fixed by resolution.

Section 2. Special Meetings of the City Council of the City of Polson, Montana, may be called by the Mayor of said City, or by two aldermen, at any time, the City Clerk on their requisition, giving reasonable notice thereof, and two hours is hereby declared to be a reasonable notice, which said notice may be either in writing, by telephone communication personally to said alderman, or direct personal communication to him or her, and to all members of the City Council at the time present within said City.

Section 3. All meetings of the City Council of the City of Polson, Montana, unless otherwise ordered for good cause, shall be held in the Council Chambers in the City Hall, in said City of Polson.

Section 1 of Article 1, of the Revised Ordinances of the City of Polson, 1937, Section 4. and all ordinances in conflict therewith is hereby repaled.

Section 5. There is hereby declared an emergency existing and this ordinance is immediately necessary for the peace, welfare and safety of the City of Polson, Montana, and by reason thereof this ordinance shall immediately become effective upon its passage and approval.
