A RESOLUTION CREATING SPECIAL IMPROVEMENT DISTRICT NO 17, OF AND IN THE CITY OF POLSON, LAKE COUNTY, MONTANA, DEFINING THE BOUNDARY THEREOF, AS STATED AND DEFINED IN THE RESOLUTION OF INTENTIONS, RESOLUTION NO 124, PROVIDING FOR THE MANNER OF ASSESSMENT, PROVIDING FOR NOTICE AND CALL FOR BIDS, AND PROVIDING FOR NOTICE AND THE FORM AND SALE OF SPECIAL IMPROVEMENT BONDS.
