A resolution by the City Council of the City of Polson, a municipal corporation, in Lake County, Montana, authorizing execution of Contract by and between said City of Polson, Montana, and the United States of America, in pursuance of Act of August 19, 1949, (Public Law 255, 81st Congress; 63 Stat. 621), relating to a system of drainage and sanitation for the said City of Polson, Montana; releasing and authorizing the Mayor of said City to release and hold the United States of America harmless against any and all damages that may be asserted by any property owner of the area or adjacent areas arising and resulting from seepage in the affected area or areas; providing for the operation, of the sanitation and drainage system in perpetuity, and its ownership in perpetuity, providing that the said City bind itself to all the terms of said contract, declaring an emergency, and fixing effective date of this resolution, and repealing any resolution in conflict herewith.

BE IT RESOLVED: by the City council of the city of Polson, Montana

WHEREAS it is the purpose and intent herein to execute, and direct and authorize the Mayor said City of Polson, Montana, to execute Contract for and on behalf of said City and by and between said City of Polson, Montana, a municipal corporation, and the United States of America, in pursuance of Act of August 19, 1949, (Public Law 255, 81st Congress; 63 Stat. 621), relating to a system of drainage and sanitation in said City of Polson, Montana;

WHEREAS it is the intent and purpose of said City of Polson, Montana to releas and hold the United States of America harmless for damages that may be claimed by any property owner as resulting from damages or for damages from seepage in th affected area, and the drainage-sanitation district so formed pursuant to section I of the contract, hereby specifically agree to hold the United States harmless against any and all damages or damage claims that may be asserted by property owners of the affected area, and such is the express purpose and intent of said city council.

THEREFORE BE IT RESOLVED: That said contract by and between the said City of Polson, Montana, a municipal corporation, and the United States of America in pursuance of Act of August 19, 1949, (Public Law 255, 81 Congress; 63 Stat. 621) relating to a system of drainage and sanitation for said City of Polson Montana is hereby authorized to be entered into by said City and said Mayor of said City is authorized and directed to execute the same for and on behalf of said City, and said city acting thru its said council approves said contract in each and every respect and in its entirety and binds itself to the terms and provisions contained therein,

A RESOLUTION CREATING OIL DISTRICT NO. 14-I, DEFINING THE BOUNDARIES THEREOF AND ESTIMATING THE COSTS THEREOF.
